Separate sealed bids for the Shady Grove Utility District Water Main Replacements consisting of approximately 39,675 linear feet of 8-inch SDR 17 PVC, 134 service line reconnections, 32 gate valves and all other associated appurtenances, fittings and connections in the Jefferson County community as depicted on the plans, specifications and bid form will be received by the Shady Grove Utility District located at 830 Highway 139 Dandridge, TN 37725 until 2:00 p.m. local time on June 6<sup>th</sup> 2024 and then at said office publicly opened and read aloud. No mandatory pre-bid meeting will be held. This project is being supported with American Rescue Fund Act, Coronavirus State and Local Recovery Fund grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity. Separate sealed bids for the Shady Grove Water Main Replacements will be received by Jefferson County at the Shady Grove Utility District Office located at 830 Highway 139, Dandridge, TN until June 6<sup>th</sup> at 2:00 PM and then at said office publicly opened and read aloud. Any person with disability requiring special accommodations must contact Jefferson County no later than 7 days prior to the bid opening. Jefferson County hereby notifies all bidders that it will affirmatively insure that in any contract entered pursuant to this advertisement will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in consideration for an award. Jefferson County is an Equal Opportunity Employer. Any contract that uses federal funds to pay for construction work is a "federally assisted construction contract" and must include the equal opportunity clause found in 2 C.F.R. Part 200, unless otherwise stated in 41 C.F.R. Part 60. We encourage all small and minority owned firms and women's business enterprises to participate. No bidder may withdraw his bid within (60) days after the actual date of the opening thereof. The Copeland "Anti-Kickback" Act is also applicable, which prohibits workers on construction contracts from giving up wages that they are owed. Contractor's must not appear on Sam.gov disbarment list. A detailed listing of all subcontractors shall be provided by the Bidder. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must also not appear on Sam.gov disbarment list. Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement. A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a general contractor with the State of Tennessee with a MU classification. The owner reserves the right to waive any informalities or to reject any or all bids.
