Mechanical (CMC) or HVAC (CMC-C) (Applies only if Contractor is awarded HVAC or Chiller Contract.)	The classification CMC is noted on licenses issued after 1992 and represents that the licensee has passed the Board licensing exam and that no county or municipality shall require such state licensee or its employees to pass any county or municipal test or examination pursuant to TCA 62-6-111(i)(2)(C). Plumbing (CMC-A) (Applies only if Contractor is awarded Plumbing Contract.)	The classification CMC is noted on licenses issued after 1992 and represents that the licensee has passed the Board licensing exam and that no county or municipality shall require such state licensee or its employees to pass any county or municipal test or examination pursuant to TCA 62-6-111(i)(2)(C). CMC-A applies to Plumbing and Gas Piping.	State of Tennessee Department of Commerce & Insurance
Mechanical (CMC) or Boilers (CMC-I) (Applies only if Contractor is awarded Boiler Contract.)	The classification CMC is noted on licenses issued after 1992 and represents that the licensee has passed the Board licensing exam and that no county or municipality shall require such state licensee or its employees to pass any county or municipal test or examination pursuant to TCA 62-6-111(i)(2)(C). TN Repair License (Applies only if contractor is awarded Boiler Contract).	Any maintenance and repair work which is required to be done to the boiler must be in compliance with the Tennessee Department of Labor and Workforce Development Division of Boiler and Elevator Inspection Board of Boiler Rules as published by the Tennessee Secretary of State's Office, currently available online at <a href="https://publications.tnsosfiles.com/rules/0800/0800.htm">https://publications.tnsosfiles.com/rules/0800/0800.htm</a> and Tenn.
