2. O V E R V I E W

Currently, there are two forms that Grantees are required to complete, Information for Audit Purposes (IAP) and End of Fiscal Year (EOFY) eForms. These forms replace the previous Notice of Audit and Parent Child Information forms. To fill out these forms, subrecipient suppliers will need to log in to their account on the Edison Supplier Portal. This document will walk Grantees through the process of completing the Information for Audit Purposes (IAP) form within the supplier portal.

3. INFORMATION FOR AUDIT PURPOSES (IAP) FORM

120 days before the fiscal year end date, Grantees will receive an email with a link to the Information for Audit Purposes (IAP) eForm. Once users click the link in the email, you will be taken to the Supplier Portal homepage. At least ninety (90) days before the end of its fiscal year, the Grantee shall complete the Information for Audit Purposes (IAP) form online (accessible through the Edison Supplier Portal) to notify the State whether the Grantee is subject to an audit. The Grantee should submit only one completed form online during the Grantee's fiscal year. Immediately after the fiscal year has ended, the Grantee shall fill out the End of Fiscal Year (EOFY) form (accessible through the Edison Supplier portal).

- 6. The form is broken down into multiple sections.
 - Grantee Information all fields in this section are required (as denoted by the * next to each field).
 As you progress, the form will automatically indicate what additional fields are required based on



your previous answers. When filling out the form, Grantees should try to be as thorough as possible. Any questions regarding the form should be directed to your Cognizant State Agency (typically the State agency whose funds comprise the greatest percentage of grants received by a Grantee).

- Grantee is Subject to an Audit for the Current Fiscal Year if the Grantee knows they will be subject to an audit this fiscal year, this will need to be marked as 'Yes'.
- Grantee's Supplier Name the Grantee's legal business name.
- Name of Primary Grantee Contact the name of the person in the Grantee's organization the State of Tennessee will reach out to if there are questions about this completed form.
- Grantee's Edison Supplier ID the Grantee's 10-digit supplier ID with the State of Tennessee.
- Grantee Phone Number the phone number in the Grantee's organization the State of Tennessee will reach out to if there are questions about this completed form.
- Grantee Email Address the email address in the Grantee's organization the State of Tennessee will reach out to if there are questions about this completed form.
- Fiscal Month Start the first month of your organization's fiscal year. (For most, this is typically January or July).
- Fiscal Day Start the date of the month your organization's fiscal year starts. (Typically, the 1st).
- Fiscal Month End the last month of your organization's fiscal year. (For most, this is typically December or June).
- Fiscal Day End the date of the month your organization's fiscal year ends. (Typically, the 30th or 31st).
- Expenditures this Expenditures section captures some of the critical information the State of Tennessee uses to determine if a subrecipient is subject to an audit. Grantees should try to be as accurate as possible when filling out this information.

- Parent/Child Information the Parent/Child Information section collects information on whether the Grantee is a parent or child and helps the state see the total amount of funds awarded to a Grantee.

- Is the Grantee A Parent if the Grantee is a parent entity of other entities, this will need to be marked as 'Yes'; this will trigger additional fields later in the form.
- Is the Grantee A Child if the Grantee knows they are the child of another entity, this will need to be marked as 'Yes'; this will trigger additional fields later in the form.
- Parent Entity's Name the parent entity's legal business name.
- Parent Entity's Tax ID Number the parent entity's 9-digit tax ID number. (Usually listed in the format 00-1234567).
- Name of Primary Contact Person the name of the person in the parent's organization the State of Tennessee will reach out to if there are questions about this completed form.
- Parent Contact Phone Number the phone number for the person in the parent's
 organization the State of Tennessee will reach out to if there are questions about this
 completed form.
- Parent Contact Email Address the email address for the person in the parent's organization the State of Tennessee will reach out to if there are questions about this completed form.
- Children of Parent the Children of Parent section is a continuation of the Parent/Child Information section. This section will only show if the answer to "Is the Grantee a Parent" is selected as 'Yes'. It allows parents to list the name of each child entity under the parent organization and their Employee Identification Number (EIN).

 Auditor Information – the Auditor Information section collects information on the current auditor. This section is only required if the answer to "Grantee is Subject to an Audit for the Current Fiscal Year" is selected as 'Yes'.

- Auditor's Name the audit firm's legal name.
- Auditor's Address Line 1 the first line of the auditor's address with street number and street name. (Example: 123 Main St.)
- Auditor's Address Line 2 the second line of the auditor's address (if applicable).
- Auditor's City the city in which the auditor's address is located.
- Auditor's State the state in which the auditor's address is located.
- Auditor's Five Digit Zip Code the zip code in which the auditor's address is located.
- Auditor's Phone Number the phone number for the auditor that the State of Tennessee will reach out to if there are questions about this completed form.
- Auditor's Email the email for the auditor that the State of Tennessee will reach out to if there are questions about this completed form.

If the Grantee is subject to an audit, the Grantee shall obtain the Comptroller's approval before engaging a licensed, independent public accountant to perform the audit. The Grantee may contact the Comptroller for assistance identifying auditors.

The audit contract between the Grantee and the Auditor shall be on a contract form prescribed by the Comptroller. The Grantee shall be responsible for payment of fees for an audit prepared by a licensed, independent public accountant. Payment of the audit fees by the Grantee shall be subject to the provision relating to such fees contained within this Grant Contract. The Grantee shall be responsible for reimbursing the Comptroller for any costs of an audit prepared by the Comptroller.

All audits shall be performed in accordance with the Comptroller's requirements, as posted on its web site. When a federal single audit is required, the audit shall be performed in accordance with U.S. Office of Management and Budget's *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*.

A copy of the audit report shall be provided to the Comptroller by the licensed, independent public accountant. Audit reports shall be made available to the public. The Grantee shall also submit a copy of the audit report to any other parties directed by the grant contract (if applicable).

 Comments - the Comments section of the form is the final section, and it allows you to explain in further detail any of the information you previously entered on the form. Once you have completed this section it is a good idea to go back and review the information you have entered before submitting the form.

- 7. At the bottom of the form, you can either Save or Submit. The Save button will allow you to save the form as completed and come back to it later. The Submit button will submit the completed form. Once submitted, you will be taken to a section that confirms your form has been successfully submitted. Once submitted no further changes can be made to the IAP form.
- 8. Suppliers will be notified after their fiscal year end when the End of Fiscal Year (EOFY) eForm is available for completion and submission.
