1. STATEMENT OF PURPOSE:

The State of Tennessee, Department of General Services, Central Procurement Office issues this Request for Information ("RFI") for the purpose of obtaining information regarding paper and plastic goods. The information gathered in this RFI will assist the State in developing a competitive solicitation to establish a statewide contract for paper and plastic goods. We appreciate your input and participation in this process.

2. BACKGROUND:

The scope of the current contract includes Non-Disposable Culinary Items, Disposable Culinary Items, Janitorial Paper Products and Dispensers, Trash Can Liners, and Paper Bags. The total estimated annual spend is \$4,832,590.
