REQUEST FOR INFORMATION FOR WEST TENNESSEE TRANSPORTATION SERVICES

1. STATEMENT OF PURPOSE:

The State of Tennessee, Department of Transportation issues this Request for Information ("RFI") for the purpose of identifying available transportation providers in the subject area and gathering information about the available programs and business models for the type of service described. We appreciate your input and participation in this process.

2. BACKGROUND:

TDOT seeks information on available transportation providers in the West Tennessee region to establish transportation service to Haywood County from an 11-county region in West Tennessee. The State is considering a transportation service that would feature express coach bus service from the two major cities in the region. TDOT is also wanting to learn more about community bus and/or vanpool services to serve as regional coverage of the 11 counties surrounding the destination. Transportation service will be 6 days per week, with the potential for 7 days per week.


The Express Coach service is the first priority for the State's consideration and would feature two routes from Jackson and Memphis/Shelby County to multiple stop locations within a few miles of a site in Stanton, Tennessee, located in Haywood County. The estimated frequency of the Express Bus Routes is as follows:

- At least 2 Coach Buses to/from Haywood County originating in Memphis/Shelby County* with 2-3 stops before delivering at the destination.
 - o Morning from Memphis: 5am to deliver by 6:15am,
 - Reverse return around 5pm
 - o Evening from Memphis: 5pm to deliver by 6:25pm
 - Reverse return around 6am
- At least 1 Coach Bus to/from Haywood County originating in Jackson* with 1-2 stops before delivering at the destination.
 - o Morning from Jackson: 5:30am to deliver by 6:15am
 - Reverse return around 5pm
 - Evening from Jackson: 5:30pm to deliver by 6:25pm
 - Reverse return around 6am

*These are rough service projections and are subject to change

The community bus/vanpool service would feature shuttle buses or a vanpool program to transport small groups of passengers from the 11 counties to the Stanton area. Delivery to site times would be similar to above, but service start times will vary based on location.

A diagram of the service area and types of coverage for each county is illustrated below:
