		3 Should a la carte pricing and package pricing include added pass-through fees or should we attach a spreadsheet with all state/county pass-through fees to be added in at the time of invoicing?	Any state/county pass-through fees may be added in at the time of invoicing. Pass-through fees are not evaluated in the RFP.

		9 How many financial investigations do you anticipate needing on a monthly or annual basis?	The State estimates needing less than one (1) financial investigation annually.

No. A financial investigation shall be required only if financial improprieties or discrepancies are identified during the application process.
		11 What level of collaboration and communication is expected between the contractor and the State's agencies throughout the duration of the contract?	The State requires communication upon request and completion of the background investigation (BI). As needed, the State may request progress updates from the Contractor or request further investigation.
		12 What performance metrics or benchmarks will the State use to assess the contractor's effectiveness and compliance with the contract requirements?	The State shall assess the Contractor based on their timeliness, responsiveness, thoroughness, and clarity of background investigation reports.
		13 In regards to subcontractors, our contractors only receive information on the relevant subject, and never have access to any client data. We have several thousand such external ICs under contract with many more under review or in the process of being screened and onboarded at any given time. We do not know in advance which contractor may be used for any task and, as part of our predetermined agreement with	All subcontractors must be approved by the State per section D.7. of the contract. The Contractor shall identify subcontractors, or it would be in breach of the contract. The Contractor may be required to submit information regarding a subcontractor per Terms and Conditions section E.5 and E.6 of the Contract. The Contractor must be required to verify information to the State as required by Terms and Conditions sections D.8, D.10, D.23, D.33, E.5, and E.6.

		17 How many existing applicants are anticipated to be reviewed per year?	The State estimates twelve (12) Operators per year, 60 vendors over 3-year period (operators renew annually, vendors renew on every 3 years).
		18 How many new applicants are expected to be added per year?	The State estimates possibly 3-5 new vendors per year.
		19 How many subjects (individuals or companies) per report?	Typically, there is 1 company and an average of 2-3 individuals per report.

The State requires a contractor that can provide business credit reports when requested.

The percentage of domestic vs international background investigations to be completed under this contract is estimated to be less than 5% total international checks for operators and vendors and approximately 25% international checks for key personnel. An estimate for each type of international search is in RFP 6.3 COST PROPOSAL & SCORING GUIDE.

The Sports Wagering Council application for Key Personnel undergoing investigation states, "Provide the information regarding your employment for the past twenty years or from age 18, whichever is less." This is the expected level of employee verification.
