TennCare is Tennessee's managed care Medicaid program which provides health insurance coverage to certain groups of low-income individuals such as pregnant women, children, parents or caretaker relatives of minor children, older adults, and adults with disabilities.

- Over 1.7 million Tennesseans are enrolled in TennCare.
- That's more than 23% of the state's population.
- TennCare pays for **50% of births** in the state.



- Overall, the number of TennCare new, acute opioid users has declined by 58% since 2015. The largest decrease occurred following the implementation of new TennCare opioid benefit limits.
- ★ Throughout 2021, 356 high-quality providers provided opioid use disorder treatment and recovery services to 15,000 members through TennCare's dedicated medication assistant treatment network.

TennCare's Managed Care Model

TennCare's managed care model means TennCare and CoverKids contract with health insurance plans - also known as managed care organizations or MCOs.

A health plan coordinates care for TennCare members and maintains a network of providers like doctors, hospitals, specialists, pediatricians, and nursing homes.

About Managed Care Model


- ⊕ TennCare pays the health plans a Per Member Per Month (PMPM) rate which is similar to a health insurance premium. The health plans pay the providers for services delivered to members.

Managed Care Model Financial Effect

TennCare currently makes up approximately 17% of the state budget.
