MINIMUM CURRICULA REQUIREMENTS

1. Firearms FPO 24 hours
**Departmental and/or POST Approved Instructor-TCA 4-3-2019 Section 2D NRA-
Post Certified Instructor-TN Handgun Permit Instructor**

- 1.1. Weapons safety, nomenclature and maintenance.
- 1.2. For handguns, stances and firing positions to include Kneeling, standing, prone, off-hand, barricade, one- and two-hand grip.
- 1.3. Double or single action (depending upon Department approved weapon)
- 1.4. Fifty (50) rounds per qualification.
- 1.5. Minimum One Thousand (1000) rounds total per candidate will be fired in basic/initial training.
- 1.6. Shall not be fired beyond 25 yards.
- 1.7. Student must demonstrate a proficiency of at least 75% both during day and darkness on all weapons issued or authorized by student's department.
- 1.8. Demonstrate a proficiency of at least 75% on a stress exertion course which has a laterally moving target.
