4. Delete RFQ 35910-15624 Pro Forma Contract section C.1. in its entirety and insert the following in its place (any sentence or paragraph containing revised or new text is highlighted):

C.1. Maximum Liability. In no event shall the maximum liability of the State under this Contract exceed One Million Seven Hundred Ninety-Five Thousand Dollars (\$1,795,000.00) ("Maximum Liability"). This Contract does not grant the Contractor any exclusive rights. The State does not guarantee that it will buy any minimum quantity of goods or services under this Contract. Subject to the terms and conditions of this Contract, the Contractor will only be paid for goods or services provided under this Contract after a purchase order is issued to Contractor by the State or as otherwise specified by this Contract.

5. RFQ Amendment Effective Date. The revisions set forth herein shall be effective upon release. All other terms and conditions of this RFQ not expressly amended herein shall remain in full force and effect.
