#### **Contract Period:**

Start Date: March 25, 2022

End Date: March 24, 2025 with three (3) one-year renewal options remaining\*

\*Special Note - No new equipment will be rented beyond the end of year five (5) (March 24, 2027) from the resulting contract. The final year of the statewide contract will allow Authorized Users to complete existing rental terms.

### **Summary/Background Information:**

The purpose of this Statewide Contract ("SWC") is to provide equipment rental services for State of Tennessee ("State"). Equipment rental services includes broad categories of equipment and specific equipment within each category. There are twenty (20) categories of equipment included for rental. The Contractor(s) shall provide all goods or services required by this Contract to all Tennessee State Agencies and shall also make this Contract available to all Authorized Users, as defined in the Terms and Conditions. Contractor(s) agrees to extend this Contract to Authorized Users.

### **Delivery/Pick Up Charges:**

Contractor is responsible for full delivery and pick-up, including but not limited to, acquiring required permits. The State will measure delivery and pick-up costs as combined into one lump sum per piece of equipment per Category per Region or per piece of equipment per Line per Region where applicable. Payment at the lump sum price bid shall be full compensation for all materials, fuel, labor, equipment, and incidentals to and from the site.

### **Fuel Charges:**

All equipment shall be delivered full of fuel and will be returned full of fuel. If the Authorized User fails to fill the fuel tank up to the same level that was present at delivery, the Contractor may charge their standard fuel charge plus the average retail cost of fuel for the Midwest region according to the United States Energy Information Administration (https://www.eia.gov/petroleum).

### **Additional Fees:**

Contractor shall not charge any additional fees such as an environmental fee.

### **Billing and Payment Instructions:**

<u>Methods of Payment</u>: All contractors accept check and ACH deposit. The following Suppliers accept P Card: Gulf Material Sales LLC, H&E Equipment Services Inc., Herc Rentals Inc., Hutson Inc, Sunbelt Rentals Inc., TriGreen Equipment LLC, United Rentals North American Inc.

The Contractor shall submit an itemized invoice to the state agency billing address provided in the PO. The invoice may include only charges for services described in the PO.



**NOTE:** Agencies may use a decimal up to 3 digits long in the PO Qty when creating a PO against a line. This will allow agencies to pay incrementally for some line items ex. Pay monthly for an item with a yearly price.

### **Emergency Call Procedures:**

The Contractor must have a dedicated emergency hotline to answer and provide equipment for declared states of emergency. Authorized User must identify emergency equipment requests as such in the call. Emergency equipment requests must be on site in twenty-four (24) hours, or otherwise mutually agreed upon time. A toll-free telephone number and an email address shall be provided to the CPO, and must be continuously answered/monitored seven (7) days a week and twenty-four (24) hours a day.
