

SWC# 242 Ground Maintenance Equipment/UTVs/ATVs
Contract Information and Usage Instructions

Contract Period: Statewide Contract 242 is a three year contract with two one year renewal options. No renewal options remain. It began on April 10, 2020 and will expire on March 31, 2025. Note that although ATVs previously were separate on SWC 248, ATVs have been merged into this SWC 242 starting in August 2022.

Summary/Background Information: Statewide Contract 242 is for Ground Maintenance Equipment, UTVs, and ATVs. These contracts are utilized by State agencies and local government entities for the procurement of several categories: Utility Vehicles (UTVs), All-Terrain Vehicles (ATVs), Walk Behind Mowers, Lawn Tractors, Zero Turn Mowers, Golf Course Maintenance Equipment, Hand Held Power Equipment, Sub Compact Tractors, and Utility Tractors.

On SWC 242, please only purchase categories and brands from the vendor to whom they were awarded for your region. The following pages list this award information, as well as vendor contact information.

This site gives information for each contract and the categories of equipment each one was awarded at discount. Refer to the attached link to a *“Discount Product Comparison by Vendor/Category”* to see what vendors were awarded in each category.

Each vendor has their contract and contact information posted in a link. The contract has the categories which each vendor was awarded and the discount percentage listed. The Edison ID numbers are generic asset numbers and are common to all contracts, and are to be used when creating a requisition. There is no pricing on the contract document.

Each vendor has their pricing information attached; either as a catalog(s) or a pricing extract. Note that some display the MSRP or suggested list price, from which you would apply their discount. Some have posted both the MSRP and the Tennessee State Pricing. When assistance is needed to configure a larger piece of equipment, such as a Golf Course Reel Type Mower, contact the vendor for their expertise.
