#### **Contract Period:**

This is a three year contract running from August 1, 2021 to July 31, 2024 with each of the last two years being optional one-year renewals. This contract has been extended in sixmonth increments for up to one year until July 31, 2027.

## **Summary/Background Information:**

The contract provides cost savings for Agencies and provides the benefit of a single provider for lab services across the State. This contract is to provide the State with lab tests and the ability to conduct and analyze the tests to include blood testing, urine analysis testing, and drug testing.

# **Usage Instructions:**

# **Test Ordering**

- 1. First-time users of this contract should contact Pam O'Brien to get set up to purchase services.
- 2. Pre-printed request forms designed for ordering tests and chain of custody forms are to be be supplied by the Contractor at no additional cost to the State. This should only be used if electronic methods are not available.

#### **Courier Service**

- 1. Courier Service includes one daily specimen pick-up at no additional cost.
- 2. Specimens are to be transported via secured vehicle that is occupied at all times during transportation.
- 3. Courier Services are available five (5) day a week (Monday-Friday), excluding legal State holidays.
- 4. Stat courier service is available seven (7) days a week, including holidays, for all State agencies.
- 5. Stat courier fee of \$5.00 applies both within and outside normal business hours. This is per pickup, not per specimen. Stat is invoiced separately from normal pickup.
- 6. Materials required to collect specimens and transport those specimens to the laboratory are supplied at no additional cost to the State.

#### **Specimen Testing**

- 1. Stat specimen pickup must occur within two (2) hours of request.
- 2. End Users may request any test be done as Stat as long as the methodology doesn't require special chemicals, cultures, etc.
- 3. Any value which does not correlate with the clinical situation, in the opinion of the Agency physician, will be repeated at no additional cost to the State.

### **Test Results**

- 1. Routine test results should be reported to the End User within twenty-four (24) hours of specimen pickup.
- 2. Non-routine test results should be reported to the End User within five (5) calendar days of pickup.
- 3. Stat test results must be received within four (4) hours of specimen pickup.
- 4. The Contractor provides pathologist for telephone consultations with Agency on interpretations of test results from 8:00 AM 4:30 PM seven (7) days a week at no additional cost to the State.

# <u>General</u>

- 1. Agencies should receive initial inventory for one month. Contractor is to replenish stock within seven (7) days of agency request.
