1. Forestry Gear and Equipment- Items include, but are not limited to, clinometers, compasses, tags & signs, measuring wheels, location stakes .

2. Arborist/Horticulture Gear- Items include, but are not limited to, hand pruners, pole saws, arborist saddles, loppers, saws, and spray paints.

3. Lab and Educational Supplies- Items include, but are not limited to, stereoscopes, bench scales, pH meters, water samplers, hazardous materials cabinets, laboratory balances.

4. Environmental Samplings - items include, but are not limited to, soil test kits, water samplers, soil color books, and pocket penetrometers

5. Weather and Temperature- items include, but are not limited to, pocket weather meters, thermometers, and rain gauges.

6. Mapping, Surveying, and Engineering Equipment- items include, but are not

limited to, vehicle distance measurer and adapter, laser distance measurer, surveying automatic level, hand levels with magnification

7. Clothing and Protective Gear- items include, but are not limited to, protective pants, reflective apparel, fire retardant apparel, safety and waterproof boots, overalls or coveralls, heat resistant clothing, protective gloves, protective hats

8. Tools and Equipment- items include but are not limited to, augers, axes, rakes, chainsaws, flamethrowers, marking carts, hoes, fertilizer spreaders

9. Outdoor Gear- items include but are not limited to, fire blankets, global positioning systems, binoculars, backpacks, tool bags, tents, first aid kits, sting relief swabs, insect repellents.
