• Area in blue is MTSU Campus




## **PROPERTY INFORMATION**

The subject property is 1.5 story single-family residential home located near Middle Tennessee State University (MTSU) Campus. Totaling 1,258 square feet, it contains a 1,037-sf 1<sup>st</sup> level and 221 sf loft area on the 2<sup>nd</sup> level. The home was built in 1954 and has 2 bedrooms and 1 bath. The property has a driveway for parking and is adequate for single-family use.
