BOARD OF MEDICAL EXAMINERS

Licensee: Christopher Adams, MD 58423, Winston Salem, NC

Violation: During a clinical review of the licensee's cases after quality-of-care concerns, the licensee, while on a medical leave of absence, created a false narrative as well as fraudulent letters about a diagnosis of penile cancer which indicated he was receiving treatment at the Cleveland Clinic and Vanderbilt. Licensee did not, nor has he ever had penile cancer. In conjunction with his recredentialing and in response to the clinical review of his cases, Licensee reported that, while on medical leave, he was a "visiting physician" at the Cleveland Clinic and was performing complex cardiology cases under the supervision of another physician. Licensee provided several support letters from 3 physician leaders at the Cleveland Clinic attesting to Licensee's skillset and abilities. Licensee admits that he altered a prior recommendation letter he had received from a physician at the Cleveland Clinic with fraudulent information which suggested he was training with the Cleveland Clinic. Licensee admits that these letters were forged and that he did not, nor had he ever, trained at the Cleveland Clinic. As a result, Licensee was terminated from Cookeville Regional Medical Center. Following the actions by CRMC, Licensee voluntarily surrendered, in lieu of revocation both his Kentucky and Virginia medical licenses.

Action: Respondent's license is voluntarily retired, same as revocation. Respondent is assessed costs, not to exceed \$10,000.

Licensee: Bruce Boggs, MD 39382, Gray, TN

Violation: Licensee served as the medical director of an unlicensed Med Spa.

Action: Respondent's license is reprimanded. Respondent is assessed civil penalties in the amount of \$1,200 and costs not to exceed \$5,000.

Violation: Licensee is licensed in Tennessee through the Interstate Medical Licensure Compact and holds Compact licenses in several states. Between September and October 2025, the licensee's compact medical license was suspended in Colorado, North Dakota, and Mississippi.

Action: Respondent's license is automatically suspended for a period of ninety (90) days.

Failure to perform and record adequate physical examinations when prescribing. Failure to keep adequate medical records. Failure to establish adequate practice protocols pursuant to the applicable standard of care, including a method for documenting consultation and referral. Failure to timely review historical, physical, and therapeutic data of patients when a controlled substance was prescribed.

Action: Reprimand. No prescribing of opioids for at least six (6) months from ratification of the Consent Order. No collaborating or supervising of any students, trainees, advanced practice registered nurses, physician assistants, or pharmacists for issuing opioids for at least six (6) months from the date of ratification of the Consent Order. Completion of two (2) continuing education courses related to documentation and prescribing of controlled substances as listed in the Consent Order within six (6) months of ratification of the Consent Order. Proof of notification of discipline to any collaborators within thirty (30) days of Consent Order ratification. Civil penalties totaling two thousand dollars (\$2,000). Costs not to exceed two thousand five hundred dollars (\$2,500).

Violation: Dr. Sinha's Georgia license was placed on probation for one year for behaving inappropriately toward a patient.

Action: License is Revoked.

Violation: Licensee, a Pharmacy Technician, diverted prescription drug products from the pharmacy practice site while employed and on duty as a pharmacy technician. The diverted prescription drug products include oxycodone/acetaminophen which is a controlled substance.

Action: Licensees' registration to practice as a Pharmacy Technician has been revoked.
