In the absence of the director, the medical laboratory supervisor must be responsible for the proper performance of all laboratory procedures and reporting of test results;

the medical laboratory supervisor... (2) Shall be on the laboratory premises at a minimum of thirty (30) hours per week and be readily available for consultations during all other hours when tests are performed.
