It is a violation of 63-22-110 to violate the rules and regulations of the board and to engage in professional misconduct, unethical or unprofessional conduct, including, but not limited to, willful acts, negligence and conduct likely to deceive, defraud or harm the public or engaged in such conduct. Counselors act to avoid harming their clients, trainees, and research participants and to minimize or to remedy unavoidable or unanticipated harm. Counselors do not engage in or condone sexual harassment. Sexual harassment can consist of a single intense or severe act, or multiple persistent or pervasive acts. Counselors have a responsibility to read, understand, and follow the ACA Code of Ethics and adhere to applicable laws and regulations.  
Action: Respondent violated the American Counseling Code of Ethics principles by making inappropriate comments that were sexual in nature and for imposing Respondant's religious values on client. License revoked; assessed civil penalties in the amount of \$2,000.00, plus costs not to exceed \$10,000.00.
