Executive Summary

The Uninsured Adult Healthcare Safety Net Fund, administered by the Tennessee Department of Health, State Office of Rural Health and Health Access (SORH), delivers access to health care for uninsured adults ages 19 to 64 who live in Tennessee. Services are implemented by Federally Qualified Health Centers (FQHC), Community and Faith-Based Clinics (CFB), Dental Organizations, Non-Profit Rural Health Centers, and Project Access entities. Local Health Departments (LHD) also provide primary care, acute care, and dental care services to Tennessee's uninsured through funding from the Tennessee Department of Health annual departmental budget. The Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS) receives separate Safety Net funding and administers the Behavioral Health Safety Net program.

During Fiscal Year 2022 (FY22), July 1, 2021 to June 30, 2022, the Tennessee Department of Health, Tennessee Department of Mental Health and Substance Abuse Services, Tennessee Department of Finance and Administration, and the Division of TennCare allocated state funding to support Safety Net services in rural and underserved areas. This funding increases equitable access to primary medical, dental, mental and behavioral health care, as well as care coordination services, which connects patients to specialty care and other support services.

Beginning in Fiscal Year 2021, with input from FQHC and CFB partners, the overall Uninsured Adult Healthcare Safety Net funding was no longer divided into separate allocations. Instead, primary medical, dental, mental and behavioral health care services were funded through a single "Primary Care Plus" category. This strategy was implemented to recognize that these services are often delivered at the same clinical sites and are all growing service needs.

The funding distributed for these Primary Care Plus services has constituted 82.5 percent of the Safety Net budget historically, and this percentage remained constant. Project Access Care Coordination for specialty services remained a separate allocation, which comprised 17.5 percent of the Safety Net base recurring budget. Additional recurring state funding appropriated by the General Assembly, was used to increase the per encounter reimbursement for providers in keeping with the will of the General Assembly and the need of service providers. The additional funding expanded Project Access reach for specialty services across Tennessee, specifically the rural regions of the state.

The Uninsured Adult Healthcare Safety Net program was allocated a total of \$24.9 million in state funding for FY22 and divided in two service categories, Primary Care Plus and

Project Access per the above description. The Primary Care Plus program provided care for 185,742 unduplicated patients for a total of 373,331 encounters of which comprised 79 percent Primary Medical, 15 percent Dental, and 6 percent Behavioral Health. Of the total, Primary Care Plus encounters 93 percent were in person visit and 7 percent were telehealth visit.

Local Health Departments provided 51,823 medical encounters to 24,946 unduplicated uninsured patients ages 19-64 years through the 40 primary care clinics. These clinics are not designated as FQHCs and do not receive state Safety Net funding. However, they are supported by state funding allocated separately through the Tennessee Department of Health, Division of Community Health Services. The 16 LHD clinics designated as FQHCs funded by the Uninsured Adult Healthcare Safety Net program had a total 26,793 encounters from 11,652 unduplicated patients.

The Tennessee Project Access Network provides specialty care coordination services to patients in 73 counties with central offices located in five centralized metropolitan areas: Chattanooga, Johnson City, Knoxville, Nashville, and Memphis. The Tennessee Project Access Network is a network of physicians, clinical care providers, hospitals, and other facilities that assists patients to obtain access to comprehensive care management, specialty care, diagnostic services, preventative care, and management of social service needs. The Project Access program provided 223,559 specialist care coordination encounters to 15,935 unduplicated patients.

In FY22, TDMHSAS administered \$35.7 million in state funding to the Behavioral Health Safety Net (BHSN) program to provide essential outpatient mental health services for uninsured adult Tennesseans and uninsured/underinsured Tennessee children who meet program eligibility criteria. Through the BHSN program, 35,460 adult Tennesseans and 1,127 Tennessee children were served.

Introduction

In 2005, the Tennessee General Assembly approved Tenn. Code Ann. § 71-5-148, authorizing funding for the Healthcare Safety Net for uninsured adults to aid individuals lacking insurance, and in need of medical, and/or emergency dental care, including services to support continuity of care through referrals for specialist care coordination. Tenn. Code Ann. § 68-1-123, adopted in 2006, requires the Commissioner of Health, in consultation with the

The changing landscape of healthcare access brings new challenges to Tennesseans, particularly those in rural areas.

Tennessee Department of Finance and Administration and other State agencies, such as the Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS), to provide an annual report to the General Assembly on data relating to access to care through Safety Net service providers, including the adequacy of access and the array of services available. The Uninsured Adult Healthcare Safety Net program helps to advance the Tennessee Governor's priority goal of promoting healthy behavior and providing high quality services to our most vulnerable populations; and the Tennessee Department of Health's Strategic Plan: (1) to achieve better health by increasing both primary prevention and access to health care services, (2) advancing equity, and (3) leveraging innovation through telehealth.

The Tennessee Department of Health, the Tennessee Department of Finance and Administration, Division of TennCare, and TDMHSAS each administer funds allocated to support Safety Net programs and services. Each agency contracts with qualified service providers to deliver primary medical care, dental care, mental and behavioral health care, and case management services to eligible adults in Tennessee.

Each year, the United Health Foundation publishes *America's Health Rankings*® Annual Report which is a comprehensive set of data that provides a state-by-state analysis of the nation's health. According to the latest published report, Tennessee ranked 37th among the 50 states with an estimated 10.4 percent of Tennesseans that are uninsured¹, demonstrated in **Figure 1**. A lack of adequate health insurance and/or poor access to health care services can lead to overall poorer health outcome. The disparity caused by lack of access to quality healthcare impacts all Tennesseans across the state - in urban and rural areas, races, ethnicities, and sexual orientation, regardless of gender or age. Having adequate access to quality primary care and coordinated health services including telehealth remains the primary goal for Tennessee.



Figure 1: Comparison of Tennessee and National Uninsured Adult Population Rates


According to the Boyd Center for Business and Economic Research at the University of Tennessee, Knoxville, costly premiums is the leading cause for failing to obtain health insurance among Tennesseans. With approximately 80 percent of total respondents citing affordability as their major cause for not obtaining health insurance².

Since the start of Coronavirus Disease 2019 (COVID-19), health insurance access has been significantly influenced by unemployment rates, loss of health insurance, and legislative changes. In Tennessee 273,680 people enrolled in private health plans through the Tennessee exchange for 2022 coverage compared with the 212,052 people enrolled in 2021, according to health insurance.org. This significant increase is a record high enrollment due in part to the enhancements in the American Rescue Plan Act of 2021. Even with the increase in health insurance enrollment many Tennessee residents are without health insurance. Tennessee State Healthcare Safety Net programs and TennCare are in place to help close this gap.




Figure 4: Counties served by Project Access for Specialty Care Coordination.

The number of state funded safety net sites have nearly doubled in the last three years. Tennessee Uninsured Adult Healthcare Safety Net's Primary Care Plus and Project Access Providers are now in 93 of 95 counties, offering primary care, behavioral health care, dental care, and care coordination services to uninsured Tennesseans ages 19-64 in the following settings (**Figures 2,3,4 and Appendix 1,2**).

- Primary Care Access:
 - 56 Local Health Department (LHD) clinics, of which 16 are designated as
 Federally Qualified Health Centers (FQHC)
 - o 118 non-LHD FQHCs
 - o 44 Community & Faith-Based clinics
- Dental Care Access:
 - o 45 LHD clinics, of which 6 are designated as FQHCs
 - o 20 non-LHD FQHCs
 - o 20 Community & Faith-Based clinics
- Specialty Care Access includes 5 Project Access entities covering 67 counties.




Figure 5: TDMHSAS Funded Behavioral Health Safety Net Locations

Safety Net Population




Figure 6: Uninsured Adult Healthcare Safety Net Population Age and Gender Distribution





Figure 8. Health Risk Percentages Among Safety Net Patients and TN BRFSS Population

The Safety Net Primary Care Plus and Project Access programs population estimates are collected on an annual basis from all Safety Net partners and include data on age, race, and ethnicity (**Figures 6, 7, 8**). However, the means in which the Safety Net program has reported and grouped populations has changed over the years.

The *Behavioral Risk Factor Surveillance System* (BRFSS) is a national data collection system focused on health risk behaviors, chronic health conditions, use of preventative services and other factors that affect the health of US adults³. The Safety Net program uses information from the Tennessee *Behavioral Risk Factor Surveillance System* (BRFSS) to acquire state level data and to monitor changes in the health status and health risk factors of the Safety Net population. **Figure 7** shows the percentage of chronic illness of the Safety Net population against the Tennessee's adults between ages 18-64 and **Figure 8** shows the percentage of health risk factors of the Safety Net population against Tennessee's adult population between ages 18-64.

Figure 7: Chronic Illness Percentages Among Safety Net Patients and TN BRFSS Population

Safety Net Funding Distribution




Figure 9. Primary Care Plus and Project Access Funding Allocation FY20 - FY22

In FY22, the Tennessee Department of Health, SORH administered a total of \$24.1 million in state allocated funding to support the Uninsured Adult Healthcare Safety Net Program. This amount included a base recurring of \$21.9 million and \$2.2 million non-recurring for Primary Care Plus and Project Access. Of the total funding, \$20.5 million was allocated for Primary Care Plus and \$4.3 million was allocated to Project Access (**Figure 9**).

The total Primary Care Plus funding is evenly distributed quarterly. The volume of patient care services reported determines the individual patient encounter rate. Patient volumes and their correlating per encounter payments may fluctuate from quarter to quarter. This funding methodology assures that all appropriated funds are distributed in a manner proportional to the number of encounters provided (**Figure 10**). 



Figure 11. Historical Safety Net Expenditures FY18 - FY22



Health Care Service Delivery

Community and Faith-Based Clinics

The overarching purpose of Community and Faith-Based (CFB) clinics is to provide consistent, culturally sensitive health care to minimize costly utilization of emergency room services and other hospital resources while




Figure 12. Total Medical Encounters served by CFB Clinics FY20 - FY22




Figure 13. Unduplicated Patients served by CFB Clinics FY20 – FY22

providing vulnerable Tennesseans with a compassionate medical home and continuity of care. CFB organizations provide an array of preventive and wellness, primary medical care, specialty care, oral health, mental health, substance abuse, vision, diagnostic, and pharmaceutical assistance services free or at a significantly reduced cost. **Figure 12** and **Figure 13** represents the number of total encounters provided by CFB clinics and the total number of unduplicated patients served from FY20 to FY 22, respectively.

The patients served by CFB organizations frequently have conditions impacted by a lack of preventive care services, lack of social support networks, and limited financial resources. CFB organizations are important partners in Tennessee's Safety Net Program and amplify their impact by leveraging the services of volunteer licensed professionals to fulfill both clinical and administrative functions. Additionally, these organizations optimize donated resources, equipment, and supplies to further advance care for the uninsured and underserved populations across the state. With no direct federal funding to serve the uninsured, state funding from the Uninsured Adult Healthcare Safety Net is vital to support CFB organizations in fulfilling their mission.

The Tennessee Charitable Care Network (TCCN) is the statewide membership association which serves as the collective voice for Tennessee's Community and Faith-Based (CFB) clinics and programs. With 59 member locations across the state, TCCN's member organizations provide healthcare in 65 of Tennessee's 95 counties.

Federally Qualified Health Centers

Federally Qualified Health Centers (FQHCs) or community health centers, are federally funded, non-profit organizations providing comprehensive preventive and primary care in underserved rural and urban areas. By mission and statute, community health centers care for all patients that come through their doors, regardless of their insurance status or ability to pay. There are 30 community health center organizations in Tennessee, with more satellite sites across the state. The 30 community health center organizations in Tennessee have sites in 68 of the state's 95 counties.

Community health centers are continuing to provide a wider range of services to patients including behavioral health, treatment for substance use disorder, dental, and pharmacy services. Health centers also promote a Patient-Centered Medical Home model of care, emphasizing whole-person, team-based care that seeks to improve health outcomes for patients. Finally, health centers continue to implement programs to meet the social determinant of health needs of patients.






Figure 15. Unduplicated Patients served by FQHC Clinics FY20 – FY22

Figure 14 represents the number of medical encounters provided by FQHCs from FY20 to FY22. Uninsured Adult patient encounters for the 16 Local Health Department FQHCs are included in the FY22 Safety Net total. **Figure 15** represents the number of unduplicated patients served by FQHCs in FY20 to FY22. The unduplicated patients served by the 16 Local Health Department FQHCs are included in the FY22 Safety Net count.

Local Health Departments

In FY22, 56 local health departments (LHD) primary care services and 45 provided dental care services. Of those, 16 primary care and 6 dental LHD clinics were designated as FQHCs. A combined total of 79,004 medical and dental encounters were rendered to uninsured adults ages 19 to 64 at Local Health Departments. The 40 non-designated FQHC LHD clinics provided 51,823 medical encounters for uninsured Tennesseans 19-64 years, a 10.07 percent increase from FY21. **Table 1** shows the number of medical encounters in FY22 for each age group in non-FQHC local health departments.



The 40 non-designated FQHC LHD clinics do not receive funding through the Uninsured Adult Healthcare Safety Net program. These sites receive separate state funding to offer primary care and emergency dental services for uninsured adults including traditional public health services such as immunizations, family planning, screening for breast and cervical cancers, case management, and supplemental nutrition services for pregnant women, infants, and children (WIC).

In FY22, the 16 LHD clinics designated as FQHCs received funding through the Uninsured Adult Healthcare Safety Net program. These sites had a total 26,793 encounters from 11,652 unduplicated patients. The number of encounters, including medical and dental, delivered by each type of LHD provider is displayed below in **Figure 16**.

Project Access

The Tennessee Project Access Network provides specialty care services to patients in 73 counties with central offices located in five centralized metropolitan areas: Chattanooga, Johnson City, Knoxville, Nashville, and Memphis. The Tennessee Project Access Network does not provide direct clinical health care services, but is affiliated with networks of physicians, clinical care providers, hospitals, and other facilities, and assists patients with comprehensive care management, access to specialty care, diagnostic services, preventative care, and management of social service needs.




Figure 17. Care Coordination Encounters for FY 20 - FY22




Figure 18. Total Unduplicated Patients Served by Project Access FY20 – FY22

The total number of care coordination encounters and the total unduplicated patients over a three-year fiscal period are represented in **Figures 17 and 18**, respectively. Project Access programs have provided \$767 million in donated health care services provided by 6,714 volunteer physicians and 34 hospital campuses, coordinating for patients from 175 health centers and clinics. The network of volunteers provides free primary and specialty care services, as well as ancillary lab and diagnostic services to 3,000-3,500 uninsured adult Tennesseans per month.

In FY22, Project Access was funded separately from other service delivery types, receiving a total of \$6,580,806 in Uninsured Adult Healthcare Safety Net funding. Due to the strain on the health care system related to COVID, including limitations placed on elective procedures, staffing challenges, and patient concerns about exposure, some expansion efforts and related funding from FY22 have been carried over to FY23. This enables Project Access programs to continue expansion efforts.

Oral Health Services





Figure 20. Unduplicated Dental Patients served by CFB and FQHC Clinics FY20-FY22

In FY22, a total of 30 Primary Care Plus providers received \$2,994,256 in funding to support 57,237 oral health services for 26,817 uninsured adults 19 to 64 years of age (Figure 19). Uninsured dental patients increased by 7.3% from FY21 to FY22 (Figure 20).

In addition to the oral health services supported by the state Uninsured Adult Healthcare Safety Net funds, other public and non-profit organizations provide a variety of dental services for uninsured Tennesseans.

Tennessee Department of Health's Oral Health Services (OHS) provides programs for the prevention of oral disease and education of the public regarding the value of good oral health. In addition, the program identifies those without access to dental care and attempts to assure basic care, as well as care for acute dental conditions. OHS is expanding recruitment and retention efforts across the state. This includes offering staff incentives such as sign-on bonuses, student loan repayment options, and partnering with dental schools for student rotations.

Forty-six Local Health Department facilities provide emergency dental services to uninsured adults in 45 of Tennessee's 95 counties. The Metro Public Health Department in Davidson County also offers emergency dental services, while the Shelby County Health Department provides emergency dental services for adults and comprehensive dental services for individuals less than 21 years old. The 30 LHD dental clinics provided 17,149 encounters to 9,671 patients.

SMILE ON 60+

SMILE ON 60+ is an innovative, statewide initiative with the goal of improving the overall health and quality of life of low-income, mobile seniors aged 60 and older through access to oral healthcare services and oral health community education. Since SMILE ON 60+ began providing care in August of 2018, individuals from 94 counties accessed care through the network.

SMILE ON 60+ evaluated, educated, and navigated older adults into safety net clinic dental homes and then helped them with transportation and the cost of care. As the lead agency of SMILE ON 60+, Interfaith Dental built a statewide network of care for older adults and thus transformed the oral health landscape for older adults in Tennessee. The network includes 22 partners in 32 locations.

SMILE ON 60+ began with funding from by the chancery court of TN through the Senior/Elder Trust. Funding for the program was exhausted March 30, 2022.

Lawrence County and Maury County Health Departments were added in the second year of the program and provided direct care to 20 new unduplicated adult patients, completing 231 patient visits during FY22. During the length of the entire program, Lawrence County and Maury County Health Departments provided direct care to 199 unduplicated adult patients, completing 974 patient visits.

Referral, education, and case management services were provided to individuals from all counties in the state and managed through the program hotline and regional Community Dental Health Coordinators. Additionally, providers were present in all regions throughout the state.

While clinics faced huge demand for the services, staffing the dental clinics to capacity was a challenge, particularly in rural areas. After the onset of the COVID pandemic, people left the workforce temporarily due to health and caregiving challenges, and volunteers decreased as they had to manage their own practices. It took time for clinics to ramp back up and when they did, patients' oral health had gone backwards and those receiving care through SMILE ON 60+ required more visits to achieve health than projected.

Our data revealed that cost and/or lack of insurance was the most common barrier preventing older adults from finding a dental home. By offering care at a \$25 per visit cost, SMILE ON 60+ helped remove that barrier and 82% of our patients visited their dental home clinic 2 or more times.




Figure 21. SMILE ON 60+ Encounters

Tennessee State Oral Health Plan

The 2022 Edition of the Tennessee State Oral Health Plan is the second edition of the state's five-year statewide, comprehensive oral health plan. Building on Tennessee's long-standing commitment to improving oral health in Tennessee, the 2022 Tennessee State Oral Health Plan details how the Tennessee Department of Health is working to improve dental care access and expand Tennessee's dental care workforce. Additionally, the Plan includes recommendations that serve as a guide for the

Department's work in improving oral health. Recommendations focus on four key areas:

- 1. Access to Care
- 2. Oral Health Education and Advocacy
- 3. Prevention of Oral Disease
- 4. Oral Health Resources and Workforce

The plan can be found* at https://www.tn.gov/health/health-program-areas/oralhealth/state-oral-health-plan.html. The plan also includes the Healthy Smile Initiative, a public-private partnership supported by the Governor's Office and funded by the General Assembly to expand dental and dental hygienist training in the state, to expand safety net dental resource, and clinical placement of future dental workforce in rural and underserved areas of the state.

During Fiscal Year 2022 the Tennessee Oral Health Data source grid was updated. The data source grid provides information and instructions for accessing resources for dental care, preventive services, and various surveillance systems at the state and national level. The oral health grid is located on the department's website at https://www.tn.gov/health/health-plan/oral-%20health-resources-%20and-workforce-updates/oral-healthdata-resources.html

The interactive Dental Care for Tennesseans Map was updated. The Dental Care for Tennesseans map lists dental and health clinics across the state. These clinics help connect families to dental care. Some clinics may charge a lower fee. Dental services may be dental treatment, dental referrals, or a voucher (coupon) program. The map is located on the website at https://www.tn.gov/health/health-program-areas/oralhealth/dental-care-for-tennesseans.html Oral Health Services information on dental resources is also available on the MyTN app. MyTN is a mobile application providing personalized service delivery to Tennesseans through technology solutions. The website with information regarding MyTN is https://www.tn.gov/mytn.html.

Access to Health Care in Tennessee

To collect and assess Health Care Access data, the Tennessee Department of Health's SORH conducted a statewide Census of Primary Care Providers. The Census data is used to determine the ratio of the population to primary care providers, or the number of individuals expecting to be served by one provider in a county. The statewide list of providers is compiled using primary care census data from the previous year and the current list of Tennessee licensed providers. The survey scope is physicians, advanced practice nurses, and physician assistants practicing family practice, general practice, pediatrics, general internal medicine, public health, obstetrics, gynecology, or OB/GYN in an outpatient setting. The survey is sent to individual providers and collected via mail, electronic questionnaires, and phone interviews. Multiple attempts are made to collect data from each provider, so the shortage designations are as accurate as possible. Due to contributing factors such as outdated licenses, incomplete questionnaires, lack of responses, and invalid practice locations, estimations are then determined from previous cycle data or an average of other providers in the area.

The final data is computed from each provider's Full-Time Equivalent (FTE). One FTE is calculated at direct patient care divided by 40 hours weekly, anything less is considered a partial FTE, rounded to the nearest tenth. For each county or Rational Service Area (RSA), the FTEs are summed and compared to the appropriate population of the county or RSA. The FTE of an area will be equal to or less than the number of providers in the area since no provider may have an FTE greater than one, despite seeing patients for more than 40 hours weekly. The provider to population data collected from the census is shown by county with a corresponding map in **Appendix 4**. Counties represented on the maps in the none or worst category are listed in the table as "None identified" which means either no provider in that area or insufficient responses for that county. The ratio of primary care population to provider ratio is shown in **Appendix 5**.

Provider Shortage Areas

Federally designated Health Professional Shortage Areas and state-designated Health Resources Shortage Areas identify communities underserved by health professionals. Health Professional Shortage Area is a county or parts of a county (such as a census tract), or public facility recognized as meeting or exceeding the standards of need for certain services and must meet or exceed the following thresholds.

- For a Geographic designation, the population-to-physician ratio is greater than 3,500:1.
- For a Population designation, a segment of the population experiencing barriers to care has a population- to-physician ratio that is greater than 3,000:1.
- For a Facility designation, a public or private nonprofit medical facility is providing
 primary medical care services to an area or population group designated as having a
 shortage of primary care professionals, and the facility has insufficient capacity to
 meet the primary care needs of that area or population group. A community health
 center or homeless clinic is an example of such a designation.

Ninety-three of ninety-five counties in Tennessee contain designated shortage areas for primary medical care, dental and/or mental health services. **Appendix 4** represents the thirty counties with the worst population to provider ratios.

TennCare Providers

The population to provider ratio associated with access to a TennCare provider represents the number of TennCare Enrollees in the general population served by one primary care TennCare provider in a county. TennCare providers are defined as physicians, advanced practice nurses and physician assistants providing family and general practice, internal medicine, obstetrics, and pediatric health care. Very few providers accept 100% TennCare patients, so the FTEs are usually partials, computed from the percentage of the hours spent in direct patient care.

Oral Health Providers

Access to oral health services is an important contributor to health and wellbeing, yet many counties across the state are without dental providers. Six counties in Tennessee have no dental providers: Grundy, Houston, Lake, Meigs, Pickett, Van Buren counties. According to the latest *America's Health Rankings® Annual Report*, Tennessee has 48.6 dentists for every 100,000 residents, compared to the nationwide rate of 62.3 dentists per 100,000 residents, ranking Tennessee 45th among the 50 states¹.

Obstetric Providers

The worst primary care workforce shortages are in the field of Obstetrics. Ten Tennessee counties have zero obstetric providers. The population-to-provider ratio associated with access to an Obstetric provider represents the county population of women of childbearing age (15-44 years) served by one Obstetric provides. This is defined as physicians, advanced practice nurses, physician assistants, or certified nurse mid-wives who specialize in obstetrical care, or provide prenatal services and delivery, and clinicians who may provide obstetric services in addition to practicing in other patient care specialty areas. The population to obstetric provider ratio for each county is shown in **Appendix 5: Table 3, Figure 3**.

Pediatric Providers

The population-to-provider ratio associated with access to a Pediatric provider represents the number of children 0-18 years of age served by one pediatric provider in a county. This is defined as physicians, advanced practice nurses, or physician assistants with specialties in pediatrics or general pediatric care including those clinicians who may provide family and general practice in addition to pediatric health care. The population to pediatric provider ratio for each county is shown in **Appendix 5: Table 4, Figure 4**.

Mental Health Providers

According to the latest *America's Health Rankings*[®] *Annual Report*, Tennessee is ranked 45th among the 50 states for access to mental health professionals (psychiatrists, psychologists, licensed clinical social workers, counselors, marriage and family therapists, substance abuse treatment counselors, and advanced practice nurses and physician assistants specializing in mental health care), with 173.4 rate of mental health providers per 100,000 residents, far more than the national rate of 284.3 mental health providers per 100,000 residents¹.

Behavioral Health Safety Net Program

The Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS) administers the Tennessee Behavioral Health Safety Net (BHSN) Program. The program was initiated in 2005 as the Mental Health Safety Net with funding authorized by the

Tennessee General Assembly through Tennessee Public Chapter No. 474 and Section 59 of the Tennessee Appropriations Act of 2005. The BHSN Program provides essential outpatient mental health services to uninsured adult Tennesseans and uninsured/underinsured Tennessee children who meet program eligibility criteria through network of 15 BHSN Community Providers. Essential services include assessment, evaluation, diagnostic and therapeutic intervention, case management, transportation, peer support services, psychosocial rehabilitation services, psychiatric medication management, labs related to medication management, and pharmacy assistance and coordination. BHSN Providers serve eligible Tennesseans no matter which county they reside.

The BHSN Program serves Tennessee residents in all 95 counties. For Adults, there are 145 physical locations across 78 counties, with 61 of those counties being rural. For Children, there are 130 across 78 counties, with 61 of those counties being rural. Telehealth is significantly utilized for BHSN services, with 21% of BHSN services offered via telehealth in FY22.




Figure 22. Behavioral Health Safety Net Program Encounters

Despite the continued BHSN successes, as with most areas of healthcare across the country, workforce issues related to recruitment and retention within Tennessee's public behavioral health system have been a challenge. In FY22, through the generosity of Governor Bill Lee and the Legislature, TDMHSAS was able to increase seven (7) BHSN service rates to align with TennCare averages. These increases have supported cost-of- living salary adjustments for BHSN Provider staff and are assisting in addressing public

behavioral health workforce shortages. TDMHSAS will continue to explore future opportunities for incentivizing and building out the behavioral health workforce.

Over the last three fiscal years, TDMSHAS has been partnering with the State's Strategic Technology Solutions (STS) to modernize the BHSN System, a database supporting both BHSN enrollment and BHSN billing. In FY22, the final phase of this modernization involved the billing infrastructure and its completion greatly improve program efficiencies for TDMSHAS and for the BHSN Provider Network.

Special Populations

Ryan White Part B Enrollment

The Tennessee Department of Health jointly administers the Ryan White Part B program, with the Department of Health and Human Services. The Ryan White Program acts as a payer of last resort. Through revenue streams gained from federal grants and qualifying pharmaceutical rebates, the Ryan White Part B program provides HIV services for eligible clients, who have incomes up to 400 percent of the federal poverty levels. Some of the key services provided by the Ryan White Part B program to eligible clients include: 1) the Insurance Assistance Program (IAP), which covers insurance premiums for outpatient medical care and prescriptions; 2) the HIV Drug Assistance Program (HDAP), which procures and directly delivers antiretroviral and other HIV treatment drugs to eligible clients that are uninsured; and 3) supporting a network of clinics, private practitioners, and health departments across the state that provide outpatient medical services to people living with HIV/AIDS. In FY22, the Ryan White Part B Program spent \$19.1 million to serve 10,700 clients.




Figure 23. Ryan White Part B Clients' Utilization of the HIV Drug Assistance Program (HDAP) and Insurance Assistance Program (IAP)

Figure 23 below provides an update on the number of clients the Tennessee Ryan White Part B program supports concerning IAP and HDAP services. The 8,131 clients in Tennessee

that receive IAP and HDAP services from the Ryan White program, account for 43 percent of Tennessee's estimated 19,000 persons living with HIV/AIDS.

Children's Special Services Program

The Children's Special Services (CSS) Program may provide coverage for comprehensive medical care and other non-medical resources for children with physical disabilities and special health care needs from birth to 21 years of age. Diagnostic and financial eligibility criteria must be met to participate in the program. The CSS program has two components: medical services and care coordination.

The medical services component provides for reimbursement of medical services, i.e., physician/clinic visits, hospitalizations, medical supplies, pharmaceuticals, durable medical equipment, and therapies for children who meet medical and financial eligibility requirements.

The care coordination component assists families of eligible children with coordinating primary and specialty care through the designated primary care physician and corresponding managed care organization networks. Care coordinators assist the family in accessing many services (educational, medical, social, transportation, support, and advocacy).

The CSS program is a critical gap -filling program supported by federal and state Maternal and Child Health Block Grant funds. It serves as both a payor of last resort for Children and Youth with Special Health Care Needs (CYSHCN) as well as a care coordination entity for

these families. Founded in 1919, CSS is governed by state statute, and departmental rules. Services are provided in all 95 counties through local and metropolitan health departments.




Figure 24. CSS Reimbursement for Medical Services by Payor Source FY20 – FY 21

Current Issues and Priorities

The Tennessee Department of Health takes a comprehensive and collaborative approach to providing excellent healthcare services and increasing access to communities across the state. The approach is facilitated by the TDH Strategic Plan and strategic planning process, in coordination with the State Office of Rural Health and Health Access, and other stakeholders throughout the TDH.

As oral health services in Tennessee continue to be deficient and are one of TDH and Governor Bill Lee's priorities, the Healthy Smiles Initiative was developed. It was the result of a working group of TDH and stakeholders to develop a comprehensive public-private partnership to broaden access to high-quality, low-cost dental care to Tennesseans. The goal of the Healthy Smiles Initiative is to increase access to dental care in Tennessee, particularly among rural and underserved populations.

These opportunities have allowed TDH to set up two dental expansion programs to increase access to dental care for senior adults and provide prosthodontics throughout Tennessee.

In addition, TDH will also be funding the Tennessee Dental Recruitment and Incentive Program to provide incentives to dentists, dental hygienists, and dental assistants with outstanding education loans in exchange for a practice obligation in an underserved area. A Community Dental Health Coordinator Training program will also be implemented to increase access to care by focusing on community-based prevention, care coordination, and patient navigation to help individuals get the dental health resources.

The devastation from the pandemic continues to affect workforce shortages across Tennessee. Individuals are more at ease with scheduling appointment and the demand is increasing but a severe shortage still exists with the demand even higher in rural populations due to an increase in chronic illness and the need for primary and specialty care.

Currently, TDH is working on additional strategies to increase recruitment and retention efforts to place primary, mental, and oral healthcare practitioners in shortage areas through the Tennessee Student Loan Repayment Program (TSLRP). Based on existing data and feedback from stakeholders in our small rural hospitals and Safety Net clinics, there has been an additional demand for nursing professionals. Historically TSLRP has not provided funding to Registered Nurses, but this additional funding is crucial to eliminating health disparities and placing providers in the most vulnerable, underserved communities.

Final Thoughts

The Uninsured Adult Healthcare Safety Net fund helps to fulfill the mission of the Tennessee Department of Health to protect, promote, and improve the health and prosperity by enhancing equitable access to quality, affordable primary care, dental, behavioral health, and care coordination services for uninsured adults in Tennessee. Likewise, the Behavioral Health Safety Net advances the mission of the Tennessee Department of Mental Health and Substance Abuse Services to create collaborative pathways to resiliency, recovery and independence for Tennesseans living with mental illness and substance use disorders.

The Tennessee Department of Health is grateful to the commitment, hard work, and innovation of its partners and providers for their collaborative work to address the healthcare challenges together. Tennessee Department of Health also wants to acknowledge and recognize each of the dedicated professionals and volunteers at

community health centers, community and faith-based clinics, Project Access entities, community mental health agencies and local health departments with support from professional associations including the Tennessee Primary Care Association, the Tennessee Charitable Care Network, the Tennessee Association of Mental Health Organizations, and many others. The greatest strength of the Uninsured Adult Healthcare Safety Net Program is the dedicated workforce and their ability to provide, sustain, and increase healthcare services for the most vulnerable Tennesseans. Additionally, we appreciate Tennessee Governor Bill Lee and members of the Tennessee General Assembly for supporting the expansion of safety net programs to meet the needs of rural Tennesseans, remove the barriers to care, and work to overcome the ongoing challenges to promote access to quality and equitable health care in Tennessee.

Glossary of Terms

Behavioral Health Safety Net - Pursuant to Tenn. Code Ann. § 71-5-148, the behavioral health safety net fund provides support for community-based providers of behavioral health services to seriously and persistently mentally ill adults who are uninsured and lack financial resources to secure behavioral health care.

Census of Primary Care Providers - A census that is conducted annually by the Tennessee Department of Health State Office of Rural Health and Health Access for 4 categories of healthcare providers: Primary Care, Obstetrics, Pediatrics, and TennCare. The Census collects full-time equivalents data for Physicians and Mid-level Providers (advance practice nurses and physician assistants). The purpose of the Census is to determine the ratios of population to healthcare providers in order to accurately identify Health Resource Shortage Areas in the state.

Federally Qualified Health Center (FQHC) - Federally Qualified Health Centers are public and private non-profit clinics that meet certain criteria under the Medicare and Medicaid programs and receive federal grant funds under the Health Center Program, established as Section 330 of the Public Health Service Act (PHSA). Some target specially defined populations such as migrant and seasonal farmworkers or homeless persons, while others target a general community and are commonly referred to as "community health centers." These facilities meet the requirements of 42 U.S.C. § 1396d(l)(2)(B) and 42 U.S.C. § 254b. Applications to be designated as an FQHC are considered only when additional funding becomes available.

Health Care Safety Net for Uninsured - Pursuant to Tenn. Code Ann. §71-5-148(a) the health care safety net program provides funding in support of medical and dental assistance to uninsured adults, 19-64 years of ages.

Health Care Services - As applied to FQHCs by Tenn. Code Ann. § 71-5-148(2) means the same as "Primary Care" and "Required Primary Health Services" and "Behavioral Consultations" as applied to FQHCs by 42 U.S.C. § 254b and incorporated in 42 U.S.C. § 1396d(I)(2)(B).

Health Professional Shortage Area (HPSA) - Federally designated county, parts of a county (such as a census tract), or public facility recognized as meeting or exceeding the standards

of need for certain services. Primary care HPSA status is a national measure used to denote difficulties in access to care. A HPSA must meet or exceed the following thresholds:

- For a Geographic designation, the population-to-physician ratio is greater than 3,500:1.
- For a Population designation, a segment of the population experiencing barriers to care has a population- to- physician ratio that is greater than 3,000:1.
- For a Facility designation, a public or private nonprofit medical facility is providing primary
 medical care services to an area or population group designated as having a shortage of
 primary care professionals, and the facility has insufficient capacity to meet the primary
 care needs of that area or population group. A community health center or homeless
 clinic is an example of such a designation.

Medical Encounter - A day on which a primary care provider meets with an uninsured adult regardless of the number of procedures performed or the number of primary care providers who see the uninsured adult.

Primary Care Provider or PCP - A physician (MD or DO), licensed psychologist, licensed clinical social worker (LCSW), advanced practice nurse (APN), licensed medical social worker (LMSW), psychiatric nurse specialist (PNS), certified nurse midwife, or physician assistant (PA) actively licensed to practice in Tennessee.

Sliding Scale - Rates charged to an uninsured adult based on 42 U.S.C. § 254b(k)(3)(G) and 42 C.F.R.§ 51c.303(f).

Uninsured Adult - A patient aged nineteen (19) through sixty-four (64) years who is uninsured pursuant to Tenn. Code Ann. §71-5-148(a).

Appendix 4: Health Resource Shortage Areas 2022


In 1989, the Tennessee General Assembly amended the Tennessee Code Annotated, Title 66, Chapter 29, Part 1 to require the Commissioner of Health to designate Health Resource Shortage Areas, to inform decisions about allocation of funding for programs intended to encourage the location of health care practitioners in areas of greatest need. Health Resource Shortage Areas (HRSA) are identified as the 30 counties of the state with the worst

population- to- provider ratios, as calculated by comparing the relevant population to the number of full-time equivalent clinicians practicing in that area, as follows:

Health Resource Shortage Area (HRSA): The 30 highest ranking "population-to-provider ratios" for Rational Service Areas designated for Primary Care, Obstetric, Pediatric, TennCare and Dental providers. Note: Multiple counties may have the same rank number resulting in the top 30 shortage areas possibly having more than 30 counties.


TennCare HRSA: The 30 highest ranking TennCare enrollees to TennCare provider ratios among the TennCare Rational Service Areas. TennCare primary care providers are defined a physician, advanced practice nurse and physician assistant providing primary care services to the TennCare enrollees within a TennCare Rational Service Area.






Primary Care HRSA: The 30 highest ranking total population to primary care provider ratios among the Primary Care Rational Service Areas. A Primary Care provider is defined as a family practice, internal medicine and general practice physician, family nurse practitioners and physician assistants.

Appendix 4, Figure 2. FY 22 Primary Care Health Resource Shortage Areas



Appendix 4, Figure 3. FY 22 Obstetric Health Resource Shortage Areas




Appendix 4, Figure 4. FY 22 Pediatric Health Resource Shortage Areas

Appendix 5: Population to Provider Ratios 2022





Appendix 5, Figure 2. FY 22 Population to Primary Care Provider Ratio Map



Appendix 5, Figure 3. FY 22 Female Population of Childbearing Age to Obstetric Provider Ratio Map


