The Board of Dentistry has the duty and responsibility to function in such a manner as to promote and protect the public's health, safety and welfare. Thus, the Board must review licensure applications and determine whether the applicant is qualified to be issued a license in accordance with the facts, the law and the regulatory statutes governing the profession, public welfare demanding it. *Policy Statement Adopted May 1998*

NEW POLICIES AND ISSUES DISCUSSED BY THE BOARD

The board discussed and determined the following at the January 2011 meeting:

POLICY STATEMENT ON OWNERSHIP OF DENTAL PROFESSIONAL CORPORATIONS AND DENTAL PROFESSIONAL LIMITED LIABILITY COMPANIES

The Board voted to issue this policy regarding the definition of "owner" under Rule 0460-01-.08. In addition to issuance of the policy, it is the Board's wish to review this language at a properly noticed rulemaking hearing for a possible amendment to the referenced rule.

For the purpose of Rule 0460-01-.08(1) regarding Dental Professional Corporations (D.P.C.), "owner" means a stockholder dentist with an active Tennessee license issued pursuant to Tennessee Code Annotated Title 63, Chapter 5.

For the purpose of Rule 0460-01-.08 (2) regarding Dental Professional Limited Liability Companies (D.P.L.L.C.), "owner" means a member dentist with an active Tennessee license issued pursuant to Tennessee Code Annotated Title 63, Chapter 5.

Adopted by the Board of Dentistry on January 28, 2011.

The board discussed and determined the following at the September 2011 meeting:

POLICY STATEMENT ON USE OF LASERS FOR DEBRIDEMENT AND BACTERIAL REDUCTION BY DENTAL HYGIENISTS

The position of the Tennessee Board of Dentistry is that the use of lasers for debridement and bacterial reduction by licensed dental hygienists is permitted after a certification course which should include didactic and hands-on training.

Adopted by the Board of Dentistry on September 9, 2011.

The board discussed and determined the following at the May 2012 meeting:

POLICY STATEMENT ON ACCEPTANCE OF THE AMERICAN BOARD OF DENTAL EXAMINERS, INC. (ADEX) EXAMINATION

The Tennessee Board of Dentistry has determined that the American Board of Dental Examiners, Inc. (ADEX) examination is closely aligned to the examination given by the Southern Regional Testing Agency (SRTA).

For licensure credentialing the candidate must have passed the ADEX exam administered by SRTA or NERB. In addition, the WREB and CRDTS exam will also be accepted.

Accordingly, it is the Board's policy that any applicant for licensure by examination who relies on ADEX scores must have successfully completed such examination in order to meet the requirements for licensure by examination.

Adopted by the Board of Dentistry on May 18, 2012.

The following issues were also discussed by the Board.

At the September 2011 meeting, the Board clarified Rule 0460-03-.09 Scope of Practice, in particular (1)(a) "performing clinical examination of teeth and surrounding tissues for diagnosis by the dentist", as it relates to performing and charging for periodic evaluation when treating a patient under general supervision. It was the opinion of the Board that a hygienist can do an examination for diagnosis by a dentist and that it is the office charging for the exam and not the hygienist.

STATUTORY CHANGES OF INTEREST

The Board of Dentistry's administrative staff has monitored several bills that are of interest to dental professionals in the state of Tennessee. Below is a brief summary of the entire text of those bills. If you wish to review any of these public chapters in their entirety, please visit: <u>http://www.tennessee.gov/sos/acts/index.htm.</u> From the 2011 Legislative Session:

Public Chapter 75- Provides that each licensed dentist shall conspicuously display an original or a copy of his/her license or certification displayed in the office or place of practice and shall conspicuously display a sign in intelligible lettering and not less than one inch (1") in height, containing the name of such licensee immediately followed by the recognized abbreviation indicating the professional degree, if any held by such licensee, and containing immediately below the licensee's name, in equal size lettering, the following words: "Dentist", "doctor of dental surgery" or "doctor of dental medicine" for practitioners of dentistry. A licensee may substitute a specialist designation for these words for any specialized field that is recognized or approved by the appropriate board licensing that profession. The licensee shall also affirmatively communicate the licensee's specific licensure through one (1) of the following methods: (1) licensee shall wear a photo identification name tag during all patient encounters that contains a recent photograph of the licensee with the licensee's full name and license type; or (2) licensee shall communicate to a patient the licensee's full name and license type in writing at the patient's initial office visit after January 1, 2012. In communicating the license type, the licensee shall use one of more of these words: "Dentist", "doctor of dental surgery" or "doctor of dental medicine" for practitioners of dentistry. All licensees are required to comply with these requirements at each practice setting. These requirements do not apply to licensees working in licensed health care facilities or to licensees who are not working in patient care settings who have no direct patient care interactions. A licensee who provides information regarding healthcare services on the internet that is directly controlled or administered by the licensee or licensee's agent, shall prominently display on the internet the licensee's full name and type of license using one (1) or more of the following words: "Dentist", "doctor of dental surgery" or "doctor of dental medicine" for practitioners of dentistry. A licensee who violates the provisions of this law may be subject to disciplinary action by the Board of Dentistry. The provisions of this law shall

Public Chapter 132- Provides that a dental hygienist is an individual who has graduated from a dental hygiene program accredited by the American Dental Association's Commission on Dental Accreditation ("CODA") and is licensed to practice dental hygiene. Law provides that the practice of dental hygiene is the performance of preventive, educational, and therapeutic services performed under the supervision of a licensed dentist and includes the following: removal of hard and soft deposits and stain from teeth; polishing teeth; performing clinical examination of teeth and surrounding tissue for diagnosis by a dentist; and performing other procedures delegated by a licensed dentist. A dental hygienist shall perform root planning, subgingival curettage, administering nitrous oxide, and local anesthesia under the direct supervision of a licensed dentist. A dental hygienist may perform all other dental hygiene services not specifically listed under the general supervision of a licensed dentist for not more than fifteen (15) consecutive business days as long as the hygienist has at least one (1) year of full-time or equivalent amount of experience

practicing dental hygiene; the hygienist complies with written protocols; the supervising dentist examined the patient not more than seven (7) months prior to the date that the hygienist provides the services; hygienist provides services to the patient in accordance with a written treatment plan; and the patient is notified in advance of the appointment that the supervising dentist will be absent from the location of the appointment and that the hygienist cannot diagnose.

Public Chapter 166- Provides that a prescription label for any legend drug for all patients shall contain an indication or indications for which the drug is being prescribed if the indication or indications are requested by the prescriber, patient or patient's caregiver and the prescriber, patient or caregiver provides the indications to the pharmacist dispensing the drug.

Public Chapter 218- Amends the law to provide that a restriction on the right of an employed or contracted healthcare provider to practice the healthcare provider's profession upon the termination or conclusion of the employment or contractual relationship shall apply to osteopathic physicians as well as podiatrists, chiropractors, dentists, medical doctors, optometrists, and psychologists. The new law also removes the provision contained in the prior law that did not have the restriction apply to a healthcare provider who had been employed by, or under contract with, the employing or contracting entity for at least six (6) years.

Public Chapter 230 - Provides that each health-related board shall establish a procedure to expedite the issuance of a license, certificate, or permit for an applicant who is certified or licensed in another state to perform the same profession that is the subject of the application; whose spouse is a member of the armed forces; whose spouse is the subject of a military transfer to Tennessee; and who has left employment to accompany the person's spouse to Tennessee. The procedure shall include issuing the applicant a license, certificate, or permit if the licensure requirements in the other state are substantially equivalent to Tennessee's requirements or developing a method to authorize the applicant to practice in Tennessee with a temporary permit in accordance with current law (T.C.A. §63-1-142).

Public Chapter 435 - Provides that any governmental entity or private business or establishment that provides or offers a place of assembly or entertainment, transportation, lodging, dining, educational, medical or leisure activities or services, or any business or any establishment licensed by the State or any political subdivision thereof, or that is engaged in commerce in this State is strongly encouraged to post a sign indicating that certain information regarding the Tennessee human trafficking resource center hotline is in a location within the establishment that is visible to employees and the general public. The Department of Labor and Workforce Development shall provide the sign authorized by this section on its internet website for entities or establishments to print as needed.

From the 2012 Legislative Session:

Public Chapter 628 - SECTION 1. Tennessee Code Annotated, Section 63-5-103, is amended by deleting subsection (a) in its entirety and by substituting instead the following:

(a)(1) The dentist members of the board may be appointed by the governor from lists of qualified nominees submitted by interested dentist groups including, but not limited to, the Tennessee Dental Association. No person is eligible for appointment as a dentist member of the board unless such person has been an actual and bona fide resident and a legally licensed practicing dentist of this state for a period of five (5) years or more immediately preceding such appointment.

(2) The dental hygienist members may be appointed by the governor from lists of qualified nominees submitted by interested dental hygienist groups including, but not limited to, the Tennessee Dental Hygienists Association. No person is eligible for appointment as a dental hygienist member of the board unless that person has been an actual and bona fide resident and a legally licensed practicing dental hygienist of this state for a period of five (5) years or more immediately preceding such appointment.

(3) The dental assistant member may be appointed by the governor from lists of qualified nominees submitted by interested dental assistant groups including, but not limited to, the Tennessee Dental Assistants' Association. No person is eligible for appointment as a dental assistant member of the board unless that person has been an actual and bona fide resident and has been a legally registered and practicing dental assistant of this state for a period of five (5) years or more immediately preceding such appointment.

SECTION 2. Tennessee Code Annotated, Section 63-5-103, is further amended by adding the following language immediately preceding subsection (b) and by redesignating the subsequent subsections accordingly:

(b) The governor shall consult with interested dental groups including, but not limited to, the Tennessee Dental Association, the Tennessee Dental Hygienists Association and the Tennessee Dental Assistants' Association to determine qualified persons to fill the positions as provided in subsection (a).

SECTION 3. This act shall take effect upon becoming a law, the public welfare requiring it.

The provisions of this law became effective March 23, 2012.

Public Chapter 945 - SECTION 1. Tennessee Code Annotated, Section 63-5-108(c)(5)(c), is amended by deleting the words "seven (7) months" and substituting instead the words "eleven (11) months".

SECTION 2. Tennessee Code Annotated, Section 63-5-115, is amended by deleting the second sentence in subsection (a) and inserting the following: "Such licensed and registered dental hygienists may practice as authorized in this section or § 63-5-108 only in the office of and under the direct and/or general supervision of a licensed and registered dentist, in authorized public health programs or at other locations otherwise authorized by this chapter."

SECTION 3. Tennessee Code Annotated, Section 63-5-115, is amended by deleting subsection (d) in its entirety and by substituting instead the following:

(d)(1) Settings in which licensed and registered hygienists may engage in the provision of preventive dental care under the general supervision of a dentist through written protocol include nursing homes, skilled care facilities, nonprofit clinics and public health programs. Dental hygienists licensed and registered pursuant to this chapter are specifically permitted to render such preventive services as authorized in § 63-5-108 or by regulation of the board, as prescribed by the supervising dentist under a written protocol. Dental hygienists rendering such services shall be under the general supervision of a licensed dentist as specified in a written protocol between the supervising dentist and the hygienist which must be submitted in advance to the board. No dentist may enter into a written protocol with more than three (3) dental hygienists at any one time nor may any hygienist be engaged in a written protocol with more than three (3) dentists at any one time. The supervising dentist must process all patient billings. Each written protocol will be valid for a period of two (2) years at which time it must be renewed through resubmission to the board. Should a dentist cease to be the employer/supervisor of a dental hygienist where a written protocol is in force and on file with the board, the dentist must

notify the board within ten (1 0) working days by certified mail/return receipt requested or electronic mail that the written protocol is no longer in force.

(2) Licensed and registered dental hygienists working under written protocol, in addition to those requirements enumerated under the general supervision as authorized by § 63-5-108(c)(5), must have actively practiced as a licensed dental hygienist for at least five (5) years and have practiced two thousand (2,000) hours in the preceding five (5) years or taught dental hygiene courses for two (2) of the proceeding three (3) years in a dental hygiene program accredited by the American Dental Association's Commission on Dental Accreditation and completed six (6) hours of public health continuing education within the past two (2) years; provided, after satisfying the requirement of this subsection (d), in subsequent years the hygienist may work on a part-time basis.

(3) Each written protocol, required for off-site practice under general supervision, shall be submitted to the board by certified mail/return receipt requested and shall include at a minimum:

(A) The name, address, telephone number and license number of the employer (supervising) dentist;

(B) The name, address, telephone number and license number of the dental hygienist;

(C) The name, address, telephone number and other pertinent identification from all locations where the dental hygiene services are to be performed; and

(D) A statement signed by the dentist that the dentist and the dental hygienist that meets all minimum standards for general supervision as well as those required for practice under a written protocol as stipulated in this section and § 63-5-1 08.

(4) The board will receive each written protocol submitted and keep those on file which meet the minimum requirements enumerated in subsection (f). Those received by the board and determined not to be complete shall be returned to the submitting dentist within thirty (30) days of receipt with a request for the additional information required. The dentist may then resubmit an amended written protocol to the board.

The provisions of this law became effective May 10, 2012.

Public Chapter 880 - Amended Tennessee Code Annotated, Title 53, Chapter 10, Part 3; Title 53, Chapter 11, Part 3; Title 53, Chapter 11, Part 4 and Title 63, Chapter 1, Part 3, relative to controlled substance database, criminal penalties and enforcement of narcotic drugs and drug control.

At the January 2012 and May 2012, the board discussed the certifications required for dental hygienists and registered dental assistants before certain procedures can be performed. The Tennessee Board of Dentistry reminds all licensees that any licensed and registered dental hygienist, registered dental assistant and/or practical dental assistant operating under a dentist's supervision must apply for and complete a Board-approved certification course and obtain their certification, issued by the Board, before he/she can provide services relating to sealants, nitrous oxide, radiographs and any other procedure that requires additional certification.

Listed below are the areas of practice in which a dental hygienist or registered dental assistant must attend a board approved course and receive certification from the Tennessee Board of Dentistry prior to such providing service:

Dental Hygienists

Administration and Monitoring of Nitrous Oxide Certification

- Prosthetic Function Certification
- Restorative Function Certification
- Administration of Local Anesthesia Certification

Dental Assistants

- Coronal Polishing Certification
- Dental Radiology Certification
- Monitoring Nitrous Oxide Certification
- Sealant Application Certification
- Prosthetic Function Certification
- Restorative Function Certification

The Tennessee Board of Dentistry may lawfully discipline and assess a civil penalty for each separate violation against any dentist who allows a licensed and registered dental hygienist, registered dental assistant and/or practical dental assistant under his supervision to administer any of the aforementioned services without being issued proper certification from the Board.

The Tennessee Board of Dentistry may lawfully discipline and assess a civil penalty for each separate violation against any licensed and registered dental hygienist, registered dental assistant and/or practical dental assistant who administers any of the aforementioned services without being issued proper certification from the Board.

It is important that the employer dentist, supervising dentist and licensed hygienist or registered dental assistant check his/her license and registration to make sure that it accurately reflects those additional duties which the individual is legally allowed to perform.

At the May 2012 meeting, the board also discussed correspondence received on the following:

 A dental office inquired about offering a promotion for existing patients called "Care to Share" where when an existing patient refers a new patient to the office would offer that existing patient up to \$50.00 off needed treatment completed within six months of the referral. The rules of the program require that referred (new) patient schedule and keep an initial appointment at the office and once the new patient has kept their initial appointment, the referring (existing) patient would be eligible to receive up to \$50 off any planned treatment for a period of up to six months following the referred patients first appointment. After discussion, the board determined that this was not fee splitting and that it is allowed under the current statutes and rules governing the practice of dentistry.

• The Tennessee Dental Association requested clarification on adjusting appliances by dental assistants. After discussion, the board clarified that dental assistants and dental hygienists cannot adjust dental appliances in the mouth.

2010 and 2011 CONTINUING EDUCATION AUDIT REPORT

The board's administrative office is randomly auditing dental professionals each month. Non-compliant dental professionals are subject to board discipline which includes a fine of \$600 for dentists, \$300 for dental hygienists and \$150 for registered dental assistants and a requirement to make up the delinquent hours and/or CPR. RULE CHANGES

There were rule changes effective March 19, 2012 that changed the requirement to obtain the coronal polishing certification. The Board approved courses will now be required to include a clinical examination in the course. The final clinical examination given by the Board will be held on September 22, 2012. Registered dental assistants who completed a Board approved course prior to 2012 and have not passed the Board's examination must pass the September examination or they will be required to repeat the coronal polishing course before the certification can be added to their registration.
