The Tennessee Massage Licensure Board is composed of seven (7) members. members are licensed massage therapists and (2) members are citizen members.

MISSION OF THE BOARD

The Board's purpose is to protect the public beina misled by incompetent, unscrupulous and unauthorized practitioners, and from unprofessional or illegal practices by persons licensed to practice massage therapy. The Board adopts and interprets the laws, rules, and regulations to establish and maintain a high standard of integrity, skills, and practice in the profession of massage therapy. The board is responsible for the investigation of alleged violations of the Practice Act and rules and is responsible for the discipline of licensees who are found quilty of such violations.

BOARD ADMINISTRATIVE OFFICE TO RELOCATE

The Department of Health's Division of Health Licensure and Regulation, Office of Health Related Boards, will be transitioning from leased space at Heritage Place Metro Center to a newly renovated state-owned space. CONTINUING EDUCATION (CE) HOURS OBTAINED VIA MULTI-MEDIA FORMAT

At the meeting held on August 5, 2013, the Board stated that all continuing education hours, including all make up and penalty hours for non-compliance for the 2011-2012 audit shall meet cvcle. the current requirements. Rule 0870-01-.12 states that each licensed massage therapist must attend and complete twenty five (25) hours of massage therapy-related continuing education every two (2) calendar years in courses approved by the Board, and only eight (8) of the twenty-five (25) hours required may be completed in a multi-media format. Based upon the revised rules, licensees are only permitted to obtain a maximum of eight (8) hours via multi-media format to fulfill the continuing education requirements for both cycles. The Board's decision is effective October 1, 2013 and applies for all audit cycles from the effective date forward for as long as the therapist license remains active. The administrative office will accept all makeup and penalty hours obtained via multi-media format for the 2009-2010 & 2011-2012 audit cycle for hours that were completed before October 1, 2013.

ELECTRONIC NOTICES TO LICENSEES

On January 1, 2013, a new law, Public Chapter 952, became effective requiring healthcare professional licensing boards to provide electronic notices to licensees. The law gives you the **option** of being notified electronically of the following: (1) Renewals of license, certification, or registration; (2) Any fee increases: (3) Any changes in state law that impact the license holder; and (4) any board meeting where changes in rules or fees are on the agenda. If you "opt in", the Department of Health will also be able to alert you of critical public health matters impacting the State of Tennessee.

Please visit https://apps.tn.gov/hlrs/begin.jsp and complete the registration process to opt in. Once you opt in and provide a current email address, you will begin to receive ALL notices electronically rather than through the United States Postal Service mail. Please not that opting in means your renewal notification will be delivered electronically approximately 45 days in advance of the expiration date of your license. The e-notice will direct you to the appropriate webpage to renew. If your profession does not permit you to renew your license online, a paper renewal will continue to be provided.

CONTINUING EDUCATION (CE) VIOLATIONS

Due to the consistently high percentage of massage therapists failing to obtain the required hours, a 100% audit of continuing education hours is conducted.

Reminders:

- All licensees must complete twenty-five (25) hours of CE every two calendar years.
- Two (2) of the twenty-five (25) required hours shall pertain to Tennessee statutes and rules concerning massage therapists and establishments.
- Two (2) of the twenty-five (25) required hours shall pertain to practice management, professional ethics, or substance abuse.
- Eight (8) of the twenty-five (25) required hours may be obtained via multi-media format.
