The meeting was called to order at 9:13 a.m. by Dr. Ed Bolden, Board Chairperson. Dr. Bolden welcomed everyone to the meeting and encouraged the students to attend the Board meetings and become an active part of the massage and body work profession. Dr. Bolden said the reason the Board exists is to protect the health, welfare and safety of the citizens of the state of Tennessee. Dr. Bolden welcomed Ms. Debra Persinger, Executive Director of the Federation of State Massage Therapy Boards and Francine Baca-Chavez, Deputy General Counsel. Prior to conducting business, Lisa Lampley conducted a roll call to establish a quorum. A quorum was present.

<u>Minutes</u>

Upon review of the February 9-10, 2015 minutes and the March 30, 2015 minutes, Ms. Cross made a motion, seconded by Ms. Easterly, to approve the minutes as written. The motion carried.

Applicant Interviews

Xiaozhu Hong, LMT – Hong Massage & Hong Spa

Ms. Hong appeared before the Board to answer and explain concerns regarding her establishment applications. The Board reviewed new establishment applications for Xiaozhu Hong, a licensed

massage therapist who applied for establishment licenses for Hong Massage and Hong Spa in Knoxville, TN. Ms. Hong's previous establishment applications were denied at the May 4, 2015 meeting due to evidence that showed Ms. Hong's establishments had been open and in operation before being approved for an establishment license. At the May 4, 2015 meeting, the Board based their decision for denial on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). Upon the Board reviewing Ms. Hong's newly submitted establishment applications at the August 10, 2015 meeting, it was determined that Ms. Hong had continued to operate Hong Massage after the Board had directed her at the May 4, 2015 meeting to close the establishment. The Board reviewed a statement from the Knox Co. Sheriff Department that Hong Massage was open as of July 15, 2015. The Tennessee Massage Board administrative office provided an interpreter from the Tennessee Foreign Language Institute for interview. The interpreter, Ms. Jiao Hoggard, translated the Board's questions and concerns regarding Ms. Hong's licensure applications that she submitted for Massage Establishments in Tennessee. After a brief discussion, Mr. Velker made a motion to deny both of Ms. Hong's establishment applications based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). Ms. Cross seconded the motion, and the motion carried.

Sheng En Sun

The Board reviewed the massage therapist application for Sheng En Sun at the May 4, 2015 meeting and deferred the application to the August 10, 2015 meeting to allow him the opportunity to submit the final court documents regarding his arrest for impersonation of a licensed professional. Mr. Sun was not present at the August 10, 2015 meeting, but he did submit his final court documents to the Board Administrative Office. Mr. Sun was convicted of impersonating a licensed professional, and was placed on probation and parole until June 8, 2016. The Administrative Office requested for Mr. Sun to contact TnPAP for an evaluation. The Board, at its discretion, may deny an application, based upon the Board's Policy regarding applicants currently on criminal probation. Ms. Cross made a motion seconded by Ms. Burke, to proceed with a discussion and a decision regarding Mr. Sun's file. The motion carried. After a brief discussion, Ms. Cross made a motion, seconded by Mr. Velker to deny Mr. Sun's massage therapist application based on T.C.A 63-18-108 (1)(7). The motion carried.

<u>Feng Pan</u>

Mr. Pan was asked to appear before the Board to answer and explain concerns regarding the educational transcript submitted for his massage therapy application. The Board reviewed the massage therapist application of Feng Pan. Mr. Pan was asked to attend the meeting because his application was first reviewed by the Applicant Review Committee at the April 16, 2015 meeting. Mr. Pan was present at the April 16, 2015 meeting, and the ARC Committee requested additional documentation be provided to show proof of attendance at California Trinity College. Mr. Pan was then requested to attend the July 17, 2015 ARC meeting to provide the requested additional documentation. Mr. Pan was not present at the July 17, 2015 ARC meeting. At the July 17, 2015 the Committee recommended denial of Mr. Pan's massage therapist application. The Committee's decision was based on evidence that the massage school he attended, California Trinity University, was called into question by the California Massage Therapy Council (CAMTC) and is now listed as an unapproved school effective September 30, 2015 on the CAMTC website. The Administrative Office sent him an additional letter requesting him to attend the August 10, 2015 meeting. Mr. Pan was not present. Ms. Cross made a motion seconded by Mr. Velker, to proceed with a discussion and a decision regarding Mr. Pan's file. The motion

carried. After a brief discussion, Ms. Easterly made a motion, seconded by Ms. Cross to deny Mr. Pan's massage therapist application based on T.C.A 63-18-108 (1)(7). The motion carried.

Dan Wang

Ms. Wang was asked to appear before the Board to answer and explain concerns regarding the educational transcript submitted for her massage therapy application. The Board reviewed the massage therapist application of Dan Wang. Ms. Wang was asked to attend the meeting because her application was first reviewed by the Applicant Review Committee at the April 16, 2015 meeting. Ms. Wang was present at the April 16, 2015 meeting, and the ARC Committee requested additional documentation be provided to show proof of attendance at California Trinity College. Ms. Wang was then requested to attend the July 17, 2015 ARC meeting to provide the requested additional documentation. Ms. Wang was not present at the July 17, 2015 ARC meeting. At the July 17, 2015 the Committee recommended denial of Ms. Wang's massage therapist application. The Committee's decision was based on evidence that the massage school she attended, California Trinity University, was called into question by the California Massage Therapy Council (CAMTC) and is now listed as an unapproved school effective September 30, 2015 on the CAMTC website. The Administrative Office sent her an additional letter requesting her to attend the August 10, 2015 meeting. Ms. Wang was not present. Ms. Cross made a motion seconded by Ms. Easterly, to proceed with a discussion and a decision regarding Ms. Wang's file. The motion carried. After a brief discussion, Ms. Cross made a motion, seconded by Mr. Veker to deny Ms. Wang's massage therapist application based on T.C.A 63-18-108 (1)(7). The motion carried.

<u>Guan Ren Zhou</u>

The Board Administrative Staff requested that Mr. Zhou's massage therapist application be deferred until the November 2, 2015 meeting. Ms. Burke made a motion, seconded by Ms. Cross to defer Mr. Zhou's application until the November 2, 2015 Board meeting. The motion carried.

Dong Mei Ni

Ms. Ni was asked to appear before the Board to answer additional questions and concerns regarding the educational transcript submitted for her massage therapy application and, owning and operating unlicensed establishments. The Board reviewed the massage therapist application of Dong Mei Ni. Ms. Ni was asked to attend the meeting as her application was initially denied by the Applicant Review Committee at the July 17, 2015 meeting. The Committee's decision was based on evidence that Ms. Ni attended a massage school that was subsequently unapproved by the California Massage Therapy Council, owned and operated two unlicensed massage establishments, employed unlicensed therapist at at least one of the establishments, continued to operate one of the establishment after the Board denied the establishment application, and she was untruthful with the ARC Committee during her interview on July 17, 2015. The Tennessee Massage Board administrative office provided an interpreter from the Tennessee Foreign Language Institute for interview. The interpreter, Ms. Jiao Hoggard, translated the Board's questions and concerns regarding Ms. Ni's massage therapist licensure application. After a brief discussion, Ms. Wray made a motion, seconded by Ms. Cross to deny Ms. Ni's massage therapist application based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). The motion carried.

Haiyan Bernhardt, LMT – Blue Moon Asian Massage

Ms. Bernhardt appeared before the Board to answer and explain concerns regarding her establishment application. The Board reviewed the establishment applications for Haiyan Bernhardt, a licensed massage therapist, who applied for an establishment license for Blue Moon Asian Massage in Murfreesboro, TN. Ms. Bernhardt was asked to attend the meeting as her establishment application was initially denied by the Applicant Review Committee at the July 17, 2015 meeting. The Committee's decision was based on evidence that the location for which Ms. Bernhardt had applied for licensure had been open and operating without a license. The Tennessee Massage Board administrative office provided an interpreter from the Tennessee Foreign Language Institute for interview. The interpreter, Ms. Jiao Hoggard, translated the Board's questions and concerns regarding Ms. Bernhardt's massage establishment licensure application. After a brief discussion, Ms. Cross made a motion, seconded by Ms. Easterly to deny Ms. Bernhardt's massage establishment application based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). The motion carried.

Chunan Jiang, LMT & Hui Lu Pruett – Massage Therapy

Mr. Jiang and Ms. Pruett appeared before the Board with counsel, Mr. Frank Carney, to answer and explain concerns regarding their establishment application. The Board reviewed the establishment application for Mr. Jiang and Ms. Pruett, licensed massage therapists, who applied for an establishment license for Massage Therapy in Memphis, TN. Mr. Jiang & Ms. Pruett was asked to attend the meeting as their establishment application was initially denied by the Applicant Review Committee at the July 17, 2015 meeting. The Committee's decision was based on evidence that the location for which Mr. Jiang & Ms. Pruett had applied for licensure had been open and operating without a license. The Tennessee Massage Board administrative office provided an interpreter from the Tennessee Foreign Language Institute for interview. The interpreter, Ms. Jiao Hoggard, translated the Board's questions and concerns regarding Mr. Jiang & Ms. Pruett's massage establishment licensure application. After a discussion, Ms. Wray made a motion, seconded by Ms. Cross to deny Mr. Jiang and Ms. Pruett's massage establishment application based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). The motion carried with Mr. Velker opposed.

<u>Wen Tao Wang – Reborn Massage Centre</u>

Mr. Wang appeared before the Board to answer and explain concerns regarding his establishment application. The Board reviewed the establishment applications for Wen Tao Wang, a certifed reflexogist, who applied for an establishment license for Reborn Massage Centre in Seymour, TN. Mr. Wang was asked to attend the meeting as his establishment application was initially approved by the Applicant Review Committee at the July 17, 2015 meeting. Then upon additional research, the Administrative Office was able to secure evidence that Mr. Wang had current discipline in Alabama for owning and operating unlicensed massage establishment. Mr. Wang moved from Alabama to Tennessee without taking care of his obligations and fines with the Alabama Massage Board. Evidence was also presented that Mr. Wang owned and operated several unlicensed establishments in Tennessee. The Tennessee Massage Board administrative office provided an interpreter from the Tennessee Foreign Language Institute for interview. The interpreter, Ms. Jiao Hoggard, translated the Board's questions and concerns regarding Mr. Wang's massage establishment licensure application. After a brief discussion, Ms. Cross made a motion, seconded by Ms. Jaggers to deny Mr. Wang's massage establishment application based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). The motion carried.

Rainye Lynette Johnson

Ms. Rainye Lynette Johnson requested that her application be deferred to November 2, 2015. Ms. Burke made a motion, seconded by Ms. Cross, to defer her application to the November 2, 2015 Board meeting. The motion carried.

Ajalon Coleman, LMT – Second Wind Massage, LLC

The Board reviewed the establishment applications for Ajalon Coleman, a licensed massage therapist, who applied for an establishment license for Second Wind Massage in Hermitage, TN. Ms. Coleman was requested to appear before the Board to answer questions regarding her massage therapy license that was previously disciplined for working in an unlicensed establishment. After a brief discussion, Ms. Cross made a motion, seconded by Mr. Velker to approve Ms. Coleman's establishment application. The motion carried.

<u>Tina Marie Burns</u>

Ms. Burns appeared before the Board to explain her multiple criminal convictions. Ms. Burn's massage therapist application was reviewed and denied by the Board at the August 2013 meeting and the August 2014 meeting for being incomplete. Ms. Burn's submitted a new massage therapy application along with all the required court documents for her criminal convictions. Upon the Board reviewing her file, Ms. Wray made a motion, seconded by Ms. Burke, to approve Ms. Burn's massage therapist application. The motion carried.

Rodney Mitchell – Rodney Mitchell Style Bar and Spa

Mr. Mitchell appeared before the Board to answer and explain concerns regarding his establishment application. The Board reviewed the establishment application for Rodney Mitchell who applied for an establishment license for Rodney Mitchell Style Bar and Spa in Nashville, TN. Mr. Mitchell was requested to attend the Board meeting based on evidence that the location for which he had applied for licensure had been open and operating without a license. Mr. Mitchell was also requested to appear before the Board to explain why he answered "no" to his ownership or disclosure form regarding any convictions other than a minor traffic offense. Mr. Mitchell's criminal background check revealed a 2002 conviction for a DWI and a 2004 DUI. After a brief discussion, Mr. Velker made a motion to approve Mr. Mitchell's establishment application. The motion failed. Ms. Cross made a motion, seconded by Ms. Jaggers to deny Mr. Mitchell's massage establishment application based on T.C.A 63-18-108 (1)(7) and T.C.A 63-18-104 (a)(b). The motion carried with Mr. Velker and Ms. Easterly opposed.

The Board at the February 9, 2015 Meeting deferred their decision to the May 4, 2015 meeting to allow Ms. Latour an opportunity to submit additional information regarding the format and structure of her class. Ms. Latour contacted the Administrative Office and requested to be deferred to the August 10, 2015 Meeting. As of the August 10, 2015 meeting, Ms. Latour hadn't submitted any additional documentation regarding her requested continuing education course to be reviewed by the Board for approval. Ms. Wray made a motion, seconded by Ms. Cross, to proceed with a discussion and decision regarding Ms. Latour's continuing education approval request. The motion carried. After a brief discussion, Ms. Cross made a motion, seconded by Ms. Latour's continuing education course. The motion carried.

Review approval requests for Continuing Education Courses

Kathryn Ann Hansen, LMT, ANP

Ms. Hansen requested approval of twenty-one (21) continuing education hours for a course titled "Painweek" that was taken from the Global Education Group and sponsored by the American Academy of Nurse Practitioners. After a discussion, Mr. Velker made a motion, seconded by Ms. Easterly, to approve the 21 hours for the 2011/2012 cycle. The motion carried with Ms. Cross opposed.

Lori Kemper, LMT

Ms. Kemper requested approval of eighteen (18) continuing education hours for courses that were taken from the Pine Grove Behavioral Health and Addiction Services and Tristar Skyline Behavioral Health Facility. After a discussion, Ms. Cross made a motion, seconded by Mr. Velker, to approve the 3 hour course titled "Complex Treatment of Eating Disorders and Substance Use Disorder" for the 2011/2012 cycle. Ms. Cross also moved that Ms. Kemper submit her two (2) hour Tennessee Law Class to the administrative office within seven (7) days. Mr. Velker requested that and updated agreed citation be sent to Ms. Kemper reflecting thirteen (13) hours of non-compliance. The motion carried.

Board Correspondences

American Massage Therapy Association Tennessee Chapter regarding Inspections

The AMTA wrote a letter of concern to the Board for its members requesting clarification on how unannounced inspections of establishments would be carried out. In the letter, AMTA addressed concerns regarding the "secret" shopper suggestion. Some members felt that it was unfair due to loss of income, while others expressed concerns that non-compliance would result in failing the inspection. The letter addressed that therapist have sporadic hours and, therefore, many therapist

will not be able to provide consistent work schedules to be present for an unannounced inspection. No action was taken by the Board since the task force is still working to gather information regarding re-instating inspections.

Shannon Moorleghen Webb – Continuing Education

Ms. Webb wrote a letter to the Board requesting that the Board waive her twenty-one (21) continuing education hours for the 2011/2012 continuing education cycle due to medical reasons. Ms. Webb submitted her \$675.00 penalty fees for non-compliance, but didn't submit her signed agreed citation. The Board requested that a letter be sent to Ms. Webb from the Office of General Counsel.

<u>Ginger Janet Osborne-Wells – Felony Conviction</u>

The Tennessee Higher Education Commission originally received a letter from Ms. Osborne-Wells. Upon reviewing the letter, THEC forwarded the letter to the Tennessee Massage Board for it to be reviewed at the Board's next regularly scheduled meeting. In her letter, Ms. Osborne-Wells is appealing to the Board to allow individuals to apply for licensure despite having a felony on his/her record. Since Ms. Osborne-Wells hadn't contacted the Board Administrative Office at the time of the August Meeting, the Board decided to not take any action regarding her letter.

Presentation by the Tennessee Professional Assistance Program

Mr. Mike Harkreader, Executive Director of TnPAP, and Ms. Elaine Eaton, Administrative Director, was present at the meeting and provided an overview of the Tennessee Professional Assistance Program. TnPap's contract with the Tennessee Licensure Board of Massage went into effect on July 1, 2015. Currently TnPAP is monitoring one (1) massage therapist and one (1) establishment owner and there have been six (6) Board referrals. TnPAP is a professional monitoring organization, which is classified as an alternative to discipline model. TnPAP only monitors. All evaluations and treatments are performed by independent licensed practitioners that TnPAP has a working relationship with, and that has an understanding of mental health and addiction issues. Mr. Harkreader discussed the requirements and cost of an evaluation and different methods of drug testing. He explained that evaluations range in price from \$300.00 to \$1,000.00 dollars. He also discussed with the Board how TnPAP monitor's individuals. TnPAP is currently working on an educational video for the Massage Board and schools. Upon review of the two hour video, students would be required to take a short test over the information viewed in the video.

Ms. Eaton proposed to the Board to allocate \$40,000.00 in funds from the contract to be moved to the line item that is labeled "special assistance to individuals" to help offset the expenses for an evaluation and drug test for individuals that are working with TnPAP. Ms. Cross made a motion, seconded by Ms. Wray to accept a proposal to amend the contract and budget to allocate \$40,000.00 to cover expenses for evaluations and drug test for all individuals working with TnPAP up and until the \$40,000.00 is depleted. The motion carried.

<u>Discuss and review rule amendments to Chapter 0870-01 and 0870-02 General Rules</u> <u>Governing Massage Therapy and Educational Programs</u>

Mr. Velker requested that Rule 0870-02-02(3)(d) be changed in the rule making packet to reflect that that each program shall ensure that each graduating class shall have received a minimum of a two hour power point presentation with a posttest prior to graduation. The Board supported the rule change.

<u>Discuss and consider changes regarding Massage Establishment and Massage Therapist</u> <u>Applications</u>

Ms. Easterly made a motion, seconded by Cross, to delete the words "It is recommended that you" on page 3 sentence 6 of the instructions on the massage therapist licensure application. The sentence should be changed to read "Do not make arrangements to accept employment as a massage therapist or open a massage establishment in Tennessee until you are granted a license or authorization from the Board". The motion carried.

Discuss Inspection of Massage Establishments

Ms. Cross and Ms. Hodge reported that the Inspection Task force had discussed and recommended that when the Request for Grant Proposal is written, it require that inspectors have previous background in investigations or law enforcement. Ms. Hodge contacted the Alabama, Florida, Massachusetts, Louisiana, Missouri, and Texas Board of Massage, and verified that their inspectors either were investigators or had law enforcement background. The task force felt that this would help prevent the appearance of any bias from the massage inspector. Dr. Persinger, Executive Director of the Federation of State Massage Boards, informed the Board that the FAIR Task Force will be working to gather information on best practice for massage inspections. She also offered assistance in researching additional states requirements for inspectors. After a brief discussion, Ms. Cross made a motion, seconded by Mr. Velker to require previous law enforcement or investigation experience as one of the qualifications in the RFGP for the investigators. The motion carried.

Discuss and consider English Language Proficiency Test for licensure and potential rule change

Dr. Persinger informed the Board that the Federation Examination Task Force is currently brainstorming adding an English language screening component at the beginning of the MBLEx exam. The Board discussed applicants whose first language is not English, being required to take and pass the TOEFL before submitting a licensure application to the Tennessee Board. Ms. Cross made a motion requiring the TOEFL exam for Non-English applicants. The motion carried. Ms. Baca-Chavez informed the Board that she would be researching the Board's request and contacting the Title VI coordinator for guidance.

Discuss and consider Massage Therapy Core Curriculum being offered online

Dr. Bolden requested that the Board discuss Core Curriculum being offered online. Dr. Bolden felt that the Board would begin to see an increase in the near future of transcripts from other states that reflect science and ethic classes being taught online. Currently the Tennessee Massage Board doesn't accept online education to meet the requirements for licensure as a massage therapist. Dr. Bolden emphasized that the Board would have to be very specific in detailing classes that would be required to be hands on in a class room. After a discussion, Dr. Bolden

recommended that a survey be created and sent to all approved Tennessee schools requesting the schools opinion on offering online core curriculum courses, and providing feedback on the specific courses that should be allowed to be offered online. Ms. Cross made a motion, seconded by Mr. Wray to create and send a survey regarding online core curriculum to all approved Tennessee Massage Schools. The motion carried.

Discuss and approve Resolution on Trafficking in Human Beings to be presented at the Annual FSMTB Meeting.

Ms. Cross made a motion, seconded by Ms. Burke to approve the Resolution on Trafficking in Human Beings to be presented at the Annual FSMTB Meeting. The motion carried.

Discuss and approve the updated Lapsed License Policy

Ms. Francine Bach-Chavez presented two (2) lapsed license policies for the Board to review that reflected different civil penalties for working on a lapsed license. Upon review and discussion, Ms. Wray made a motion, seconded by Ms. Burke to accept the second updated lapsed license policy. The motion carried.

Discuss changes for attendance to the 2015 FSMTB Conference

Dr. Bolden informed the Board that he wouldn't be able to be the delegate for the Tennessee Board at the Annual FSMTB meeting since he has been elected to sit as a Board Member on the FSMTB Board of Directors. After a brief discussion, Mr. Velker made a motion, seconded by Ms. Cross to approve Ms. Burke as the voting delegate for the Tennessee Board and to approve Ms. Jaggers and Ms. Easterly to attend the annual meeting. The motion carried.

Discuss and take action if needed regarding rulemaking hearing, rule amendments, and policies

Ms. Cross made a motion, seconded by Mr. Velker to move into the rulemaking hearing at the November 2, 2015 meeting. The motion carried.

Discuss and clarify when/if an Establishment License is required

The Administrative Office requested that the Board provide guidance on when an establishment licensed is required. Ms. Hodge and Ms. Baca-Chavez presented different scenarios and examples to the Board that have been questioned in the Administrative Office over the past few months. The Board requested to defer the conversation to the February 2016 Meeting so that they could have time to define an out call, and what a fixed location and open to the general public means.

The Board made a motion to adjourn. The motion carried.

Upon renewing her license in October 2013, Ms. Brockman falsely indicated that she had completed all required continuing education. Upon discussion and review, the Board found that Ms. Brockman had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. Brockman's conduct constitutes grounds for discipline. A motion was made by Ms. Cross, seconded by Ms. Burke, to approve the consent order as written. The motion carried.

Ms. Brockman's license was placed on probation, and she was required to pay all actual and reasonable costs of prosecuting the case not to exceed above One Thousand Dollars \$1,000.00, and make up all continuing education hours and penalty hours for the 2011-2012 continuing education cycle.

She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above One Thousand Dollars \$1,000.00, and make up all continuing education hours and penalty hours for the 2011-2012 continuing education cycle.

<u>Tia Patrice Williams, L.M.T. – 5696</u>

She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above Three Thousand Dollars \$3,000.00.

Agreed Orders

Fenglan Dong, L.M.T - 10414

Francine Baca-Chavez, Deputy General Counsel, presented and discussed the agreed order for Fenglan Dong. Ms. Dong took and initially received a passing score on the Massage and Bodywork Licensure Exam (MBLEx). By a letter dated October 24, 2014, the Board was notified that Mr. Dong's MBLEx scores had been invalidated and that she would have to wait a period of twelve (12) months from the date of the invalidation before reapplying to take the exam. Based on the invalidation of Ms. Dong's scores, she has not met the requirements of Tenn. Code Ann. 63-18-105(b) (3). Therefore, Ms. Dong has not met the statutory requirements to hold a massage therapy license in Tennessee, which constitutes a violation of Tenn. Code Ann. 63-18-108 and Rules & Regs 0870-01-.04(1)(f).

After a discussion and review, the Board found that Ms. Dong had violated the Tennessee Massage Licensure Board statutes and regulations by not meeting the requirements to hold a massage therapy in Tennessee. Ms. Dong's conduct constitutes grounds for discipline. Ms. Easterly made a motion, seconded by Ms. Cross, to accept the agreed order as written. The motion carried. Ms. Dong's license is revoked, and she is required to pay all civil penalties and costs in full within 12 months from the issuance of the Assessment of Costs.

Xiuwei Wang, L.M.T - 10586

Francine Baca-Chavez, Deputy General Counsel, presented and discussed the agreed order for Xiuwei Wang. Ms. Wang took and initially received a passing score on the Massage and Bodywork Licensure Exam (MBLEx). By a letter dated November 21, 2014, the Board was notified that Mr. Wang's MBLEx scores had been invalidated and that she would have to wait a period of twelve (12) months from the date of the invalidation before reapplying to take the exam. Based on the invalidation of Ms. Wang's scores, she has not met the requirements of Tenn. Code Ann. 63-18-105(b) (3). Therefore, Ms. Wang has not met the statutory requirements to hold a massage therapy license in Tennessee, which constitutes a violation of Tenn. Code Ann. 63-18-108 and Rules & Regs 0870-01-.04(1)(f).

After a discussion and review, the Board found that Ms. Wang had violated the Tennessee Massage Licensure Board statutes and regulations by not meeting the requirements to hold a massage therapy in Tennessee. Ms. Wang's conduct constitutes grounds for discipline. Ms. Cross made a motion, seconded by Ms. Easterly, to accept the agreed order as written. The motion carried. Ms. Wang's license is revoked, and she is required to pay all civil penalties and costs in full within 12 months from the issuance of the Assessment of Costs.

<u> Ki Ran Han, LMT – 1279 - Asian Therapeutic Center - 711</u>

Francine Baca-Chavez, Deputy General Counsel, presented and discussed the agreed order for Ki Ran Han, owner and operator of Asian Therapeutic Center. In late 2012, undercover officers with the Knox County Sheriff's Office received a massage from an unlicensed individual in return for money. During the massage, the unlicensed individual offered to perform sex acts on the undercover agent in return for money. As a result, the two unlicensed individuals and Ms. Han were arrested, and Ms. Han was found guilty on January 28, 2013 of engaging in prostitution, a violation of TCA 63-13-513. Additionally, Ms. Han was found guilty on August 21, 2014 of attempted solicitation of money laundering, a violation of TCA 39-14-903 and an E felony.

After a discussion and review, the Board found that Ms. Han had violated the Tennessee Massage Licensure Board statutes and regulations. Ms. Han's conduct constitutes grounds for discipline. Ms. Cross made a motion, seconded by Ms. Burke, to accept the agreed order as written. The motion carried. Ms. Han's license is revoked, and Ms. Han's massage establishment license is revoked. She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above Five Thousand Dollars \$5,000.00.

<u>Alycia Marie LeClaire, L.M.T. – 7008</u>

Devin Wells, Deputy General Counsel, presented and discussed the consent order for Alycia Marie LeClaire. Ms. LeClaire failed to obtain twenty-five (25) approved hours of continuing education in the 2011-2012 continuing education cycle. Upon discussion and review, the Board found that Ms. LeClaire had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. LeClaire's conduct constitutes grounds for discipline. A motion was made by Ms. Easterly, seconded by Ms. Cross, to approve the agreed order as written. The motion carried.

Ms. LeClaire's license was placed on probation, and she was assessed twenty-five (25) Type C Civil Penalties for in the amount of fifty dollars (\$50.00) for each continuing education hour violation for a total assessment of Six Hundred Twenty Dollars (\$625.00). She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above One Thousand Dollars \$1,000.00, and make up all continuing education hours and penalty hours for the 2011-2012 continuing education cycle.

<u>Kelda J. Olson, L.M.T. – 4292</u>

Devin Wells, Deputy General Counsel, presented and discussed the agreed order for Kelda J. Olson. Ms. Olson failed to obtain twenty-five (25) approved hours of continuing education in the 2011-2012 continuing education cycle. Upon renewing her license in April 2014, Ms. Olson falsely indicated that she had completed all required continuing education. Upon discussion and review, the Board found that Ms. Olson had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. Olson's conduct constitutes grounds for discipline. A motion was made by Ms. Wray, seconded by Ms. Jaggers, to approve the agreed order as written. The motion carried.

Ms. Olson's license was placed on probation, and she was assessed one (1) Type B Civil Penalty in the amount of One Hundred Fifty dollars (\$150.00).

Vanity Wynette Wherry, L.M.T. – 7877

Devin Wells, Deputy General Counsel, presented and discussed the consent order for Vanity Wynette Wherry. Ms. Wherry failed to obtain nineteen (19) approved hours of continuing education in the 2011-2012 continuing education cycle. Upon renewing her license in May 2014, Ms. Wherry falsely indicated that she had completed all required continuing education. Upon discussion and review, the Board found that Ms. Wherry had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. Wherry's conduct constitutes grounds for discipline. A motion was made by Ms. Cross, seconded by Ms. Wray, to approve the agreed order as written. The motion carried.

Ms. Wherry's license was placed on probation, and she was assessed one (1) Type B Civil Penalty in the amount of One Hundred Fifty dollars (\$150.00) and nineteen (19) Type C Civil Penalties for in the amount of fifty dollars (\$50.00) for each continuing education hour violation for a total assessment of Six Hundred Twenty-Five Dollars (\$625.00). She was required to pay all actual and reasonable costs of prosecuting the case. not to exceed above One Thousand Dollar \$1,000.00 and make up all continuing education hours and penalty hours for the 2011-2012 continuing.

<u>Heather Marie Wilbrett, L.M.T. – 7780</u>

Devin Wells, Deputy General Counsel, presented and discussed the consent order for Heather Marie Wilbrett. Ms. Wilbrett failed to obtain twenty-five (25) approved hours of continuing education in the 2011-2012 continuing education cycle. Upon renewing her license in April 2014, Ms. Wilbrett falsely indicated that she had completed all required continuing education. Upon discussion and review, the Board found that Ms. Wilbrett had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. Wilbrett's conduct constitutes grounds for discipline. A motion was made by Ms. Cross, seconded by Ms. Burke, to approve the agreed order as written. The motion carried.

Ms. Wilbrett's license was placed on probation, and she was assessed one (1) Type B Civil Penalty in the amount of One Hundred Fifty dollars (\$150.00) and twenty-five (25) Type C Civil Penalties for in the amount of fifty dollars (\$50.00) for each continuing education hour violation for a total assessment of Seven Hundred Seventy-Five Dollars (\$775.00). She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above One Thousand Dollars \$1,000.00, and make up all continuing education hours and penalty hours for the 2011-2012 continuing.

Carla Susanne Pierce, L.M.T. – 3827

Devin Wells, Deputy General Counsel, presented and discussed the consent order for Carla Susanne Pierce. Ms. Pierce failed to obtain twenty-five (25) approved hours of continuing education in the 2011-2012 continuing education cycle. Upon renewing her license in April 2014, Ms. Pierce falsely indicated that she had completed all required continuing education. Upon discussion and review, the Board found that Ms. Pierce had violated the Tennessee Massage Licensure Board statutes and regulations by not maintaining her required continuing education hours. Ms. Pierce's conduct constitutes grounds for discipline. A motion was made by Ms. Easterly, seconded by Ms. Jaggers, to approve the agreed order as written. The motion carried.

Ms. Pierce's license was placed on probation, and she was assessed one (1) Type B Civil Penalty in the amount of One Hundred Fifty dollars (\$150.00) and twenty-five (25) Type C Civil Penalties for in the amount of fifty dollars (\$50.00) for each continuing education hour violation for a total assessment of Seven Hundred Seventy-Five Dollars (\$775.00). She was required to pay all actual and reasonable costs of prosecuting the case not to exceed above One Thousand Dollars \$1,000.00, and make up all continuing education hours and penalty hours for the 2011-2012 continuing.

Ms. Burke made a motion, seconded by Ms. Cross to adjourn the meeting at 9:55 am. The motion carried.
