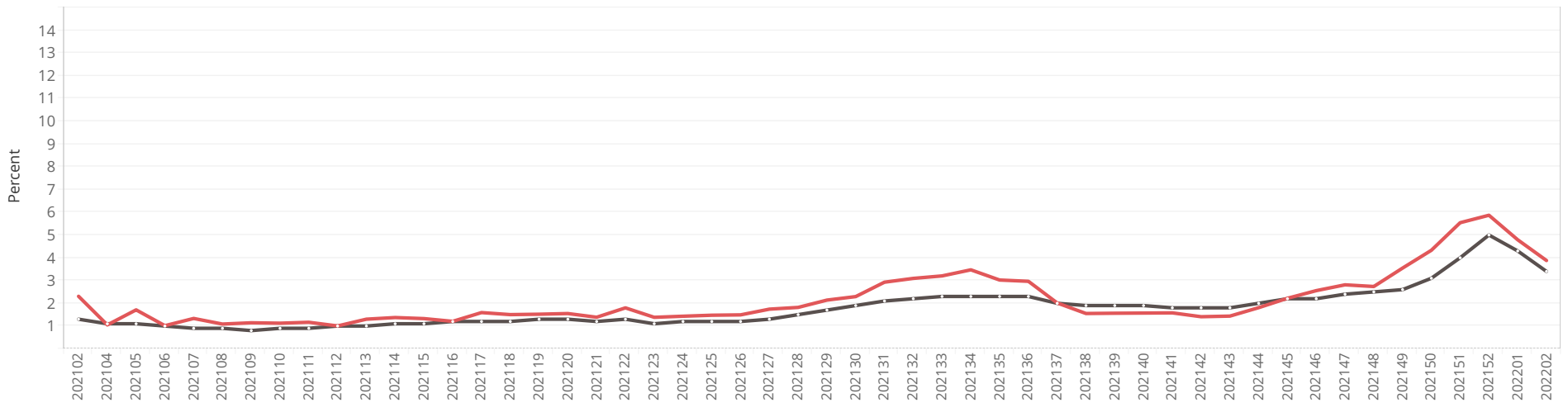
What is the Influenza-Like Illness Activity in Tennessee?

Influenza-Like Illness Activity Fast Facts:

- The percentage of outpatients with ILI visiting the state's sentinel clinic sites was **3.9%**. The CDC baseline is 3.1%.
- There have been **0** pediatric influenza-related deaths this season.
- **0** pregnant women have died from influenza-related illness this season.

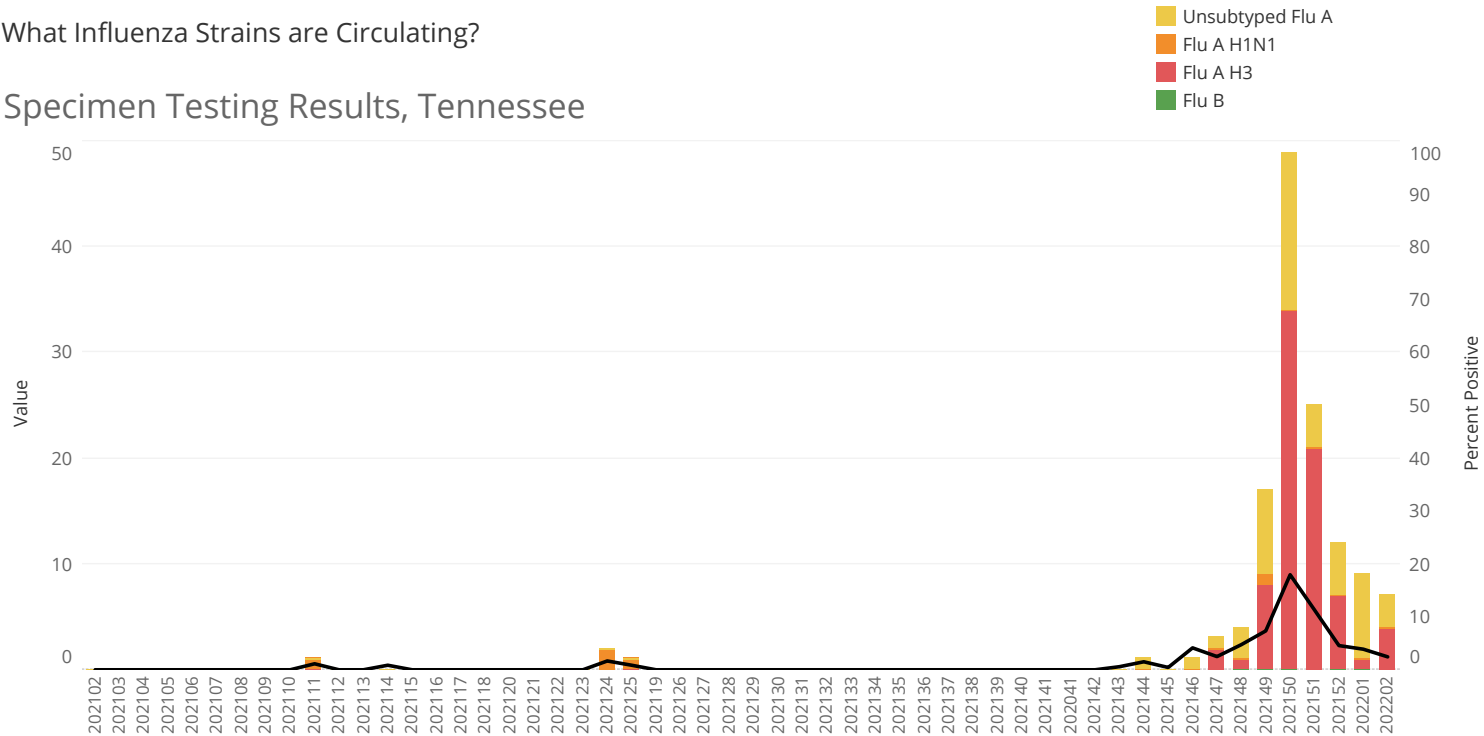
Percentage of Outpatient Visits Reported as Influenza-Like Illness by the **U.S.** and **Tennessee** ILINet, 2021 to 2022

Specimen Testing Results, Tennessee



Influenza Circulation in Tennessee Fast Facts:

- To date, **286** specimens from **Week 02** have been tested by TDH Laboratory Services and two commercial laboratories that serve clinics across the state.
- 7** were positive for influenza virus.
- The most common strain of specimens tested was **A**.
- 33** of Tennessee's 95 counties have had one or more influenza-positive result in the past 6 weeks.

Reference Information for Sentinel Provider Network

1. Influenza-like illness (ILI) is defined as fever > 100° F (37.8° C) plus cough and/or sore throat. Classification of ILI is based upon symptoms only and does not require testing. As of 10/3/2021, CDC removed "in the absence of a known cause (other than influenza)" from the case definition.

Important Information for Sentinel Providers

Sentinel Providers report ILI by the end of Tuesday following the end of the reporting week (<https://wwwn.cdc.gov/ilinet/>) and collect and ship specimens from ILI cases Monday through Thursday (maximum 10/week per provider). All Sentinel Provider specimens MUST be accompanied by the Order Manifest or Influenza and Respiratory Viral Panel Submission form or testing will not be done. The Respiratory Viral Panel is only validated for nasopharyngeal (NP) specimens. Specimens collected from other sites cannot be tested. Additional laboratory supplies may be obtained by completing the lab order supply form. To ensure the order is filled, please include the CDC Provider ID Code.
