The Tennessee Department of Health (TDH) is providing this update regarding the COVID-19 outbreak. Visit our <u>webpage</u> for the most up to date information on case counts, information, and resources.

Reporting COVID-19 cases and deaths:

The Tennessee Department of Health (TDH) urges hospitals, clinical laboratories, and health care professionals across Tennessee to ensure timely reporting of all COVID-19 cases to TDH. TDH requires reporting of designated conditions, including COVID-19, to the state health department. Reporting all cases of COVID-19 in a timely manner to public health drives actions to curb disease spread and informs critical policy decisions. Recently, point of care testing has increased with new testing platforms coming into the marketplace. As a reminder, all COVID-19 testing (positive and negative results) is required to be reported by providers immediately (within 24 hours).

In addition to reporting, it is critical to provide complete and timely patient demographic information when reporting cases of COVID-19 to TDH and when ordering COVID-19 testing from laboratories. Commercial/private laboratories also have reporting obligations to the state health department which includes the reporting of complete patient demographic information. To ensure timely public health action, patient demographic information (i.e., phone number, address, race/ethnicity, sex) at the time of test order must be complete.

Cases: Healthcare providers have 3 options for reporting laboratory confirmed cases:

- Fax the <u>PUI Form</u> and a copy of the positive laboratory report to 615-741-3857
- Call the TDH COVID-19 call center between 8am-4:30pm, 615-741-7247
- Submit an electronic Morbidity Report*

*If you already report diseases or conditions to TDH via Morbidity Reports, you can continue to do this for COVID-19 positive labs. These are electronically submitted to NBS through https://hssi.tn.gov/auth/login.

Deaths: There are 2 options for reporting suspected or confirmed COVID-19 associated deaths:

- Call your county medical examiner
- Fax the PUI Form and a copy of the positive laboratory report to 615-741-3857. Be sure to mark the field indicating death
- An updated form can be submitted indicating death if you have previously reported the individual as a case

Testing your patients:

- <u>COVID-19 Assessment and Specimen Collection Sites</u> are available across the state. Public healthsupported sites provide testing free of charge to all comers. Call ahead before arriving to confirm hours and availability at all locations.
- Additionally, sampling events are being planning in communities across Tennessee in the upcoming weeks.
