Rhonda Phillippi, Executive Director of TN EMSC	Review of rule making process	<p>Rhonda reviewed rule making process and <u>emphasized that currently CoPEC has not made any recommendations on revision of rules and regulations.</u> They are still in subcommittee and have the following process to follow:</p> <ol style="list-style-type: none"> 1. Standardization committee of CoPEC creates a draft of pediatric facility rules and regulations 2. Draft presented to CoPEC



3. CoPEC approves or amends
4. Board for Licensing Health Care Facilities votes whether to send to rulemaking hearing on first reading
5. Office of General Counsel begins internal review
6. Legislative affairs reviews
7. Commission of Health reviews and sends to Governor for review
8. If Governor approves then sent to Secretary of State to file for rule making hearing
9. Proposed rule must be published in the TN Administrative Register at least 90 days prior to rulemaking hearing
10. The rules are also sent to any parties that may be interest in the proposed changes (profess organizations representing the affected licensees)
11. Public comments may be submitted during the 50 day waiting period
12. At the next Board for Licensing Health Care Facilities meeting after the 50 day waiting period, there is a public hearing of the proposed rules
13. After hearing all of the comments, the Board then votes to approve the rule changes or amend
14. Rules are then sent to the TN Attorney General’s Office, which reviews the rule changes for legality.
15. Once approved by the Attorney General’s Office, the rules are filed with the Secretary of State’s Office, posted 90 days before becoming effective.
16. During that 90 day period, the rules are reviewed by the Legislature’ Government Operations Committee
17. If the Legislative committee approves the rule, the rule will become effective after the 90 day period
18. Rule changes are communicated through the Department of Health and members of CoPEC and TN EMSC.
