  - The hearing docket and process of hearing were explained. Attorneys for the department and the respondents were introduced.
  - Jason Tunstall stated that he believed he would need to recuse himself due to Affiliation with the Memphis Fire Department.
  - Mr. Tim Peters provided opening statements for the State. The attorney for the respondents, Mr. Kevin Snider provided an opening statement as well.
  - A series of body cam videos were played for the members.
  - A brief recess was taken.
  - Ms. Katrina Stewart was sworn in before the Board via Webex as a witness. Both Mr. Tim Peters and Mr. Kevin Snider asked questions of Ms. Stewart.
  - Judge Summers swore in all 3 respondents prior to them providing testimony. Mr. Harper took the stand first. He answered questions of the State and Mr. Snider. The Board members then asked questions. Mr. Harper was then excused.
  - Mr. Johnathan Porchia was then called to the stand. He answered questions of the State and Mr. Snider. The Board members then asked questions. Mr. Porchia was then excused.

### EMS RULES DISCUSSION

- Ms. Rhonda Webb-Stewart spoke to the members concerning rule changes and presents proposed language for review.
- Emergency rules for training supplement have been submitted to Attorney General's office. Air Ambulance rules are complete, working on adding permanent pay supplement rules.
- Ms. Webb Stewart asked the members to consider requiring CE Broker usage. Director Ward stated there are potentially up to 17,200 licensed personnel that could qualify for the stiped program. The State office has one employee dedicated to this program. This would be an easier and more organized fashion in which to review training that has been submitted. Stacy Prater mentioned a way for the submitting services to review what was entered.
- Discussions about services that wished to opt out of the supplement program and potential conflicts with legislation. Ms. Webb-Stewart will add a statutory citation within the rule.
- *A motion was duly made by Greg Miller and properly seconded by Jeffrey Bagwell to add language in section A pursuant to state law. The motion passed unanimously.*
- *A motion was duly made by Jason Tunstall and properly seconded by Stacy Prater to remove the words "CE Broker" add language regarding "a Board Approved Continuing Education Tracking System". The motion passed unanimously.*
- *Discussion regarding unclaimed supplement funding. A motion was duly made by Drew Hooker and properly seconded by David Blevins to approve recommended steps for unclaimed property. The motion passed unanimously.*
- *Discussion regarding occurrences prior to distribution of supplement. A motion was duly made by Drew Hooker and properly seconded by Jeffrey Bagwell to approve as suggested. The motion passed unanimously with a voice vote.*

- *A motion was duly made by Greg Miller and properly seconded by Dr. Jared McKinney to amend “the balance of the training pay supplement after appropriate deductions removed as referenced in J, shall be distributed to recipient within 30 days. The motion passed unanimously.*

### TRAINING/OTHER BUSINESS

- Ms. Webb-Stewart requests a motion if funds are available, to send an attorney or member to represent the EMS Board at a continuing education opportunity. *A motion was duly made by Joyce Noles and properly seconded by Shannon Morphis supporting such. The motion passed.*
- Director Ward reminded the Board members to complete mandatory Edison trainings.
- Drew Hooker asked to request EMR to EMT bridge course study be sent to the education committee for study and gap analysis. *A motion was duly made by Shannon Morphis and properly seconded by Jeffrey Bagwell regarding such. After discussion about potential pitfalls and the need to likely involve the TBR, the motion passed by a unanimous voice vote.*
- *A motion was duly made by Drew Hooker and properly seconded by Chris Wheat to send information on the Drug Reboot and Recovery mental health program to the leadership and advancement committee. After discussion, the motion passed by a unanimous voice vote.*
- *A motion was duly made by Drew Hooker and properly seconded by Jason Tunstall to send to Clinical Issues review and discuss field determination of death protocol/guideline and changes that may be necessary around the state. The motion passed unanimously on a voice vote.*
- Question by Mr. Hooker regarding an individual licensee on a non-transport unit, who is responsible for the patient ultimately. Director Ward opines that the 911 transport service has the ultimate authority. If the first arriving units cancel the other responding units, they have resumed responsibility for the patient at that point.
- It was mentioned that the Board requests home addresses/contact information be removed from the website.
- Stacy Prater mentioned Clinical Issues Committee was intended to be cancelled at the upcoming meeting because of the absence of a chair. *A motion was then duly made by Mr. Prater and a proper second was provided by David Blevins to require the election of a vice chair at their March meeting to prevent the cancellation of meetings. As amended, Mr. Prater added that the Clinical Issues meeting in March would be reinstated and the Co-Chair shall be a physician. The motion passed unanimously.*

The meeting was adjourned at 1525 hours.
