8	Is eligibility contingent on any specific documentation (e.g., CDC recognition status at time of award vs. application, proof of affiliation between CMN and CVG, or licensure/credentialing evidence)? If awarded, it is required that DPPs must apply for CDC recognition or have CDC recognition currently, and DSMESs must apply for ADA recognition or ADCES accreditation; funds can be used for applying for DSMES recognition/accreditation. There is no charge for DPP recognition.
9	We have plans to do diabetes education at our clinic once a month with the assistance of volunteer physicians and pharmacists.
