

**FREQUENTLY ASKED QUESTIONS**  
**CONTINUING MEDICAL EDUCATION REQUIREMENTS FOR OSTEOPATHIC PHYSICIANS**

1. **QUESTION:** How many total hours of continuing medical education am I required to complete each year?

**ANSWER:** All osteopathic physicians must complete forty (40) hours in the two calendar years preceding the year of license renewal. Unless exempted by statute, if you are a prescriber with a DEA registration, at least two (2) of the forty (40) required hours must relate to controlled substance prescribing, which must include instruction in the Department's treatment guidelines on opioids, benzodiazepines, barbiturates and carisoprodol and may include instruction on topics such as medicine addiction, risk management tools and other topics approved by the Board. If you do not have a DEA registration and do not prescribe, at least two (2) of the forty required hours shall be in a course or courses designated specifically to address prescribing practices. To simplify:

If your medical license is renewed in October of 2016, forty hours of CME must be completed between January 1, 2014 and December 31, 2015. It doesn't matter how many hours are completed in a single year as long as forty total hours are completed within the appropriate two year timeframe.

2. **QUESTION:** Who is statutorily exempted from the two (2) hour controlled substance prescribing CME?

**ANSWER:** Providers practicing at a registered pain management clinic and medical doctors or osteopathic physicians who are board certified by the American Board of Medical Specialties (ABMS), American Osteopathic Association (AOA) or the American Board of Physician Specialties in one (1) or more of the following specialties or subspecialties do not have to complete the two (2) hour controlled substance prescribing course(s):

- i. Pain management;
- ii. Anesthesiology;
- iii. Physical medicine and rehabilitation;
- iv. Neurology; or
- v. Rheumatology.

3. **QUESTION:** What if I fail to complete all forty (40) required CME hours in the two calendar years preceding my license renewal?

**ANSWER:** The Board of Osteopathic Examination has adopted a policy to address a licensee's failure to obtain the requisite number of CME hours. That policy (available here: [http://www.tn.gov/assets/entities/health/attachments/Osteo\\_Cont\\_Ed\\_03-05.pdf](http://www.tn.gov/assets/entities/health/attachments/Osteo_Cont_Ed_03-05.pdf)) imposes the following penalties on the provider:

- i. The physician must pay a civil penalty in the amount of forty dollars (\$40.00) for each hour of Category I-A and II-A CME that he or she is deficient;
- ii. The physician must make up the amount of CME hours that he or she is deficient, in addition to completing the hours required for the current year; and

- iii. The physician must complete ten penalty hours which must be completed in addition to making up the physician's deficient hours as well as any hours due during the current renewal timeframe.

These penalties will be imposed through an Agreed Citation, which will be posted to the Board's monthly disciplinary action report and linked to the physician's verification page. A physician's failure to comply with the policy may result in formal disciplinary action.

4. **QUESTION:** How do I know whether my controlled substance prescribing CME will be accepted by the Board?

**ANSWER:** Because the Board does not endorse any particular CME course and thus does not publish available courses to the Board website, Board staff is unable to "approve" CME in advance of a provider's completion. However, as long as the CME course or courses total two (2) hours and include instruction in controlled substance prescribing, or where applicable, the Department's treatment guidelines on opioids, benzodiazepines, barbiturates and carisoprodol, the course will be accepted.

5. **QUESTION:** I serve as a preceptor; will these hours count towards my continuing education requirement?

**ANSWER:** Yes, osteopathic physicians serving as preceptors in any AOA approved osteopathic medical education program may be granted one (1) Category I-B credit for each hour of preceptor work actually performed, up to a maximum of fifty percent (50%) of the total biennially required continuing medical education.

6. **QUESTION:** How do I know whether a particular course is acceptable to the Board?

**ANSWER:** The course must be approved in content, structure and/or format by the AOA, or by the Accrediting Council for Continuing Medical Education (ACCME) or by a state medical association recognized by the ACCME as an intrastate accreditor of sponsors of continuing medical education, or the course must be designated by the AAFP as meeting the criteria of the AAFP's prescribed credit.

7. **QUESTION:** How long must I retain proof of completion of my CME?

**ANSWER:** All licensees must retain independent documentation of completion of all CME hours for a period of four (4) years from the end of the calendar year in which the CME was completed.

Proper documentation may consist of any one of the following:

- i. Original certificates or photocopies of original certificates from course providers verifying the licensee's attendance and/or completion of hours;
- ii. Original letters or photocopies of original letters from course providers verifying the licensee's attendance and/or completion of hours;
- iii. Documentation from the American Academy of Family Physicians (AAFP) indicating acquired CME hours.
- iv. Official transcript verifying credit hours earned. One (1) semester academic credit hour is equivalent to fifteen (15) clock hours for the purpose of licensure renewal. Credit for auditing will be for the actual clock hours in attendance, not to exceed the academic credit.

8. **QUESTION:** I would like to request a waiver of my CME hours. What criteria must I meet in order for a waiver to be considered?

**ANSWER:** The Board may waive a physician's CME requirements for a two year renewal timeframe in cases where illness, disability or other undue hardship beyond the control of the licensee prevents a licensee from complying. **Requests for waivers must be sent to the Board prior to the expiration of the calendar year in which the CME is due.**

9. **QUESTION:** My license is retired. Do I have to complete CME?

**ANSWER:** No, you do not have to complete CME if your license is retired; however, should you later choose to reinstate your license and reenter clinical practice, the Board may consider whether you have completed CME as part of its deliberations concerning your readiness to reenter practice.

10. **QUESTION:** My license is inactive. Do I have to complete CME?

**ANSWER:** No, you do not have to complete CME if your license is inactive; however, should you later choose to reinstate your license and reenter clinical practice, the Board may consider whether you have completed CME as part of its deliberations concerning your readiness to reenter practice.
