Office of Investigations

Mr. Roger Knowlton presented the 2022 year end complaint numbers and the complaints received so far in 2023. There have been twenty-two (22) complaints opened in 2023. One (1) opened complaint was for being outside of the investigative scope. For the year 2022, there were ten (10) complaints opened. Two (2) were closed with insufficient evidence, two (2) closed by being sent to another office

for review, and one (1) closed with a letter of warning. Of the complaints opened, one (1) was for false billing, one (1) was for substance abuse, one (1) was for unlicensed practice, six (6) was for unprofessional conduct, one (1) was for outside of investigative scope.

The total number of Applied Behavior Analysts being monitoring is two (2). The total number reprimanded is one (1) with terms. The total number revoked is one (1) with terms.
