# Litigation:

The Office of General Counsel currently has approximately 45 open cases to the Massage Licensure Board.

Today, there are 3 consent orders for entry and 3 contested final hearing.

## Rulemaking:

The reciprocity licensure rule revisions are in the legislative review stage.

#### Legislation:

Nothing to report.

# **Applicant Interviews:**

- A. Travis Bray Mr. Bray was present for the meeting. The Board administrators received an reinstatement application for Mr. Bray. He had a conditional license that expired on August 31,2022. Mr. Bray was ordered to give quarterly reports to OGC. Mr. Bray began work at a new establishment and OGC did not receive reports as required. MS. Burke recused herself. After review and discussion from the Board, a motion was made by Ms. Yarbrough and seconded by Ms. Vickers to approve reinstatement, the motion carried.
- B. Tina's Therapeutic Touch Tina Burns Ms. Burns was present for the meeting. Ms. Burns applied for a massage establishment license for "Tina's Therapeutic Touch", located at 1310 Jefferson St, Suite 207 Nashville, TN 37208. The administrative office found advertisements on bodywork2.setmore.com. The administrator was able to book an appointment. After review and discussion from the board it was determined that Ms. Burns had advertised for a February 18, 2023 opening and was not accepting appointments at this time. A motion was made by Mr. Velker and seconded by Ms. Burke to approve Ms. Burns for an establishment license, the motion carried.
- C. I Knead That Massage Cassandra Orso -Ms. Orso was not present. She requested a phone audience and was available by phone. Ms. Orso applied for a massage establishment license for "I Knead That Massage, LLC" The administrative office found advertisements on Facebook, massagebook.com, and MS. Orso'd website. The administrators were able to book an appointment. After review and discussion by the Board it was their finding to approve Ms. Orso without citation. Mr. Velker made a motion, seconded by Ms. Vickers, motion carried.

#### D. Hand and Stone

#### 1. Murfreesboro

At its February 2023 meeting, the Massage Licensure Board considered the massage establishment application for Hand and Stone Murfreesboro location and interviewed their representatives from the establishment. In reviewing the application, the Board considered the following facts in deciding whether to issue an establishment license:

Hand and Stone Murfreesboro operated an establishment on a lapsed license for a period of five (5) months. Said establishment had a total of seven (7) massage tables.

These facts constitute grounds to deny or condition this application pursuant to T.C.A. 63-18-108, which authorizes the Board to deny or condition a license, among other reasons, if the applicant:

- (7) Has violated this chapter or any substantive rule promulgated under the authority of this chapter.
- (12) Is guilty of unethical or unprofessional conduct.

These facts constitute grounds to deny or condition the application pursuant to T.C.A. 63-18-104: License Required.

- (a) Persons or massage establishments engaged in massage for compensation shall be licensed by the massage licensure board.
- (b) Any person or establishment who advertises or engages in massage for compensation without a current valid license from the massage licensure board commits a Class B misdemeanor. It is unlawful to use the word "massage" or any other term that implies massage technique or method when advertising a service by a person who is not licensed under this chapter or another chapter of state law.

Based on the evidence before the Board, the Board found that the applicant had violated the rules regarding licensure requirements for massage establishments.

The Board voted to offer Hand and Stone a conditional license agreement. In order to obtain a conditional license reinstatement, the applicant agree to the following conditions:

- 1. A reprimand on the establishment license.
- 2. Hand and Stone was assessed Civil Penalties in the amount of three-thousand-eight hundred dollars (\$3,800.00). This civil penalty must be paid in full within thirty (30) days.
- 3. Within thirty (30) days of the entry of this conditional license, provide a memorandum to all employees which will include contact information for the new managers, responsible person, and/or ownership. This memorandum shall be provided to each employee and posted within the establishment. It shall also be provided to the disciplinary coordinator for the Department at:

4. Hand and Stone license will not be issued until they sign and return this agreement.

If Hand and Stone agrees to the conditions set forth above, they must sign and date this document in the space provided below and return it to me within thirty (30) days. Hand and Stone's massage license will not be issued, and they may not practice massage therapy until this document with their signature has been received and Hand and Stone has obtained their "go to work" letter from the Board's administrative office.

The effective date of this conditional license agreement will be the date the OGC receives the signed order back from Hand and Stone. This letter has the full force and effect as an Order issued by the Board for purposes of Tenn. Code Ann. § 63-18-108(9). Once Hand and Stone has signed and returned this

order, it will constitute a formal and public disciplinary action and will be reported to the National Practitioner Data Bank (NPDB) and/or similar agency and will be posted on the Board s "license lookup" website.

#### 2. Brentwood

At its February 2023 meeting, the Massage Licensure Board considered Hand and Stone Brentwood massage establishment location application and interviewed representatives from the establishment. In reviewing the application, the Board considered the following facts in deciding whether to issue an establishment license:

Hand and Stone Brentwood operated an establishment on a lapsed license for a period of eight (8) months. Said establishment had a total of five (5) massage tables.

These facts constitute grounds to deny or condition their application pursuant to T.C.A. 63-18-108, which authorizes the Board to deny or condition a license, among other reasons, if the applicant:

- (7) Has violated this chapter or any substantive rule promulgated under the authority of this chapter.
- (12) Is guilty of unethical or unprofessional conduct.

These facts constitute grounds to deny or condition your application pursuant to T.C.A. 63-18-104: License Required.

- (a) Persons or massage establishments engaged in massage for compensation shall be licensed by the massage licensure board.
- (b) Any person or establishment who advertises or engages in massage for compensation without a current valid license from the massage licensure board commits a Class B misdemeanor. It is unlawful to use the word "massage" or any other term that implies massage technique or method when advertising a service by a person who is not licensed under this chapter or another chapter of state law.

Based on the evidence before the Board, the Board found that Hand and Stone had violated the rules regarding licensure requirements for massage establishments.

The Board voted to offer Hand and Stone this conditional license agreement. In order to obtain a conditional license reinstatement, they must agree to the following conditions:

- 1. A reprimand on their establishment license.
- 2. Hand and Stone was assessed Civil Penalties in the amount of four-thousand three hundred dollars (\$4,300.00). This civil penalty must be paid in full within thirty (30) days.
- 3. Within thirty (30) days of the entry of this conditional license, provide a memorandum to all employees which will include contact information for the new managers, responsible person, and/or ownership. This memorandum shall be provided to each employee and posted within the establishment. It shall also be provided to the disciplinary coordinator for the Department at:

4. The license will not be issued until Hand and Stone signs and returns this agreement.

If Hand and Stone agrees to the conditions set forth above, they must sign and date this document in the space provided below and return it to me within thirty (30) days. Hand and Stone's license will not be issued, and they may not practice massage therapy until this document with their signature's have been received and they have obtained their "go to work" letter from the Board's administrative office.

The effective date of this conditional license agreement will be the date OGC receives the signed order back from Hand and Stone

This letter has the full force and effect as an Order issued by the Board for purposes of Tenn. Code Ann. § 63-18-108(9). Once Hand and Stone has signed and returned this order, it will constitute a formal and public disciplinary action and will be reported to the National Practitioner Data Bank (NPDB) and/or similar agency and will be posted on the Board's "license lookup" website.

#### 3 Franklin

At its February 2023 meeting, the Massage Licensure Board considered Hand and Stone massage establishment Franklin location application and interviewed representatives from the establishment. In reviewing the application, the Board considered the following facts in deciding whether to issue an establishment license:

Hand and Stone Franklin operated an establishment on a lapsed license for a period of eight (8) months. Said establishment had a total of six (6) massage tables.

These facts constitute grounds to deny or condition your application pursuant to T.C.A. 63-18- 108, which authorizes the Board to deny or condition a license, among other reasons, if the applicant:

- (7) Has violated this chapter or any substantive rule promulgated under the authority of this chapter.
- (12) Is guilty of unethical or unprofessional conduct.

These facts constitute grounds to deny or condition their application pursuant to T.C.A. 63-18-104: License Required.

- (a) Persons or massage establishments engaged in massage for compensation shall be licensed by the massage licensure board.
- (b) Any person or establishment who advertises or engages in massage for compensation without a current valid license from the massage licensure board commits a Class B misdemeanor. It is unlawful to use the word "massage" or any other term that implies massage technique or method when advertising a service by a person who is not licensed under this chapter or another chapter of state law.

Based on the evidence before the Board, the Board found that Hand and Stone had violated the rules regarding licensure requirements for massage establishments.

The Board voted to offer Hand and Stone this conditional license agreement. In order to obtain a conditional license reinstatement, you must agree to the following conditions:

- 1. A reprimand on their establishment license.
- 2. Hand and Stone is assessed Civil Penalties in the amount of five-thousand one hundred dollars (\$5,100.00). This civil penalty must be paid in full within thirty (30) days.
- 3. Within thirty (30) days of the entry of this conditional license, provide a memorandum to all employees which will include contact information for the new managers, responsible person, and/or ownership. This memorandum shall be provided to each employee and posted within the establishment. It shall also be provided to the disciplinary coordinator for the Department at:

4. Hand and Stone's license will not be issued until Hand and Stone signs and returns this agreement.

If Hand and Stone agrees to the conditions set forth above, they must sign and date this document in the space provided below and return it to me within thirty (30) days. Hand and Stone's license will not be issued, and they may not practice massage therapy until this document with their signature's have been received and they have obtained their "go to work" letter from the Board's administrative office.

The effective date of this conditional license agreement will be the date OGC receives the signed order back from Hand and Stone.

This letter has the full force and effect as an Order issued by the Board for purposes of Tenn. Code Ann. § 63-18-108(9). Once Hand and Stone has signed and returned this order, it will constitute a formal and public disciplinary action and will be reported to the National Practitioner Data Bank (NPDB) and/or similar agency and will be posted on the Board's "license lookup" website.

- E. Leslie Stump This is Ms. Stump's third application (1-withdrawn, 1-denied) Ms. Stump had an excessive background check; she attended TnPAP and has not met all their requirements; however, they do advocate for safety to practice at this time.
  - 1. Ms. Stump has previously been denied due to concerns regarding her criminal history and her failure to comply with TNPAP recommendations.

These facts constitute grounds to deny or condition her application pursuant to T.C.A. 63-18-108, which authorizes the Board to deny or condition a license, among other reasons, if the applicant:

- (7) Has violated this chapter or any substantive rule promulgated under the authority of this chapter.
- (12) Has violated or attempted to violate, directly or indirectly, or has assisted in or abetted the violation of, or conspired to violate, any provision of this chapter or any lawful order of the board issued pursuant to this chapter;

These facts constitute grounds to deny or condition your application pursuant to Tenn. Comp. R. & Regs., Rule 0870-01-.19(L), which states in part:

(l) Refrain from providing services when the licensee is either physically or mentally incapable of safely doing so. The term "safely" as used in this rule means safety of the massage therapists and anyone they come into contact with during the course of professional practice

Based on the evidence before the Board, the Board found that you had violated the rules regarding licensure requirements for massage therapists.

The Board voted to offer Ms. Stump this conditional license agreement. In order to obtain a conditional license, you must agree to the following conditions:

- 1. The applicant's license is suspended until TNPAP recommends and authorizes you to begin work as a massage therapist.
- 2. Upon recommendation and authorization by TNPAP, the suspension of the applicant's license shall be suspended, and her license shall be placed on probation for a period of time which shall mirror the recommendations of the monitoring agreement with TNPAP.
- 3. If at any time during this period of probation she loses TNPAP advocacy, her license shall immediately be suspended, and further disciplinary action may be taken.
- 4. During the period of probation, she must notify any establishment which employees her as a licensed massage therapist of this conditional license within one (1) week of employment and provide a copy of said notification to the disciplinary coordinator.
- 5. During the period of probation, she may not practice massage therapy outside of a massage establishment. Furthermore, she shall not be the responsible person of said establishment
- 6. During the period of probation, either she or TNPAP must provide quarterly employment reports to the disciplinary coordinator.
- 7. During the period of probation, she shall refrain from using alcohol and illegal substances and follow all laws of the state of Tennessee.
- 8. Upon recommendation and successful completion of her TNPAP monitoring agreement and upon appropriate documentation of such being provided to the disciplinary coordinator, your probation (and the suspension of your suspension) shall be lifted.
- 9. All documentation can be provided to the disciplinary coordinator at:

Ms. Stump's license will not be issued until she signs and returns this agreement.

If Ms. Stump agrees to the conditions set forth above, she must sign and date this document in the space provided below and return it to me within thirty (30) days. Ms. Stump's license will not be issued, and she may not practice massage therapy until this document with her signature has been received and she has obtained her "go to work" letter from the Board's administrative office.

The effective date of this conditional license agreement will be the date OGC receives the signed order back from Ms. Stump..

This letter has the full force and effect as an Order issued by the Board for purposes of Tenn. Code Ann. § 63-18-108(9). Once she has signed and returned this order, it will constitute a formal and public disciplinary action and will be reported to the National Practitioner Data Bank (NPDB) and/or similar agency and will be posted on the Board's "license lookup" website. Any violation of this agreement shall constitute a separate violation of the Massage Licensure Act, T.C.A.§ 63-18-108(9), and is grounds for disciplinary action by the Board.
