The meeting was called to order at 9:00 a.m. by Mr. Michael Velker, Board Chairman. Ms. Kimberly Hodge, conducted a roll call. All members were present, and a quorum was established. Ms. Hoggard was present to provide interpretation for the applicants as needed. Ms. Hodge introduced the new Health Related Board Director, Jennifer Putnam.

#### **Administrative Office Update**

Ms. Hodge, spoke about how the Administrative Office has been conducting meetings with schools. Ms. Hodge stated this has helped the Administrative Office function smoothly, as the applicants and school staff members know what is required of them, and additionally, deficiency letters have been going out in a timely manner. However, due to the number of cases Ms. Turner has, the August Board meeting will most likely last three (3) days.

# Approval of Minutes from the February 9th Board Meeting

Ms. Yarbrough made a motion, to correct the spelling of her name and approve the previous meeting minutes. Ms. Vickers seconded the motion, none opposed. The motion carried.

## **Applicant Interviews**

# **Dongmei Ni – (0:07:33)**

Ms. Dongmei Ni – was present. Ms. NI was invited to appear before the Board due to educational concerns, previous denials, and previous discipline on her reflexology license. Ms. Ni has appeared, and has been denied by the TN Massage Board three (3) times for a massage therapist license, and she has appeared, and was denied for an establishment license at 112 Brentridge Drive, Antioch, TN, and 5722 Hickory Plaza Drive, Nashville, TN. The denials were based upon educational concerns that both of her schools were not approved by the California Massage Therapy Council, owning and operating unlicensed establishment(s), employing unlicensed therapist, receiving discipline on her Reflexology certification, and for being guilty of engaging in unprofessional conduct. In 2015, Metro Nashville PD executed a search warrant on several establishments, including Hickory Day Spa, and What a Day Spa. During the search a black light was used, and semen appeared on every table in each of the establishments. Ms. Ni admitted to performing massage on clients' arms, legs, head, feet, and hands. Ms. Ni was observed performing a full body massage on a client at What a Day Spa while only holding a reflexologist certification. Ms. Hoggard was present to interpret for Ms. Ni. The Board asked Ms. Ni various questions regarding her certifications, education, and past discrepancies. Ms. Ni stated that she had not reported her discipline to the other states for which she holds a license. Mr. Mullins, made a motion to deny the application due to Ms. Ni not meeting the educational requirements, discipline against her reflexologist license, and previous discrepancies. The motion was seconded by Ms. Yarbrough, none opposed. The motion carried.

#### Suxin Zhang -(0:30:50)

Ms. Suxin Zhang — was present. Ms. Zang, was invited to appear before the Board to determine if she meets the educational requirements for licensure. Ms. Zhang appeared before the board at the August 2021 meeting, due to not meeting the Distance Learning Policy requirements for licensure. Ms. Zhang attended a 500-hour program at Phoenix International School of Massage in Houston TX. She completed 445 of her 500 massage program hours in an online format, which was more than 40% that the Distance Learning Policy allowed. At the August 2021 meeting, the Board allowed Ms. Zhang to withdraw her application instead of taking action. Ms. Zhang subsequently, attended Tennessee School of Therapeutic Massage, which is now closed, due to the program being under investigation. It appears that Tennessee School of Therapeutic Massage transferred all of Ms. Zhang's hours into their school and then allowed her to complete additional required hours. Ms. Zhang's transcript from Tennessee School of Therapeutic Massage reflects 700 hours completed (400 transfer hours & 300 classroom hours). The concern of the administrative office is that now Ms. Zhang is still non-compliant with the Distance Learning Policy. The Policy states that "the Massage Licensure Board will consider up to 40% of the total contact hours in a Tennessee Massage School's total curriculum that are offered in an online or distance learning format to be "classroom hours. Forty percent of Ms. Zhang's 700-hour program would allow for 280 online hours and 420 classroom

hours. However, Tennessee School of Therapeutic Massage transcript doesn't account for the 55 hours of in-person hours completed at Phoenix, and based upon all hours being transferred, the administrative office isn't sure if the Phoenix transcript should be considered. Ms. Hoggard was present to interpret. The Board discussed the educational requirements with Ms. Turner. Ms. Vickers made a motion, to deny the application, due to applicant not meeting educational requirements. Mr. Mullins seconded the motion, none opposed. The motion carried.

## **Joanna Lee – (0:50:33)**

Ms. Joanna Lee – not present. The Board reviewed Ms. Lee's application to determine if she meets the educational requirements for licensure. Ms. Lee completed additional hands on (classroom) required hours at Tennessee School of Therapeutic Massage, which has closed the massage program and is currently under investigation, after completing 270 online hours and 250 classroom hours at Touch of Healing School of Reiki Massage in Jasper, GA. Per the Board's current policy for online education, only 40% of an approved massage school may be completed in an online format. Ms. Lee appeared before the Board at the February 2022 meeting, and the Board deferred action to allow Ms. Lee the opportunity to submit additional proof that she attended and completed the required classroom hours at Tennessee School of Therapeutic Massage, to meet the Board's current distant learning educational policy. The applicant is not present, as she lives in New York. Ms. Lee submitted additional documents to show her hours of education earned. Ms. Vickers made a motion, to deny the application, due to the applicant not meeting the educational requirements. Ms. Newberry seconded the motion, none opposed. The motion carried.

#### Yanying Wu - (0.52.30)

Ms. Yanying Wu - was present. Ms. Wu, was invited before the Board due to educational concerns. Ms. Wu attended Texas Massage Academy of America, Inc. The administrative office tried to verify if the school was approved and subsequently, received an e-mail from Texas Department of Licensing and Regulation, that the school did not renew due to tuition issues caused by Covid. The school did not inform the Texas Department of Licensing and Regulation they were closing. Texas requires that the school maintain the educational records when they close, which may explain the reason that the transcript envelope was sent from Orlando, FL. The Board requested additional information as proof of attendance at Texas Massage Academy of America. The administrative office received the enrollment agreement with the school from Jing Zhou. When asked about the affiliation with the school, we received no response. The administrative office received the enrollment agreement from Ashley Atteberry, which is associated with Richard Atteberry, who was the owner and Director of the school. Mr. Gene Lau assisted Ms. Wu with her application and submitted Mr. Wu's credit card statement, three (3) pages of notes, and two (2) pages of a quiz to the MBLEx exam. The administrative office's additional concerns are that there are no transactions on Ms. Wu's credit card statement while in TX. Mr. Lau states this is due to Ms. Wu applying for asylum and her attorney advising her not to make purchases outside of her hometown in NY to prove she wasn't being trafficked. Mr. Lau stated Ms. Wu trashed all notes, test, etc. after passing the MBLEx exam. The quiz that was submitted has been confirmed by the FSMTB to be current exam questions that are provided on the MBLEx exam. FSMTB has been notified and has opened an investigation. Ms. Hoggard was present to interpret. The Board asked various questions regarding Ms. Wu's practice history, school approval, MBLEx exam information, and letters of recommendations. Ms. Wu states she does not hold a license in NY and that her letters of recommendation are inaccurate. Mr. Mullins made a motion, to deny the application based on educational concerns, deceit in the letters of the recommendation, and deceit with having the MBLEx exam in possession. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

#### **Break**

Ms. Hodge conducts a roll call. All Board members are present, a quorum is established.

#### Asian Massage INC, QuiLin Yu LMT – (1:49:50)

Ms. QuiLinYu — was present. Ms. Yu applied for an Establishment license at 1503 Ft. Campbell Blvd, Ste B, Clarksville, TN. She is a licensed Massage Therapist (LMT 13980) with no prior discipline. Ms. Yu is the third applicant to apply for an Establishment license at this location. The previous owners of the establishment were denied a license due to investigations of alleged sexual activity and practicing massage without a license. Ms. Yu listed Tennessee and Pennsylvania addresses on her application, and the Tennessee address is that of the Establishment. Ms. Hoggard was present to interpret. The Board asked the applicant various questions regarding her future living arrangements, establishment, and the location's history. Mr. Mullins made a motion, to defer the application to the August meeting, to allow Ms. Yu time to obtain the lease for the establishment and residency. Ms. Vickers seconded the motion, none opposed. The motion carried.

## Better and Better LLC, Guanshu Wang LMT – (2:17:00)

Ms., Wang - was present. Ms. Wang, applied for licensure of a Massage Establishment at two locations: 6933 Lee Hwy Suite 800, Chattanooga, TN, and 5425 TN Highway 153, Suite 109, Hixson, TN. Ms. Wang has been licensed as a Massage Therapist (13587) since January 2021. Ms. Wang is currently employed as a Massage Therapist at Yu Massage (ME 5823) which is located at 5425 Highway 153, Suite 153, Hixon, TN. She also shares the same home address, telephone number, and email address as the Owner of Yu Massage, Mr. NaiGuang Yu. There is currently an open case in the Office of General Counsel on this owner and Establishment. Ms. Hoggard was present if the applicant needed an interpreter. The Board asked Ms. Wang various questions regarding the establishments. Ms. Vickers made a motion, to approve both the establishment licenses. Ms. Yarbrough seconded, none opposed. The motion carried.

## Long Ma - (2:31:32)

Mr. Long Ma – was present. Mr. Ma, was invited before the Board due to failure to complete the required number ces during the 2015/2016 CE cycle. Mr. Ma was sent an agreed citation from the Administrative Office and failed to pay the citation and make-up the required hours. The Office of General Counsel issued a consent order. Mr. Ma also failed to sign the consent order and allowed his license to expire. The Office of General Counsel closed the case and flagged the file to appear before the Board for a conditional license. The Board has a policy for CE violations that are sent to the Office of General Counsel. Ms. Hoggard was present to interpret. Mr. Mullins made a motion, to grant Mr. Ma a conditional license based on the following: makeup of the deficient hours, completion of penalty hours required, show compliance with continuing education hours until January 2025, pay the civil penalties totaling \$400 (to be paid within 60 days). The motion was seconded by Ms. Newberry, none opposed. The motion carried.

#### Therapeutic Touch Massage, Barry Gager LMT – (2:48:19)

Barry Gager – was not present. Mr. Mullins made a motion, to move forward without the applicant being present. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

Mr. Gager applied for an Establishment license at 1916 Patterson St, Ste 200, Nashville, TN. This address was previously licensed by Mr. Frederick Dunlap (LMT 133) from 2010 to 2012, and applied to reinstate in August 2021. The reinstatement application expired without requirements met by Mr. Dunlap. A Board Order from the February 9, 2022, meeting placed his Mr. Dunlap's Massage Therapist license on conditional probation for a period of 3 years for practice of massage therapy without a valid license and practice; Respondent may not be the owner or responsible person of the massage establishment during period of probation; must provide proof of continuing education compliance for the prior cycle year on January 1, 2023, and January 1, 2025; assessed civil penalty of \$15,000.00. Mr. Gager applied for the license with Mr. Dunlap listed as the massage therapist. The lease agreement submitted by Mr. Gager shows that he and Mr. Dunlap are tenants of the

suite. Mr. Velker made a motion, to defer this application to the August meeting to speak with applicant in person. Mr. Mullins seconded the motion, none opposed. The motion carried.

#### **Lunch break**

Ms. Hodge conducted a roll call. All members were present, and a quorum was established.

## Freedom Massage, Robert Citarella - (3:31:00)

Mr. Robert Citarella - was present. Mr. Citarella applied for an Establishment license at 2400 Madison Street, Ste 9, Clarksville, TN. Mr. Citarella indicated on his application that he owns Sunny Massage in Hoover, AL. Upon reaching out to the AL Massage Board for a verification status of the license for Sunny Massage, the administrative staff was informed and provided investigation documentation showing that Mr. Citarell, owned and operated without a license and allowed unlicensed persons to work in the establishment. Additionally, Mr. Citarella indicated on the application for Freedom Massage, that he had never held nor applied for a license that has been disciplined. The Board asked Mr. Citarella various questions regarding the past discrepancies with his establishment in AL, and his application. Mr. Velker made a motion, to defer the applicant to the August meeting. Mr. Citarella is requested to present the agreement with Ms. Chen, for his Alabama license, and additional information from the Alabama board. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

## Meraki Beauty & Wellness, Paresha Patel - (4:03:00)

Ms. Paresha Patel — was present. Ms. Patel applied for an Establishment license at 3536 Cummings Hwy, Suite 136, Chattanooga TN. The website for the business and Facebook reflected that the business was open and operating prior to date of application for licensure. In December 2021, the Massage Board staff was also able to book an appointment for the Therapeutic Massage with Swedish and Reflexology Massages, with Paresha Patel. Ms. Patel does not hold either a Massage or Reflexology license in Tennessee. In correspondence in January 2022, Ms. Patel stated that the business is only offering beauty related services, not massages, and that the website and social media ads were only to inform of the upcoming addition of massage services. Additionally, Ms. Patel stated that Ms. Fowler was no longer working for the establishment. The Board asked Ms. Patel various questions regarding the application. Ms. Vickers made a motion, to grant a conditional establishment license upon payment of a \$700.00 fine within 60 days. Ms. Newberry seconded the motion, none opposed. The motion carried.

#### **Head 2 Toe, Madison Cantero LMT – (4:19:00)**

Ms. Madison Cantero – was present. Ms. Cantero applied for an Establishment license at 131 Cherry Street, Ste. C, Dunlap TN. She has held a TN Massage Therapist license since October 2011. Ms. Cantero disclosed at the time of her application that she had obtained the location and local business licensees but was not aware that she needed an Establishment license from the Massage Board until she was advised by the Massage Therapist that would be working with her at the establishment. The license for the location was then applied for by the other Therapist, Anne Horgan, who added Ms. Cantero to the license. Ms. Cantero's Massage Therapist license expired in November 2019, and she was removed from the establishment license in January 2020. Ms. Cantero reinstated her therapist license in May 2020 and was re- added to the establishment license August 2020. The Board asked the applicant various questions. Mr. Mullins made a motion, to grant the applicant a Conditional license based on her payment of an additional \$2,500.00 fine, and evidence of completion of an additional TN law class, within the next three (3) months, and she has thirty-six (36) months to pay off all fines. Ms. Vickers seconded the motion, none opposed. The motion carried.

#### Relaxation By the River Massage, Megan Jenkins LMT – (4:43:00)

Ms. Megan Jenkins – was present. Ms. Jenkins applied for Establishment license at 106 Edgewater Rd. Apt 2, Elizabethton, TN. She is a Massage Therapist (11965) since 2017 and has no prior discipline. Online advertisements show that massage was offered at the establishment prior to the application being submitted. Ms. Jenkins stated that her Facebook page has been in place since she became licensed as a Massage Therapist, but only outcalls have been scheduled with her. However, online reviews from April 2022 reflect those services are being offered at the establishment. The Board asked various questions regarding her advertisements. Mr. Mullins made a motion, to approve a conditional establishment license based on her payment the civil penalty of \$1,500.00 over six (6) months. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

#### **Kayla B. Longmire – (4:48:50)**

Ms. Kayla Breonna Longmire - was present. Ms. Longmire was invited to appear before the Board due to her criminal history and concern of her safety to practice based on her own admission on her letter of explanation. Ms. Longmore was originally invited to the August 2020 meeting but, she did not appear. The Board deferred action on her file until the November 2020 meeting to allow Ms. Longmire to contact and receive advocacy from TNPAP. The Board then deferred action at the November 2020 meeting until the February 2021meeting to allow Ms. Longmire additional time to complete her evaluation, and either be deemed safe to practice, or sign and adhere to a monitoring agreement, before a license could be granted. However, before the February 2021 meeting, TNPAP submitted a summary of their experience with attempting to get Ms. Longmire an evaluation. TNPAP's evaluator Dr. Kulenovic, repeatedly rescheduled appointments with Ms. Longmire to try and find dates and times for Ms. Longmire to be evaluated. Additionally, Dr. Kulenovic informed Ms. Longmire that she must complete all requirements, including a toxicology screen before her evaluation appointment. Ms. Longmire's first toxicology screen specimen was invalid, and according to the Medical Review Officer, as "Highly suggestive of an adulterated or substituted specimen". After Ms. Longmire failed to respond to several attempts to reschedule the toxicology screen, and TNPAP's attempt to contact her, Ms. Longmire's TNPAP file was closed on 12/28/2020. After hearing from TNPAP and Ms. Longmire at the February 2021 meeting, the Board denied her application file. Ms. Longmire has since submitted a new application for licensure and completed a recent evaluation with TNPAP.

After contacting TNPAP in January 2022, Ms. Longmire was scheduled to complete a new initial toxicology screen on January 10, 2022. She then sent an e-mail informing TNPAP that her job schedule was very demanding and that she wouldn't be able to complete the screening until January 24th (14 days after the required date). TNPAP informed her that sites were open and available early morning and late evening and rescheduled her for January 12, 2022. Ms. Longmire responded back that she would have to wait until she received her paycheck on the 24th to complete the toxicology screening. TNPAP then made an exception to their policy and allowed Ms. Longmire to test on the 24th, which resulted in a negative screen. After some additional delay, Ms. Longmire provided the required documentation and payment to the evaluator and appeared for a TNPAP approved evaluation on February 23, 2022. The evaluators' diagnoses are located in the letter from TNPAP. Due to Ms. Longmire's medical history the evaluator suggested that she isn't a good candidate to practice in the field of Massage Therapy. The evaluators' professional opinion is that her medical history would likely cause conflicts and danger to her clients, and therefore, not be licensed as a Massage Therapist. It should be noted that since appearing at the February 2021 meeting, Ms. Longmire was charged with aggravated assault that required to have a mental health assessment, have no contact with the new victim and have no new criminal charges. The Board asked Ms. Longmire various questions regarding her file. Mr. Mullins made a motion, to deny a license based on the recommendation from TNPAP, and the Board's rules regarding safety. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

## Break -(5:35:52)

Ms. Hodge conducted a roll call. All members were present, and a quorum is established.

#### Fare Well Massage, Carey Smith LMT – (5:47:00)

Mr. Carey Smith – was present. Mr. Smith applied for an Establishment license at 4706 Papermill Dr, Suite 105, Knoxville TN. He has been a licensed Massage Therapist (LMT 13683) since March 2021 with no prior discipline. Advertisements on the business website, as well as reviews on Facebook and Google, reflected that the business has been open and offering massage services at the location. Mr. Smith stated that before the date of application, the Establishment location had been undergoing renovations and has not been suitable to accept clients since July 2021, and that the pictures on the website are strictly promotional and not those of paying clients. Additionally, Mr. Smith stated that he has only been doing outcalls while waiting for renovation to be completed. The Board asked Mr. Smith various questions. Mr. Velker made a motion, to grant a conditional license with a penalty of \$1,900.00 based on board policy, to be paid over six (6) months. Mr. Mullins seconded the motion, none opposed. The motion carried.

#### Trilogy Aesthetics, Lauren Lyons LMT – (5:56:41)

Ms. Lauren Lyons – not present. Ms. Lyons applied for an Establishment license at 402 E Unaka Ave, Johnson City, TN. Ms. Lyons is a licensed Massage Therapist (LMT 13301) with no previous discipline on her massage therapist license. Facebook advertisements show the business is open and offering massage services and the business website listed and allowed booking of massage services. Ms. Lyons stated that she does not offer massage services at this location, but at another location where she is employed part-time. Ms. Lyons stated that she only has performed skin and esthetics services at this location. Ms. Yarbrough made a motion, to move forward and default without the applicant present. Mr. Mullins seconded the motion, none opposed. The motion carried. Ms. Vickers made a motion, to grant a conditional license with a fine according to board policy of \$700.00. Ms. Yarbrough seconded the motion, none opposed. The motion carried.

### Kneading Knots Massage Therapy, Pamela Burgess LMT – (6:00:00)

Ms. Pamela Burgess – was present. Ms. Burgess applied for an Establishment license at 199 N. 3<sup>rd</sup> Street, Ste 25, Clarksville, TN. She has been a licensed Massage Therapist since 2003 and has no prior discipline on her license. Advertisements shown in December 2021 reflected the business was open and operating prior to submitting her application. Ms. Burgess stated that she changed the business address on Google and social media in preparation of opening the Establishment, but did not accept any onsite appointments for massage, only for Reiki. The Board asked the applicant various question regarding her file. Mr. Velker made a motion, to grant a conditional license with a fine according to board policy of \$900.00, to be paid in four (4) months. Mr. Mullins seconded the motion, none opposed. The motion carried.

#### Energy Healing – LJY Reflexology, Curtiss Witt, Sr. & Keisha Fletcher – (6:05:30)

Mr. Curtiss Witt and Ms. Keisha Fletcher – were present. Mr. Witt and Ms. Fletcher are applying for a Massage Establishment license at 3877 Lebanon Pike, Hermitage, TN. Mr. Witt and Ms. Fletcher previously applied for a license of the same address in September 2021 which was closed due to being incomplete on the closing deadline of December 6, 2021. The present application was opened on February 23, 2022. The business was open at the time of both applications under Ms. Yi Sun (LMT 10536), who was stated to sell the business to Mr. Witt and Ms. Fletcher. Ms. Fletcher submitted documents showing that as of November 15, 2021, she became the owner and President of Energy Healing Inc. and that the lease had also been updated. The Massage licensure office staff was able to book services online February 17, 2022, and March 10, 2022, with Curtiss Witt and Jenny Lee. Online reviews reflected that at least 4 weeks prior to March 10, 2022, services were performed at the Establishment. Ms. Fletcher stated that on March 16, 2022, to the Massage office staff that the Establishment had been closed for two weeks while waiting for the application to be approved. The Board asked the applicants various questions regarding their file. Ms. Vickers made a motion, to grant a conditional license based upon payment of the policy penalties, a fine totaling \$2,100.00 to be paid over six (6) months. Mr. Mullins seconded the motion, none opposed. The motion carried.

#### **Curtis Witt III – (6:45:47)**

Mr. Curtiss Witt III – was present. Mr. Witt was invited to appear before the board due to multiple criminal convictions including, but not limited to several suspended licenses, 2010 DWI, 2012 Domestic Assault 3rd 2nd Offense, and lack of child support payments. Based upon the Board's Criminal Conviction Policy, the Administrative Office referred Mr. Witt III to TnPAP for an evaluation to determine if he was safe to practice. Mr. Witt III informed the Administrative Office that he would prefer to appear before the Board instead of undergoing the TnPAP evaluation. The Administrative Office is also concerned that Mr. Witt III is listed as an employee on LJY Reflexology website, and it appeared he had appointments

available to be booked with him the week of February 13-18. Mr. Witts' III father, Curtiss Witt II is applying for an establishment license and is an owner and operator of LJY Reflexology along with Keisha Fletcher. The Board asked the applicant questions regarding his file. Ms. Yarbrough made a motion, to grant the applicant a conditional license based upon payment of the policy penalties of a fine totaling \$400.00 and submit a new application with fee. The motion was seconded by Ms. Newberry. Mr. Mullins and Ms. Vickers oppose. Mr. Velker breaks the tie, and the motion was denied. Mr. Mullins made a motion to defer the application until the next meeting so that the applicant has time to complete a TNPAP evaluation and completed a corrected application. Ms. Yarbrough seconded the motion, none opposed. The motion carried.
