1. Paula Anderson Coach and Consulting LLC – business Management (Live Webinar) – TN0092023-22 - Ms. Vickers made a motion seconded by Ms. Yarbrough to approve. The motion carried.

### Discuss and take action on school approvals and / or program changes if necessary.

1. Update provided to the Board regarding FSMTB – Discussion was brought to the board by Ms. French concerning FSMTB leadership and the direction they have been going. There was more discussion of some correspondence FSMTB have sent to other members (States), on behalf of the all member states that may not have conveyed the opinion of all member States.

2. Texas Massage Exam –Discussion was brought to the board by Ms. French. After board discussion a motion was made by Ms. Vickers seconded by Mr. Velker to approve acceptance of the Texas Exam. The motion carried.

### **Applicant Interviews:**

A. Results Salon and Spa – Operated establishment without a license since it was purchased in January 2023, after discussion a motion was made by Ms. Vickers seconded by Ms. Yarbrough to approve the establishment license with the contingency to pay penalties. The motion carried.

B. The Divine Salon and Day Spa – Operated establishment on an expired license since December 1<sup>st</sup>, 2021. After discussion a motion was made by Mr. Mullins seconded by Ms. Newberry to approve establishment license with contingency to pay penalties. The motion carried.

C. Karen Lynn Wallace – LMT marked on her renewal application and submitted letter indicated she is in poor physical and/or mental health. After discussion a motion was made by Ms. Vickers seconded by Ms. Yarbrough to approve the license renewal. Mr. Mullins Nay. Ms. Burke recused all other board members affirm. The motion carried.

D. Randy Dwayne Vickers – Applicant criminal background check had extensive charges and two felonies. After discussion a motion was made by Mr. Mullins seconded by Ms. Vickers to approve initial license. The motion carried.

### **Contested Case(s):**

1. Energy Healing A.K.A. LJY Reflexology Me 433 – The Office of General Counsel presented a proposed Order of Suspension for Yi Sun, LMT and Energy Healing A.K.A LJY Reflexology ME 4333 due to unprofessional and unethical conduct while performing a massage. After review and discussion Ms. Yarbrough made a motion seconded by Mr. Mullins to suspend ME and the owner LMT licenses. The motion carried.

#### **Consent Order(s):**

1. Christina Reynolds LMT 9956 – The Office of General Counsel presented a Consent Order detailing Ms. Reynolds practiced massage therapy on an expired license. Ms. Reynolds voluntary surrender license to practice as a massage therapist. Mr. Mullins made a motion to approve the order seconded by Ms. Burke. The motion carried.

2. Ms. Johnson/Massage Elite LMT – 10702/ME 4245 – Th Office of General Counsel presented a Consent Order detailing Asuka Johnson and Massage Elite, LCC an investigator from TDH made an unannounced visit. The investigator noted three clients were undressed and waiting for service and other violations. The owner admitted she hired two women to perform massages at this location that did not possess Tennessee Massage Licenses. After discussion a motion was made by Mr. Mullins seconded by Ms. Burke to approve the order. The motion carried.

#### Legislative Updates:

1. Professional License Portability for Servicemembers and their spouses. Brittany Kendrick made board aware of legislative update that required Tennessee to allow military service member and their spouses with LMT licenses to practice in Tennessee as long as their Military Orders for this region are active. Discussion was made by board members. Public comment was made by Steve Summers and Ma-Lish Nash inquiring as to how this would be managed. Currently the process has not been fully determined.

Discuss and take action, if needed, regarding rulemaking, hearings, rule amendments, and policies.

Discussion was made to increase requirement for educational hours. It was determined that a task force be created. A motion was made by Ms. Burke seconded by Ms. Vickers. The motion carried.
