Applicant Interviews:

A. Cory Atkins, LMT File 15133 - Applicant attended Atlanta School of Massage which is closed. Applicant submitted an unofficial transcript from Atlanta School of Massage showing a graduation date of 2/4/2021. Our office informed Ms. Atkins that we needed a letter from the Georgia Board of Education stating that the school has closed and whether they have her transcript.

Ms. Atkins, submitted a letter from Shirlene Mitchell from Georgia Nonpublic Postsecondary Education Commission. On receipt of the questionable letter, Tonya Wilkins questioned the applicant on whether Ms. Mitchell sent her the letter, the applicant stated that Ms. Mitchell told her to write the letter which is attached. Ms. Wilkins then contacted Georgia Nonpublic Postsecondary Education Commission to inquire about the letter.

Ms. Mitchell contacted Ms. Wilkins and stated that she did not tell the applicant to write a letter on her behalf. Ms. Mitchell went on to say she told the applicant their office could write a letter stating Atlanta School of Massage has closed. Ms. Michell also told the applicant the school currently still has all the transcripts and has a website where she can request her transcript. Ms. Atkins did not appear. Ms. Yarbrough mad a motion to deny the license, seconded by Ms. Jones. The motion carried.

B. Country Escapes Massage Therapy – Terri Lynn Crum ME 2247 - Massage Establishment has been working on an expired license since March 1, 2023. Ms. Crum, the responsible party, is in attendance. Ms. Jones made a motion to issue a conditional license and pay accessed fees, Ms. Azimipour seconded. The motion carried.

C. Benjamin Edwards, LMT file 15081 -Applicant has a March 29, 2023, domestic assault incident. He has completed an intensive supervised probation through the East Tennessee Human Resource Agency as ordered by the Session Court of Scott County, TN on March 3, 2024. Mr. Edwards is in attendance. Public Comment:

Dr. Bolden-Greer made public comment as to the timeline of rule change concerning the educational hours. Mr. Varnell stated that the changes were in the internal review phase. Mr. Varnell also stated that there is currently a statute in place for this rule change.

Adjourn:

Consent Order

Li Wang LMT 11327 - Rejuvenating Massage ME 5226

Paetria Morgan, Office of General Counsel Board Attorney, introduces herself and the subject matter to the board. Morgan ensures that no members need to recuse themselves for this consent order. Morgan introduces the case details to the board. Wang admitted to hiring unlicensed individuals to work in her establishment Rejuvenating Massage. The board deliberates after all case information has been shared. Newberry motions to approve the proposed order as written. Azimipour seconds the motion, and none oppose. The motion carries. The massage establishment license # 5226, is hereby placed on probation for at least three years, respondent's massage therapist license # 11357, is hereby placed on probation for at least three years, during the period of probation, Ms. Wang shall submit proof of compliance with the 2023/2024 continuing education cycle by January 31, 2025. 11. During the period of probation, Ms. Wang shall notify the Board's disciplinary coordinator of any employment change at Rejuvenating Massage within thirty (30) days of the change. Respondent shall pay two (2) Type A Civil penalties in the amount of one thousand dollars (\$1,000.00) each, representing the penalty for allowing two individuals to engage in unlicensed practice. The total civil penalty assessment is two thousand dollars (2,000.00). Respondent must pay, pursuant to TENN. CODE ANN. § 63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board by the State in connection with the prosecution of this matter. These costs will be established by an Assessment of Costs prepared and filed by counsel for the State. The maximum amount for the assessment of costs shall be two thousand dollars (\$2,000.00).

Tarek Mentouri LMT 11920

The telecommunication service "Teams" is projected on screen to the board. Court reporter Loisann Abbott is present via "Teams" call. The respondent Tarek Mentouri is not present via Teams at the start of the meeting. Judge Begley confirms that we have established a quorum. Judge Begley introduces himself to the board and reviews the technical report and previous notice of hearings and charges. The Judge verifies that the respondent is incarcerated Jessica Turner, Office of General Counsel Attorney shows the judge that her delivery of the proper notice of charges were given, going into detail on how and when she contacted the respondent. Mentouri was informed by Turner that if he did not appear the board has the option to proceed today in default. The Judge reviews these documents to ensure that proper notices has been given. Judge Begley rules that the proper notice of charges and hearing have been met by the state office of general counsel. The Judge turns the decision on how to proceed to the board members. Yarbrough motions to proceed in default. Azimipour seconds this motion, and with none opposed, the motion carries. The Judge Begley verifies there are no conflicts of interest for any of the board members with this case. The board confirms there are no conflicts, and therefore no member will be recusing themselves. Jessica Turner gives her opening statement introducing the case.

Respondent has been at all times pertinent hereto licensed by the Board as a massage therapist in the State of Tennessee, having been granted license number 11920 on December 16, 2016, which expired on February 28, 2022. On or about November 30, 2022, Respondent pled guilty to two (2) counts of felony Sexual Battery. On or about November 30, 2022, Respondent pled guilty to two (2) counts of misdemeanor Assault. As a result of the convictions in paragraphs two (2) and three (3), Respondent must register as a sex offender. .Mentouri is appealing the past revocation order in pursuit of his licensure being restored. Ms. Turner is bringing this case before the board to ensure that Mentouri's licensure is revoked, barring him from practice in Tennessee in the future. Turner presents the exhibits of evidence for her case to the board and judge for review. Turner presents her closing statement to the board. The Judge informs the board on the guidelines of how they can proceed in ruling over this case. Turner provides the board with her proposed final order. The board members review and open the floor for deliberation. Amy Jones and William Mullins discuss typical revocation procedures for licensees. Emily Newberry motions to accept the findings of fact as written. Alicia Azimipour seconds this motion, and with none opposed, the motion carries. Virginia Yarbrough motions to accept the conclusion of law as written. Emily Newberry seconds this motion, and with none opposed, the motion carries. Amy Jones motions to accept the proposed order with removing "proof of continuing education and" from number 8 of the order but accept the rest as written. Alicia Azimipour seconds the motion, and with none opposed, the motion carries. Emily Newberry motions to accept the policy statement as written. Amy Jones seconds this motion, and with none opposed, the motion carries. Respondent's license is hereby **REVOKED** effective the entry date of this Order. Respondent must pay, pursuant to Tenn. Code Ann. § 63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board by the State in connection with the prosecution of this matter.

Yi Sun with Energy Healing, ME 4333 was summarily suspended previously by the board due to unethical practice and sexual misconduct. Azimipour motions to accept the proposed order as written. Jones seconds, and with none opposed, the motion passes. Respondent, Yi Sun's, massage therapist license, # 10536, is hereby REVOKED, effective the entry date of this Order. Respondent, Energy Healing A.K.A. LJY Reflexology, #4333 is hereby REVOKED, effective the entry date of this Order. Respondent(s) must pay, pursuant to TENN. CODE ANN. § 63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board by the State in connection with the prosecution of this matter. These costs will be established by an Assessment of Costs prepared and filed by counsel for the State. The maximum amount for the assessment of costs shall be six thousand dollars (\$6,000.00). The costs and civil penalties assessed in this order must be paid in full within two (2) years of receiving the Assessment of Costs in this case.

Magic Massage ME 3791 (9:12am)

Judge Begley confirms that the board has established a quorum for today's hearings. It is ensured that no board member has a conflict of interest. Kendricks distributes the notice of charges to the board and opposing counsel. Ms. Kendricks introduces herself and the case to the board. Magic Massage was found to be employing unlicensed individuals in this establishment. Opposing counsel representative Joe Wyant introduces his opening statements to the board. Kendricks enters evidence for the boards review. Joe Weyant calls two witnesses to the stand. Phillip Hughes, owner and responsible party of Magic Massage, and his stepdaughter Jiayo Li. Mr. Hughes answers various questions about his business for Mr. Weyant. The board now asks the witness various questions about the case.

Short recess called.

Magic Massage counsel Joe Weyant decides to not call his second witness Jiayo Li. He begins by asking witness Phillip Hughes additional questions. Within sixty (60) days from Assessment of Costs being sent to Respondent, Respondent must either pay the civil penalties and costs in full OR make arrangements for a payment plan with the Disciplinary Coordinator.

Respondent must pay, pursuant to TENN. CODE ANN. § 63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board by the State in connection with the prosecution of this matter. These costs will be established by an Assessment of Costs prepared and filed by counsel for the State. The maximum amount for the assessment of costs shall be Three Thousand Dollars (\$3,000.00).

Any and all civil penalties and costs shall be paid in full within sixty (60) days after the issuance of the Assessment of Costs.
