DETERMINATION OF NECESSITY OF ELECTRONIC MEETING

The Board of Nursing Home Administrators determined that the failure to have a quorum on November 7, 2022, with the next upcoming regularly scheduled meeting on March 6, 2023, posed an immediate danger to the health, safety, and welfare of the residents of Tennessee as set forth herein. The November 7, 2022, Board Meeting had fifteen (15) applicants/candidates on the agenda that were unable to move forward in the process of becoming nursing home administrators, and their ability to move forward without an emergency meeting would require each candidate to wait until March 6, 2023. Furthermore, since the November 7, 2022, scheduled meeting, two (2) additional applicants/candidates have become eligible to move forward in the process of becoming nursing home administrators. Thus, the Board finds that a failure to have a meeting between the dates of August 1, 2022, and March 6, 2023, poses an immediate danger to the health, safety, and welfare of the residents of Tennessee and that advancing qualified applicants/candidates is necessary to enable Tennessee nursing homes to provide necessary services to Tennessee residents.

If the Board deems this meeting necessary and wishes to proceed to conduct this electronic meeting for the aforementioned purpose, we need a motion, a second, and a roll call vote. Would anyone like to make a motion to this effect or otherwise?
