Dr. Schuler called the meeting to order at 9:05 a.m. A roll call vote was conducted and all Board members were present with the exception of Dr. David Sables.

#### **Minutes**

Upon review of the August 9, 2017 minutes, Mr. Fillauer moved to accept the minutes seconded by Dr. Davis. The motion carried.

#### **Investigative Report**

Ms. Lori Lenard reported that all currently monitored practitioners in Podiatry are revoked. There are nineteen (19) new open complaints for Podiatrists year to date. There have been twelve (12) complaints closed and there twelve (12) currently being monitored. Ms. Lenard stated that malpractice and negligence is the biggest complaints. There are two (2) complaints on Orthotists that are still being monitored.

#### Office of General Counsel

Mr. David Silvus, the new General Counsel for the Podiatry board introduced two (2) Consent Orders for the Boards review. The first is Dr. Charlton Peter, DPM; he was convicted of

insurance fraud April 3, 2017 in a Federal Court. He had retired his license before he went to Federal Court. The Board reviewed the Consent Order and voted to approve it. Ms. Oglesby made a motion to approve the Consent Order, seconded by Dr. Davis, all in favor.

The second Consent Order is for Dr. Bill Vuong. After receiving a complaint an investigation was conducted and it was determined that several things were going on. Dr. Vuong was involved with platelet rich plasma injections. He was doing the injections in body parts other than the feet and ankles which are beyond the scope of practice. This was occurring with dozens of patients from 2015 until earlier this year. The record keeping for these injections was inadequate with no documentation of history, the object of the exam, or the diagnosis to justify or explain the decision to administer the injections. He was also prescribing controlled substances without documenting any particular medical reason as to why and for periods of time that were not justified. Dr. Vuong would also complete the chart, sign a blank prescription pad and date it and then give it to his office manager who would then fill out the prescription based on what was in the chart. The Consent Order is to suspend his license and he will have to come back before the Board to get the suspension lifted. He also had to complete a course on prescribing controlled substances. He has already completed the course at this time. He will be eligible to come back in front of the Board in three (3) months at the next Board meeting to request to have the suspension lifted. After that he will be on probation for 5 years. Dr. Pavuluri made a motion to accept the Agreed Citation, seconded by Ms. Oglesby. All in favor. The motion carried.

#### **Financial Report**

Noranda French presented the financial report and discussed the actual year end numbers. The total expenditures for the year was \$80,522.82, total revenue for the year was \$102,117.79. That allowed the board to close at \$21,594.97 with a cumulative carry over of \$308,787.70.

#### **Administrative Report**

Ms. Hayes stated as of November 7, 2017 there are 267 active Podiatrists; 137 active X-ray operators; 152 active Orthotists; 145 active Prosthetists and 53 active Pedorthists. Ms. Hayes reviewed the monthly statistical breakdown of the renewed, retired and failed to renew.
