The Tennessee Board of Pharmacy convened on Tuesday March 9, 2021, in the Iris Room, 665 Mainstream Drive, Nashville, TN. A quorum of the members being present by WebEx, the meeting was called to order at 8:04 a.m. with Dr. Wright presiding. Dr. Dilliard asked that public comments be sent via email.

#### Minutes

Dr. McKinney made the motion to accept the minutes as presented. Dr. Breeden seconded the motion. A roll call vote was taken. The motion carried.

#### OGC

Mr. Gibbs informed the board that there are currently 47 cases open for discipline within the Office of General Counsel. Of those 47 cases, 5 are eligible for a contested case hearing.

Mr. Gibbs informed the board that the Tennessee Board of Pharmacy along with the Tennessee Department of Health has been named as two of the defendants contained in the master docket for the National Prescription Opiate Litigation. The Office of the Attorney General is aware of this litigation.

Mr. Gibbs informed the board that the rules pertaining to pharmacy interns, pharmacy technicians and medical devices are currently in internal review. The medical device rules began the internal review process on January 4, 2021.

Mr. Gibbs presented the following bills currently being introduced to the 112th General Assembly.

**HB0686** - Health Care - As introduced, authorizes implementation of a statewide collaborative pharmacy practice agreement specific to epinephrine auto-injectors; authorizes pharmacists

licensed in, and practicing in, this state to dispense epinephrine auto-injectors; makes other related changes. - Amends TCA Title 39, Chapter 17; Title 49, Chapter 50, Part 16; Title 53; Title 63 and Title 68.

Assigned to committees of the House of Representatives and Senate on February 20 and February 22, 2021, respectively.

**HB0877** - Pharmacy, Pharmacists - As introduced, makes changes with regard to compounding pharmacies, including allowing out-of-state pharmacy practice sites to provide certain inspections, equivalent to what are currently required, if accepted by the Tennessee board of pharmacy and removing the requirement that pharmacies engaging in sterile compounding have to make certain quarterly reports to the board. - Amends TCA Section 63-10-216.

Assigned to committees of the House of Representatives and Senate on February 20 and February 22, 2021, respectively. Note – requires a new rule promulgated by the Board.

**SB1253** - Drugs, Prescription - As introduced, requires the board of pharmacy and the board for licensing health care facilities to promulgate rules to establish certain guidelines for pharmacies and facilities to provide for disposal of unused controlled substances and prescription drugs. - Amends TCA Title 4; Title 63 and Title 68.

Assigned to the Senate Health and Welfare Committee February 22, 2021.

Mr. Gibbs informed the board that the complaint committee investigated 23 cases for the board.

Dr. Rodgers made the motion to accept **Joshua Wilson, RT**. consent order to voluntarily surrender his pharmacy technician registration (same as revocation). Mr. Wilson violated T.C.A. §56-10-305 (6). Dr. Pryse seconded the motion. A roll call vote was taken. The motion carried.

Dr. Breeden made the motion to accept **Denise Dubay, RT** consent order with a \$100.00 civil penalty. Ms. Dubay violated board 1140-01-.09 (1). Dr. McCall seconded the motion. A roll call vote was taken. The motion carried.

Dr. Breeden made the motion to accept **Walgreens Pharmacy #11113** consent order with a \$1000.00 civil penalty. Walgreens Pharmacy #11113 violated board rule 1140-03-.01 (1)(a) and (f). Dr. McKinney seconded the motion. The motion carried.

Dr. Breeden made the made the motion to approve the request from Ballad Health to waive the requirement for direct supervision by a pharmacist for filing/stocking of medication to the automated dispensing machines (ADMS) at Hancock County Hospital, Johnson City Community Hospital and Unicoi County Memorial Hospital for one (1) year. Dr. Pryse seconded the motion. A roll call vote was taken. The motion carried.

# **Director's Report**

Dr. Dilliard presented the Food and Drug Administration (FDA) Memorandum of Understanding Addressing Certain Distributions of Compounded Human Drug Products Between the State Board of Pharmacy or Other Appropriate State Agency and the Food and Drug Administration (MOU) to the board. If the board signs the MOU, it will allow a pharmacy to ship 50% of product across state lines without issue from the FDA. If the board does not sign the MOU, the pharmacies can still ship 5% of products across state lines. After discussion, this issue will be presented at the May meeting to determine
