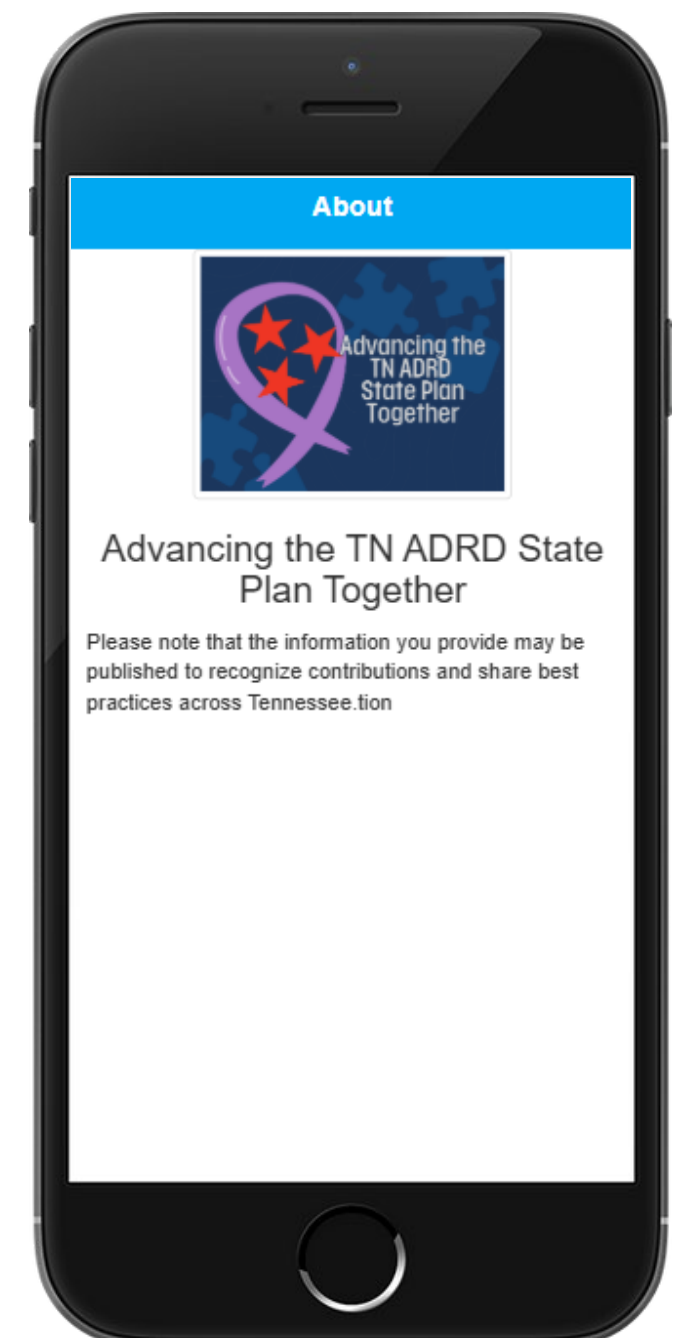


Approval of March Meeting Minutes
