Job Overview

The Tennessee Department of Health (TDH) is seeking applicants for a Medical Director for the Division of Community Health Services (CHS). This is an Executive Service leadership position reporting to the Assistant Commissioner. CHS Leadership provides oversight of all services provided by 95 rural health departments across the state including Women, Infants, and Children (WIC); family planning; sexually transmitted diseases (STD) management; immunizations; and oral health services. In addition, physicians and advanced practice nurses provide reproductive health services and primary care in 56 health department sites.

Duties and Responsibilities

- Supervising seven (7) Regional Health Officers (RHOs), encompassing 89 counties across the state
- Providing leadership and support for RHOs who oversee physicians, advanced nurse practice nurses, public health nurses, and associated clinical staff in regional clinics and rural health departments
- Developing and updating CHS clinical policies and standardizing procedures in coordination with RHOs to provide best practice guidelines for primary care clinics, family health and wellness services, and specialty clinics such as Tuberculosis and sexually transmitted diseases
- Supervising the State Nursing Director to assure quality and safe care is delivered by public health nurses
- Working closely with the Assistant Commissioner of CHS in providing executivelevel management of clinical operations, including continuous quality improvement to ensure efficient use of resources, appropriate patient flow, and maximization of access to care for the population served
- Leading the TDH Clinical Quality and Process Improvement teams in initiatives to ensure that medical services provided meet the highest standards of care, professionalism, and efficiency
- Collaborating closely with other TDH divisions such as Family Health and Wellness and Communicable and Environmental Diseases and Emergency Preparedness in appropriately implementing related activities in rural health departments
- Overseeing the provision of and growth of telehealth services throughout the state
- Serving as clinical leader of the CHS Electronic Health Record team for implementation of a new medical and dental record system
- Supervising the State Oral Health Director and State Pharmacy Director

Required Qualifications

Must have completed a graduate medical education program and hold either a Doctor of Medicine (M.D.) or Doctor of Osteopathic Medicine (D.O.) degree, have been board certified in their specialty, and maintain a valid license to practice in the state of Tennessee; impeccable personal and professional ethics and integrity; excellent oral and written comunication skills; and the ability to interface with the community as a public health officer.
