## **Poster/PSA Contest Questions**

### Q. Could a childcare agency submit one for their site, or is it preferred for one per child?

- A. The poster contest is for young children, through middle school age. Each individual child must create their own poster entry and the childcare agency can submit them.
- Q. I am the art teacher at XXXXX Middle School, and I had a few questions about the Health Poster contest:
- 1. Does the poster have to use certain materials? For example, can some students create a digital poster and others use watercolor/create it on paper?
- A. Digital and paper poster submissions will be accepted from youth.

### 2. Is there a limit on how many submissions I can turn in?

A. One poster may be submitted on behalf of each child. One PSA may be submitted on behalf of each teenager or team of teenagers.

### 3. Is there a size limit or file type you don't accept when uploading the entries?

- A. The standard file type for video work is .mp4., with a maximum file size of 32MB.
- Q. XXXXX County Schools would like to participate in the PSA video contest.
- 1. Can we have as many people as we want to submit a video, or does it need to be just one?
- A. A teen or a team of teens should each submit one PSA video. One school may have several "teams" submitting PSA videos.

# 2. Would you rather have a "captain" submit for a "team" that is making the video or is the expectation individual students submitting a video themselves?

A. It's up to the students. A captain can submit a video for a team or individuals can submit their own videos.

## Q. Due to the child's safety and privacy, will the child's school name be advertised in the publication?

A. We only need the contact info to inform the child/teen if they are a winner. We do not have to post personal information on social media if the adult/school/organization does not give consent.

# Q. When submitting a student's entry, should the phone number and email be the student's home information or that of his/her teacher?

A. The entry should not include a student or teacher's home information. The entry should include the school phone number and the teacher's email address.

## Q. I wanted to know do the kids take a picture of the poster and then add it to your link?

A. The children/students can take a picture of their poster or they can scan the poster onto a computer and upload it.

### Q. I live in Wisconsin and was wondering if I could participate in the video contest?

- A. Thank you so much for your interest in the Poster/PSA Contest. However, the contest and all Child Health Month activities are designed to engage Tennessee residents in events that will promote health and wellness among Tennessee's children, teenagers and their families.
- Q. Our students at XXXXX Elementary school participated in a poster competition last year about hand washing. They created some amazing posters and I'm so proud of them! Is there a way that I could submit those posters in for the competition? I have the winning posters in my clinic, and it would be a wonderful opportunity for me to show my students work, if permitted.
- A. We are certain that you should be proud of the posters your students created last year. However, we would like to encourage new, original artwork created specifically for the Child Health Month 2020 Poster Contest.
