Sections 1819(h)(2)(B)(ii)(IV)(ff) and 1919(h)(3)(C)(ii)(IV)(ff) of the Social Security Act incorporate specific provisions of the Patient Protection and Affordable Care Act pertaining to the collection and uses of civil money penalties (CMPs) imposed by the Centers for Medicare & Medicaid Services (CMS) when nursing homes do not meet requirements for long term care facilities. In accordance with 42 CFR § 488.433 and CMS Survey & Certification Memo 12-13-NH (effective January 1, 2012) States must obtain approval from CMS for the use of federally imposed CMP funds.

Our office has reviewed the proposal submitted by Tennessee Technological University for \$665,086.00 to implement a program titled, "ArtTherapy4Life Tennessee." Art therapy is a proven method for slowing cognitive decline in residents living with dementia and is proven to discourage negative behaviors. Participating facilities will be equipped with training and materials necessary to ensure long-term sustainability of the art therapies. Overall, the project is likely to result in direct improvement in residents' quality of life. This is a three year project involving 100 Tennessee certified nursing homes across the state. Nursing facilities will be selected for participation based on the following conditions: (1) a high percentage of psychotropic medication use; (2) star quality ratings at or below three stars, or (3) located in a

rural setting. Tennessee Technological University will use third-party vendor, ArtTherapy4Life (T4L), to provide up to 20 staff from each facility an onsite training workshop on how to implement an art therapy program and supplementary manuals for reference.

Based on the CMP application request and additional information provided for review, the CMP request has been approved. Acceptance of CMP funds by Tennessee Technological University requires the university to:

- Review the CMP project and deliverables with Alliant Quality, the Tennessee Quality Improvement Organization (QIO);
- Ensure that all participating nursing homes are registered with Alliant Quality;
- Provide a list of participating nursing homes to CMS, Alliant Quality and the State Survey Agency;
- Review the CMP project and deliverables with the Medical Director of each nursing home;
- Quarterly reports shall disclose the number of residents participating in the clinical art therapy program at each nursing home;
- Quarterly reports shall discuss the impact of the clinical art therapy program on residents' quality of life; and
- At least annually, Tennessee Technological University shall schedule a conference call with CMS and the State Survey Agency to share information on lessons learned and best practices identified. The QIO and LTCO shall be invited to voluntarily participate in the annual project update.

Quarterly reports on this project and a final report summarizing lessons learned will be sent to CMS, with CMP request number 2020-04-TN-0430 included on all pages of the report. Please address correspondence for CMS to:
