# **TOPICS OF DISCUSSION**

Focus: All Things Clinical Health

Presenter: Dr. Stephan Sharp, Medical Director of Clinical Research Associates, Inc.

**Summary:** Mr. Sharp, presented this presentation and it was about clinical trials. Mr. Sharp. spoke about Clinical Research Associates, Inc. known as CRA and it's a clinical trial site which seeks to recruit patients, coordinate clinical trials, monitor patients' health, and report data. CRA, clinical trials have three phases for the patient's safety. Phase 1, study takes up to 12 - 18 months, to see if the patient's body can handle the administered trial product. Phase 2 is to identify the maximum amount of dosage the body can tolerate and see if the patient's immune system is producing the type of responses, their desiring, in a 2-year span. Phase 3 is to see if the trial product is preventing infections or at least helping

to reduce the severity of the disease in 2+ years or more. Clinical Trials are event based which means an event must occur for researchers to get to work. The only way researchers will know a vaccine is able to prevent and cure a virus or disease if someone contracts a virus or disease. Then the researchers can do a study and if they receive 90% efficacy rate meaning 9 out of 10 people is a success, then the trial product can be used.

Anyone of all races and ethnicities that's healthy and manage their medications well may participate. Note, not all individuals with pre-existing conditions are allowed to participate in clinical research because the research itself have its own inclusion and exclusion criteria. If someone would like to join a clinical trial study/research below is list of what to expect:

- Discuss health history of self, family and medicines taking
- > Physical Exam: check heart, lungs, blood pressure, weight and temperature
- > Basic Lab Work: blood, urine screenings, nasal swab and other health screens, if needed
- > Patient will have 24/7 access and may call and discuss concerns or health issues
- > Study Related Care: Provide additional health care to patients
- > Compensation: for time-off, travel, childcare expenses, all determined by an Independent Review Board
