TOPICS OF DISCUSSION

Focus: "Drug Take Back Events in Tennessee"

Presenter: Sarah Murfree – Prevention Coalition for Success, Inc., Rutherford County headquartered in Murfreesboro via TN Dept of Mental Health, Mr. Anthony "Tony" Jackson

Summary: The presentation focused on the coalition's involvement with taking unused, prescribed/OTC drugs for proper destruction and preventing abuse. Discussed using the DEA and the state of Tennessee as sources for guidance and sponsoring a "Take Back Day" locally. Discussed the statistics for users of unused medications, success of the take back program, and potential for education and messaging at the events. Also, provided information for OTC medication that is risky for overdose. Deterrent pouches are useful in individual destruction of unused medicines.
