Updating Facility Information

We understand that as time goes on information for a facility may change. We at TDH, would like to remind you to keep us up to date by emailing us at TDH.Informatics@tn.gov whenever a large-scale change or small-scale change occurs at your facility or facilities.

This can include any of the following:

- · Change in the facility's name
- · Location change (i.e. street name, building, etc.)
- · An update to the facilities NPI
- A facility closing (permanently or temporarily) or being acquired

Reporting Tips

- If there are any missing weeks in your DOR summary report, please make sure to submit those weeks, as it means TDH does not have a record of receiving those files from those weeks with no errors. A missing week can be identified as a facility name in RED on your DOR Summary Report with no totals in the rows. If you believe you submitted a file for a week that did not appear on your DOR Summary Report, please reach out to TDH.Informatics@tn.gov for assistance.
- If either your DOR Summary Report or Data Detail Validation File says your DOR record contains a warning, please reach out to TDH.Informatics@tn.gov for assistance with correcting the warning.
- To correct an error, TDH recommends using the Error handling Guide. Which contains detailed instructions on all possible errors, including their description, their likely causes and how to correct them.
