We are writing on behalf of Jamestown Medical Center, Inc. (Hospital #48) in response to your correspondence regarding the expiration of the current inactive status waiver on April 22, 2026.

At this time, we respectfully request an extension of the facility's inactive status for 12 months. The facility remains non-operational and is not currently admitting patients. While we are not yet in a position to resume operations, we are actively working toward future reopening and are beginning preliminary planning and evaluation efforts to support that process. We continue to assess operational and strategic considerations and will notify the Health Facilities Commission promptly of any change in status in accordance with Board Policy #77. We appreciate the Commission's consideration of this request and respectfully ask that this matter be placed on the agenda for the April 22, 2026, Health Facilities Commission meeting.
