Attached please find a labeled schematic and supporting visuals outlining the proximity and layout of The Rutherford Assisted Living and The Rutherford Memory Care. The two buildings are located directly across from one another, separated only by Gold Valley Drive, with an approximate distance of 45 feet from driveway to driveway.

For additional context:

- **The Rutherford Assisted Living (68 beds)** faces Lasscasas Pike
- **The Rutherford Memory Care (32 beds)** faces Gold Valley Drive

The buildings are situated directly across the street and operate as a unified campus. Their close proximity allows for immediate accessibility, clear line of sight, and effective administrative oversight between both locations.

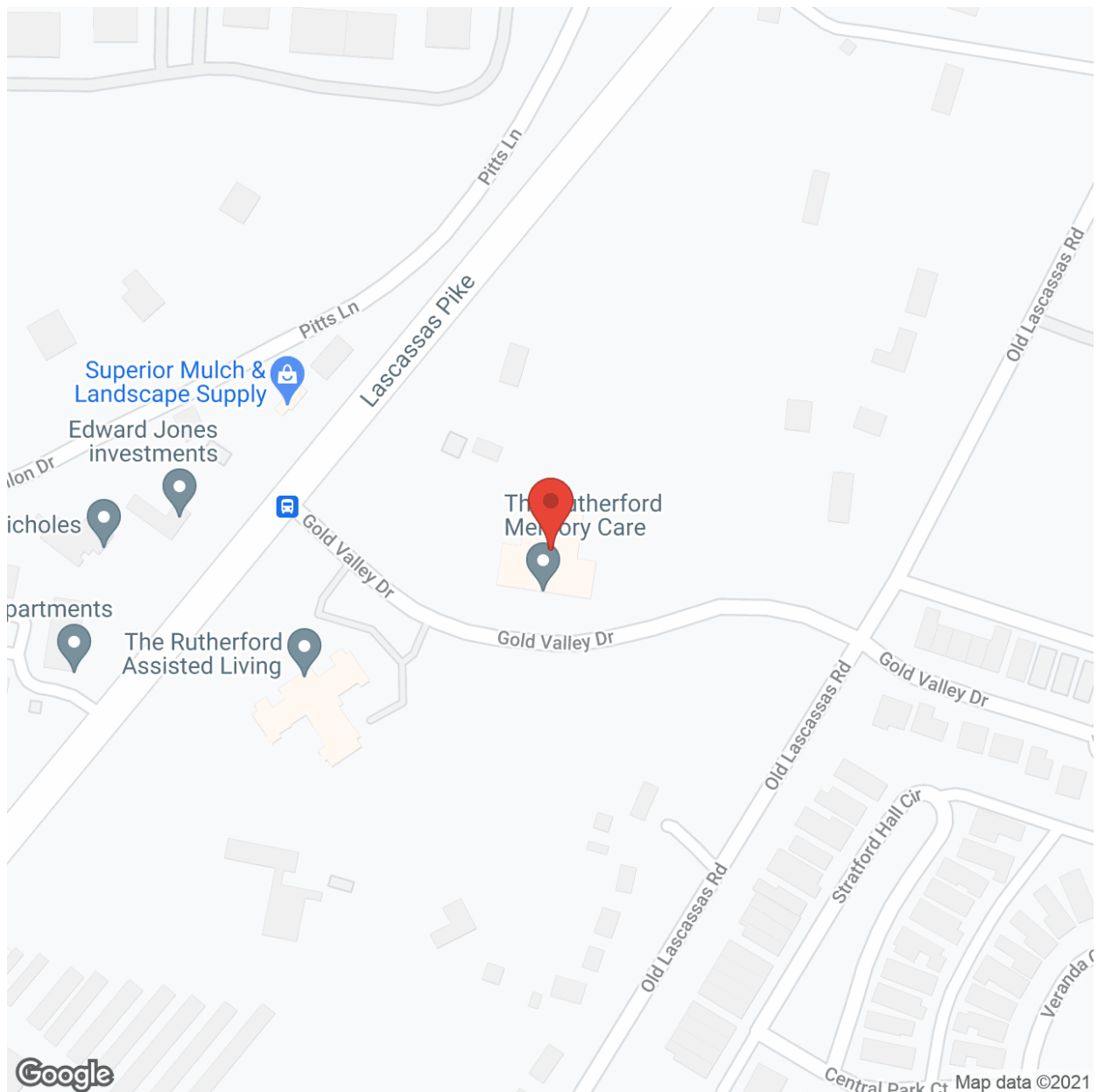
