Subject: Request for Waiver – Outpatient Rehabilitation Services

Dear Director and Members of the Board,

I am writing on behalf of West Tennessee Post Acute to respectfully request a waiver for the provision of outpatient rehabilitation services at our facility. Our commitment to patient-centered care and the evolving needs of our community have highlighted the necessity for expanded outpatient rehab offerings, which are currently limited by existing licensing regulations.

Background and Justification:

West Tennessee Post Acute has consistently demonstrated high standards in patient care and rehabilitation. The demand for outpatient rehab services has increased, particularly among patients transitioning from acute care who require ongoing therapy to achieve optimal recovery. Granting this waiver will allow us to provide seamless, high-quality rehabilitation services, reduce unnecessary hospital readmissions, and improve patient outcomes.

Proposed Scope and Safeguards:

- All outpatient rehab services will be delivered by licensed and credentialed professionals.
- The outpatient rehab services have a separate entrance without going through resident care areas
- All outpatient rehab services will be provided in our rehab designated areas

Community Impact:

This waiver will enable us to better serve our community, particularly vulnerable populations who may face barriers to accessing rehabilitation elsewhere. It aligns with our mission to provide accessible, high-quality healthcare and supports broader public health goals.

Request:

We respectfully request the Board's consideration and approval of a waiver to allow West Tennessee Post Acute continue to offer outpatient rehabilitation services.

West Tennessee Post Acute (WTPA) was formerly known as West Tennessee Transitional Care (WTTC).

On January 1, 2025, Links Healthcare Group took over new ownership of the facility from AHC that lead to the subsequent facility name change.

Outpatient services were offered prior to the acquisition and remained available following the acquisition.

West Tennessee Transitional Care was granted a Board Waiver on May 4, 2016

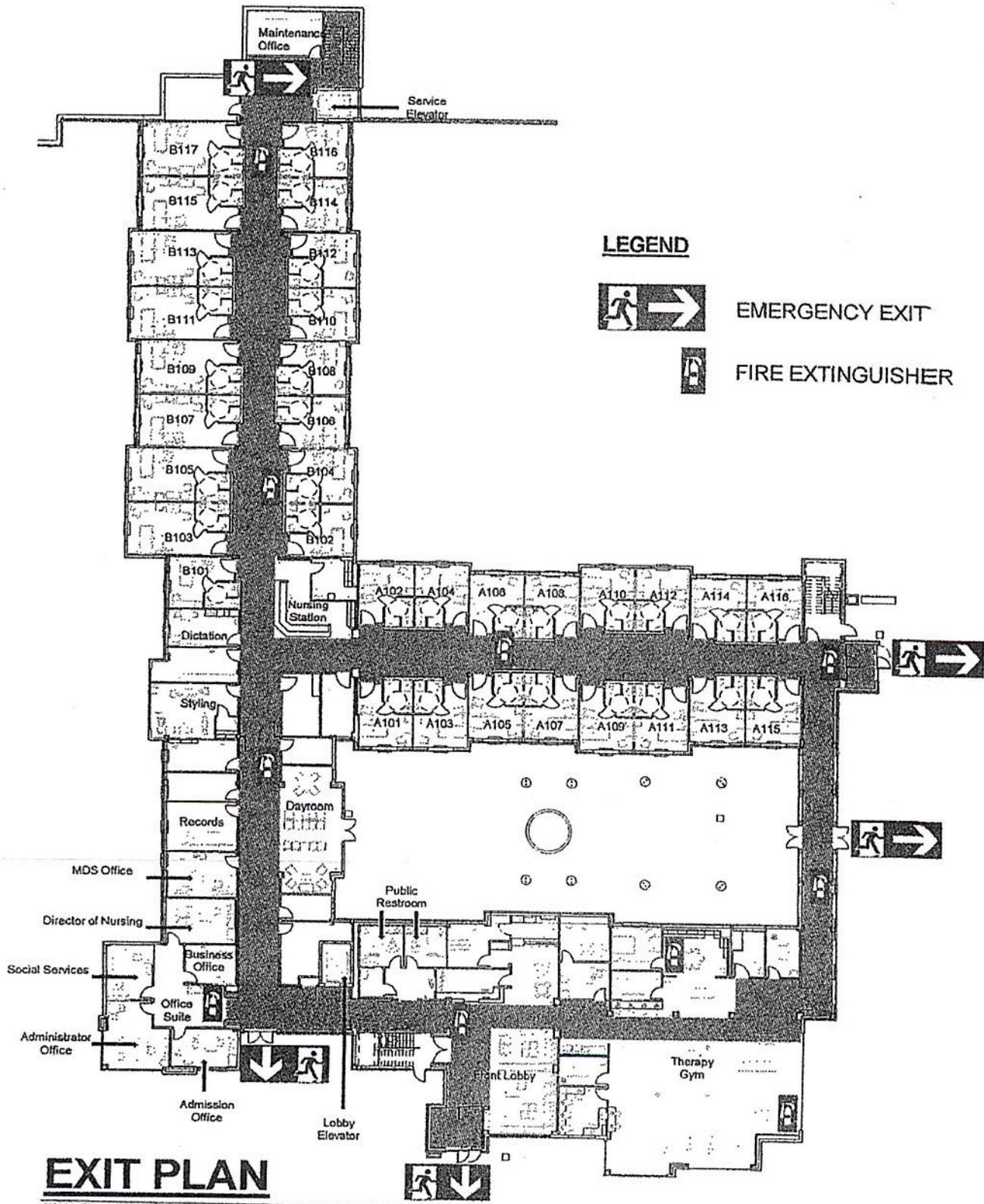

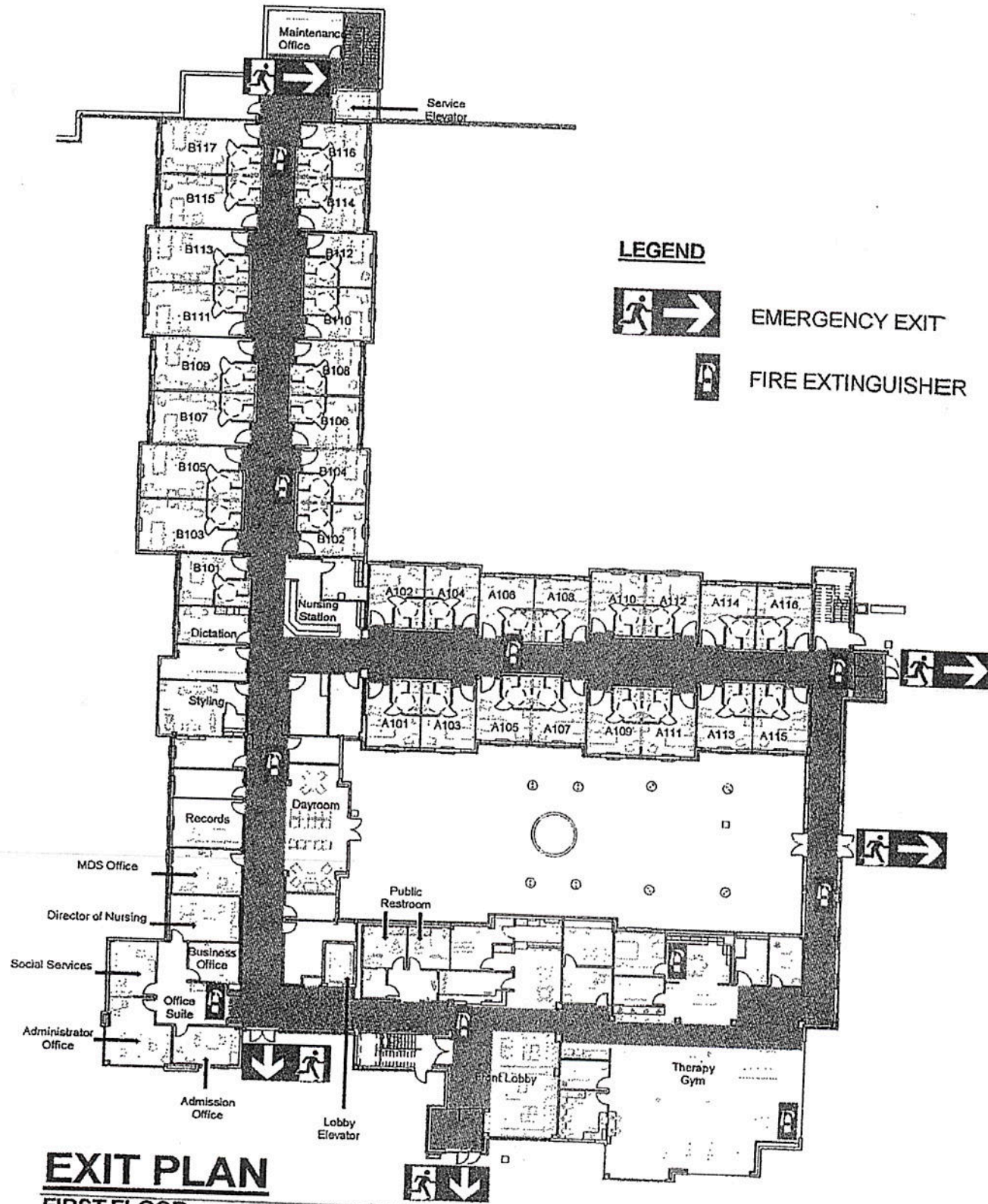
