For the establishment of a home care organization and the initiation of home health services located at 1035 Westhaven Blvd, S-301, Franklin (Williamson County), Tennessee 37064. The proposed service area consists of Williamson County. The applicant is owned by Emily Manning, PA-C with an ownership type of Limited Liability Company. Estimated project cost: \$60,800.

**OPPOSITION: AccentCare Home Health of Nashville**
  - B. AMA Home Care Services, LLC. dba HomeTN Nashville, Nashville (Davidson County) TN CN2603-008**

For the establishment of a home care organization and the initiation of home health services located at 4350 Sneed Road, Nashville (Davidson County), TN 37215. The proposed service area consists of Davidson County. The applicant is owned by Aubrey Austin, NP with an ownership type of Limited Liability Company. Estimated project cost: \$60,200.

**OPPOSITION: AccentCare Home Health of Nashville**
  - C. AHC Home Health and Hospice of Nashville, LLC. (Davidson County) TN CN2604-011**

For the modification of the scope of services of the existing Agency's home health services, whose parent office is located at 627 19th Ave. N., Nashville, TN 37203. The approval of this application will remove the condition on the existing home health agency license #667 limiting its home health services to only those patients who have received services at AHC Nashville, LLC, d/b/a Advanced Health Care of Nashville, an existing skilled nursing facility (the "Center"), also located at 627 19th Ave. N., Nashville, TN 37203. The approval will grant the Agency an unrestricted home health agency license in Cheatham, Davidson, Robertson,

Rutherford, Sumner, Williamson and Wilson Counties. The applicant is owned by LHM MAN HHH, LLC, a holding company which is ultimately owned by The Larry H. Miller Company. Estimated project cost: \$190,840.

**OPPOSITION: AccentCare Home Health of Nashville**

**D. Naven Health, Inc., Knoxville (Knox County) TN CN2604-009**

For the establishment of a home care organization and the initiation of home health services located at 9041 Executive Park Dr., Suite 250, Room 6, Knoxville (Knox County), Tennessee 37923. The project will be limited to home infusion services. The proposed service area will consist of 95 counties including CON-exempt Grundy and Lake Counties. The applicant is owned by SPNN Holdings, LLC which is ultimately owned by Option Care Enterprises, Inc. Estimated project cost: \$142,733.

**E. Sumner Regional Medical Center, Gallatin (Sumner County) TN CN2604-010**

For the establishment of a satellite hospital, under the single license of Sumner Regional Medical Center at 225 Big Station Camp Boulevard in Gallatin (Sumner County), Tennessee. The satellite hospital will incorporate the existing free-standing emergency department (which received CON approval and is operational) and will have 28 licensed inpatient acute care beds (twenty-four private medical beds and four intensive care unit beds), an endoscopy suite, a cardiac catheterization laboratory, two operating rooms and ancillary spaces. The cardiac catheterization laboratory will provide both diagnostic and therapeutic procedures. This project involves the renovation of approximately 41,845 square feet and the construction of 2,705 square feet. The service area for Sumner Station differs by patient population. For adult patients, the service area consists of the home zip code for the project site (37066) and four contiguous zip codes within a ten-mile radius: 37075 (Hendersonville), 37048 (Cottontown), 37148 (Portland), and 37188 (White House), from which 90% of adult inpatients are projected to originate. The pediatric service area includes Sumner, Macon, Robertson, Trousdale, Smith, and Wilson counties. The applicant is owned by Highpoint Healthcare, LLC, a joint venture with 20 percent ownership held by Baptist Health Care Affiliates Inc. (a subsidiary of Saint Thomas Health), and 80 percent ownership held by Highpoint Partner, LLC, an indirect subsidiary of Lifepoint Health Inc. Estimated project cost: \$59,335,000.

Saint Francis Hospital a licensed acute care hospital has a 40-bed psychiatric PPS unit. The utilization of this unit has steadily declined from 2021 to 2024. The decline has made it difficult to attract and retain qualified staff. Saint Francis Hospital has made the difficult decision to temporarily discontinue their psychiatric service and notify the Commission of this closure.

**c. Covenant Health Hospitals at Home Programs**

**Covenant Health–Discontinue their Hospital-at-Home Services**

Covenant Health is notifying the Health Facilities Commission that the following hospitals have decided to discontinue their hospital-at-home services:

- Parkwest Medical Center, Knoxville–Hospital #42;
- Fort Sanders Regional Medical Center, Knoxville-Hospital #43;
- Fort Loudoun Medical Center, Lenoir City-Hospital #84;
- Covenant Health Morristown-Hamblen, Morristown-Hospital #73.

Covenant Health’s decision to discontinue these services was made following comprehensive review of the program’s operational sustainability in light of multiple federal funding interruptions, patient volumes, and other organizational priorities.

The Commission is authorized at any time during the probation to remove the probational status of the facility's license based on information presented to it showing that the conditions identified by the Commission have been corrected and are reasonably likely to remain corrected.

The facility shall request an Order of Compliance from Commission staff at the end of its probationary period. If the facility is in compliance at that time, the Order of Compliance will be prepared by Commission staff and presented at the next Commission meeting. The Commission shall make the final determination of whether to terminate the facility's probation.

**Civil Penalty:** One (1) Civil Monetary Penalty in the amount of three thousand dollars (\$3,000.00).
