#### **PROJECT DESCRIPTION:**

This application is for the establishment of a new hospital that will include 8 inpatient acute care beds, imaging, emergency services, and laboratory services. The address of the project will be at the northwest corner of U.S. 64 and Warren Road, Somerville, Fayette County, Tennessee, 38068.

#### **Executive Summary**

- If approved, the applicant projects the proposed project will open for service in March 2027.
- The applicant is seeking to establish a new community hospital within Fayette County, Tennessee. The hospital will be licensed as a satellite location under Baptist Memorial Hospital Memphis along with Baptist Memorial Hospital for Women, and Baptist Memorial Hospital Collierville. The facility will contain eight emergency department rooms and eight inpatient rooms, as well as CT, X-Ray, and Ultrasound capabilities.
- Fayette County has been without a licensed general hospital facility since the previous facility operated by Methodist Healthcare closed in 2015. Fayette County residents must travel and be transported by county EMS services to surrounding counties which require significant time to reach. The former Methodist Fayette hospital is owned by the Town of Somerville. It is primarily utilized as a campus of the University of Tennessee-Martin.
- The facility will be located on Highway 64 between the cities of Oakland (4 miles west) and Somerville (5 miles east). Patient admissions are projected to be almost entirely Fayette County residents due to the facility's central location.
- The applicant highlights the fact that 7,580 Fayette County residents' accessed emergency services in 2015 at Methodist Fayette, 145 of whom were admitted to inpatient care, and 101 were placed in observation status.
- The proposed hospital facility will be staffed to support emergency services, as well as low acuity inpatient care, and observation status patients.
- Patients requiring a higher level of care will be stabilized and transferred to a tertiary facility for further treatment.
- The applicant does not plan on providing obstetrical or surgical services or intend to seek designation as a Critical Access Hospital.
- The applicant states that it will be able to leverage telehealth consultative services to assess, diagnose, and monitor patients who present to Baptist Memorial Fayette who require specialty consults in Cardiology, Neurology, and Infectious Disease.
- The applicant highlights strong community and governmental support for the project, which is a collaboration between the applicant, Baptist Memorial Health Care Corporation, Fayette County, and the Fayette County Industrial Board.
- The applicant's owner, Baptist Memorial Health Care Corporation, operates 24 affiliate hospitals in West Tennessee, North and Central Mississippi and East Arkansas as well as a freestanding emergency department.
- The applicant states that it is the largest not-for-profit healthcare system in the region and provides the largest share of total Medicaid services.
- The applicant states that it contributed more than \$465 million in community benefit and uncompensated care to the communities it serves in FY2023.

- The hospital's network includes a physician group with more the 1,100 providers, 5,400 affiliated physicians, a Cancer Center, home health, hospice, psychiatric care, walk-in and urgent care clinics, surgery services, rehabilitation and outpatient centers, and an education system – Baptist Health Sciences University and college of osteopathic medicine.
- The applicant highlights its many credentials and recognitions in response to Item 1E. of the application. Please see Page 6 which also includes the project description, ownership, service area, existing similar service providers, project cost, and staffing.

#### **Facility Information**

- The construction of the facility will be a cooperative agreement between Baptist Memorial Health Care Corporation, Fayette County, and the Fayette County Industrial Board through which the land for the project site will be acquired from its current owner Chickasaw Electric Cooperative (Parcel ID 088 028.00) by Fayette County Government. Fayette County will provide financing for the construction of the project and convey the property to the Fayette County Industrial Board to oversee construction of the project.
- When construction is completed, Baptist Memorial will lease the physical facility for 20 years. Baptist Memorial will equip, staff, and solely operate Baptist Memorial Fayette. At the end of the 20-year lease, and fulfillment of certain covenants, Baptist Memorial will have the option to purchase the facility from the Fayette County Industrial Development Board.
- Copies of the MOU between Baptist Memorial Health Care Corporation, Fayette County Government and the Fayette County Industrial Board are available as well as a copy of the draft Agreement of Purchase and Sale between Fayette County and the Chickasaw Electric Cooperative which is included as Attachment 9AR.
- The single-story hospital facility will consist of approximately 18,233 square feet of new construction built on a parcel of approximately 5.1 acres along with potential medical office building/physician space adjacent to the facility.
- The emergency department will have one emergency department room equipped to treat behavioral health patients.
- The inpatient pharmacy will be operational 24/7. During hours in which the pharmacist is not physically on site, a pharmacist will be on call and access to medications will be done via automated dispensing machines such as Omnicell.
- The CT scanner is a 128-slice GE Revolution.

- See Attachment 10A Floor Plan. The applicant states that the facility is not being designed to accommodate future vertical expansion. The only potential expansion would be for the medical office building adjacent to the hospital as identified on the Plot Plan (See Attachment 12A).
- While the applicant expects most patients to arrive by private vehicle there is public transportation available in Fayette County through the Delta Human Resources Agency ("DHRA") which provides low-cost roundtrip "door-to-door" transportation services to the residents of Fayette County.
- The applicant has not determined whether a helipad will be constructed at the facility but has identified a potential location should it determine one is appropriate.

#### Ownership

• The applicant, Baptist Memorial Hospital Fayette County ("Baptist Memorial Fayette") will be wholly-owned and operated by Baptist Memorial Health Care Corporation ("Baptist Memorial").

#### **Project Cost Chart**

- The total project cost is \$27,745,590. Of this amount, the highest line-item costs of the project are Facility Lease Costs which will include Construction Costs (\$18,063,605), IT Services (\$4,018,772), Moveable Equipment (\$2,309,914), Fixed Equipment (\$1,991,749), and Legal, Administrative and Consultant Fees (\$1,316,550).

#### **NEED**

The applicant provided the following supporting the need for the proposed project:

- To improve access to healthcare service and reduce travel burdens for residents of Fayette County: The applicant states that the approximately 45,000 residents of Fayette County are geographically isolated from hospital care and emergency care and are forced to travel between 17-35 miles in order to reach the closest facilities in the area Saint Francis Bartlett, Baptist Collierville, or Methodist Le Bonheur Germantown. The proposed facility will alleviate these challenges by being centrally located on a major thoroughfare between the two major population centers in the county.
- To meet the needs identified by county residents and officials: The applicant highlights this project as a response to a longstanding community need which has generated support from the local government officials, who believe that there is a substantial need to restore inpatient acute care and emergency services to their

community. This is supported by the community's investment into the project. The project will also reduce the response burden on EMS in the county, which currently must transport patients' long distances for care. Fayette County operates the local EMS service for the county which includes four EMS stations in Somerville, Oakland, Rossville, and Collierville.

- To increase consumer choice in the area: The addition of a new community hospital facility will afford greater choice in healthcare services to residents of Fayette County. It will also support resident access to consults from and transportation to tertiary hospitals operated by the applicant in the region, improving the overall quality of care. The applicant also highlights its commitment to providing care to all patients regardless of race, ethnicity, income, or other socioeconomic factors. Additionally, the hospital will offer services to underinsured, uninsured, and low-income populations, including TennCare and charity care patients. The applicant does not expect the project to significantly impact the utilization of hospitals in eastern Shelby County, including Methodist Le Bonheur Germantown, or Saint Francis Bartlett.
- The project need is established according to the Acute Care Criteria: There are no acute care beds in Fayette County. The need standard is satisfied for Fayette County. According to the 2023 Joint Annual Report Summary, 3,436 Fayette County residents were forced to out-migrate for inpatient hospital care in 2023. The applicant highlights the fact that 3,114 patients were admitted to inpatient care from Fayette County in 2015 which is 10% less that were admitted in 2023 when no hospital was available.

• Fayette County has a projected a 4-year growth rate of (3.8%) which is greater than the statewide rate of (2.9%). It also has a lower percentage of the population living below the poverty level (10.8% vs. 14.0%), a lower percentage of TennCare enrollees (14.7% vs. 19.9%) and a higher median household income (\$84,764 vs. \$67,097).

#### Service Area - Historical Utilization

<sup>\*</sup>There were 59 admissions, and 355 total patients admitted to other hospitals in the state in 2024. Only four of those admissions were in West TN hospitals (3) at West Tennessee Healthcare Bolivar Hospital (Hardeman County) and (1) at Haywood County Community Hospital (Haywood County). There remainder were in Middle and East TN counties.

- Approximately (43.0%) of patient days by Fayette County residents who outmigrated in 2023 were admitted to a Baptist affiliated facility.
- The largest number of patient days were represented by Baptist Memorial Hospital (24.6%); Methodist Hospital Germantown (16.6%); Saint Francis Hospital Bartlett (14.2%); and Baptist Memorial Hospital Collierville (13.1%).
- The applicant states that while it does not have access to Fayette County EMS's transport data, it can confirm based on its internal data that approximately (15%) of Fayette County residents who were transported by EMS to a Baptist facility came via EMS.

#### Applicant's Historical and Projected Utilization

• As a new hospital, there is not historical utilization to report. The applicant projects its utilization for the first two years (2028-2029) of the project in the table below:

- The applicant projects that the same number of patient days will be provided in both Year 1 and Year 2 of the project reaching 25% of both licensed and staffed occupancy at the hospital.
- The applicant's projections are based on an analysis of Fayette County residents who were admitted to Baptist Memorial affiliated hospital facilities in 2024. It reviewed admissions based on diagnostic related groups (DRGs) to determine acuity levels of those admissions, and then compared the admissions to the proposed service levels of the new Fayette County Hospital.
- The applicant also adjusted projections based on the assumption that residents residing north of Highway 64 will be more likely to utilize the new facility than those residing to the south who may be more likely to travel to Collierville for services.
- The applicant projects that it will serve 5,110 patients in its emergency department in Year 1. Approximately (15% 767 patients) of those are projected to be for EMS drop-offs which will result in significant reductions in travel burden to county EMS services.
- Approximately (20%) of admissions the emergency department are projected to be converted to observation status resulting in an average daily census of 5 patients (2 inpatients and 3 observation patients).

• For its inpatient admissions, Baptist Memorial Fayette projects an average length of stay of 3.274 days for total inpatient patient days of 730 on the projected 223 inpatient admissions.

- The applicant's proposed average net charges are projected to decrease from \$1,018.29 in Year 1 (2028) to \$909.73 in Year 2 (2029) because of higher levels of contractual adjustments, charity care and bad debt accounting as deductions in revenue. The applicant's proposed total charges are listed on Page 18.
- Emergency services are included with outpatient revenue in response to Item 6C
   Projected Data Chart.
- The applicant also expects that physicians will utilize the hospital's laboratory testing, radiology, and imaging services on an outpatient basis.

- Medicaid (TennCare) and Medicare are projected to represent a combined (55.0%) of gross operating revenue for the project.
- The applicant projects that Charity Care will be equivalent to approximately (6.4%) of Gross Operating Revenue in Year 1 (2028) of the project. Please refer to Item 10C. in the Consumer Advantage section on Page 19 of the application for additional Payor Mix information.

- The applicant plans to contract with all TennCare Managed Care Organizations including TennCare Select.
- A list of projected contracted commercial and managed care organizations is included in the applicant's response to Item 2.C.
- The applicant discusses the fact that some commercial plans are not in-network for Baptist facilities including Cigna and United Healthcare. However, it states that other health systems in Memphis / Shelby County such as Methodist are out of network with plans such as BlueCross.
- The applicant describes the Memphis / Shelby County insurance market networks as narrow and indicates that patients who are commercially insured in the area understand the limitation of the insurance networks and will generally choose the closest facility that is in-network when seeking care.
- The applicant states that it expects most patients who have historically been innetwork for other health systems will continue to utilize those system's facilities.
- The applicant states that it will continue serving all patients in its emergency department regardless of their ability to pay consistent with EMTALA.

#### **Agreements**

- The applicant states that it will handle transfers among other Baptist affiliated facilities in Shelby County.
- The applicant states that patients in need of behavioral health treatment can be referred to local mental health providers in the area where they can either be discharged into an appropriate outpatient program or transferred for inpatient admission. The emergency department at the facility will have one room specially equipped for behavioral health patients.
- The applicant provides a list of all Fayette County medical facilities in response to Supplemental #1, Question #5, Pages 2 4.
- The applicant identifies several partnerships it maintains within the Fayette County Community including funding for local search and rescue, Fayette-Ware High School, United Way of the MidSouth, Fayette County Boy Scouts, Southwest TN Community College and Porter-Leath, which operates early childhood education programs in Fayette County. Baptist Memorial also included Fayette County in its Baptist Community Health Needs Assessment for 2013, 2016, 2019 and 2022. The Community Health Needs Assessment includes an emphasis on wellness programs, free health screenings, chronic disease prevention and management efforts.

- Direct Care positions include the following: Registered Nurses (8.4 FTEs); Paramedic (4.2 FTEs); Radiologic Technologist (4.2 FTEs); and a Physician (1.0 FTEs).
- Non-Patient Care positions include the following: Hospital Administrator (0.5 FTEs); Testing Coordinator (0.5 FTEs), APC (0.35 FTEs); Pharmacist (0.5 FTEs); and Registration Specialists (4.2 FTEs).
- There are no Contractual staff identified by the applicant.
- An ED physician will be onsite 24/7/365. The core clinical ED support staffing will also be available 24/7/365, including 1 ER-trained registered nurse, 1 paramedic, and 1 multi-modality radiology tech (for both X-Ray and CT). The applicant states that staffing will be scaled as necessary to properly manage the facility's ED volumes.
- The applicant highlights its affiliated training programs, specifically the Baptist Health Sciences University which includes a nursing program that graduates approximately 250 nurses per year.
- The applicant also operates its Center for Career Development which assists both future and current employees throughout West Tennessee, Eastern Arkansas, and North and Central Mississippi. This program includes a comprehensive range of services from career coaching and advising, to assistance with developing career and learning plans, education program search support and guidance.
- The applicant states that it will leverage its current employee assets to staff and recruit to the new facility and that it can successfully recruit the number of required staff by the facility's opening in 2028. The recruitment efforts will be led by the hospital administrator and other Baptist Memorial personnel.
- Please refer to Item 8Q. on Page 23 of the application for additional detail regarding project staffing.

- The applicant maintains Licensure through the Tennessee Health Facilities Commission, Certification through Medicare and TennCare, and Accreditation through The Joint Commission.
- The applicant states that it will adopt and implement a quality improvement and outcome evaluation process consistent with the policies and procedures of Baptist Memorial. Its quality improvement programs will include data reporting and process monitoring to ensure quality outcomes and efficiency.
- The applicant provides its CMS quality ratings as the host hospital Baptist Memorial Memphis in Attachment 1N, Pages 2 & 3. Each of the measures is classified as either "Better than the National Benchmark" or "No Different than the National Benchmark" according to CMS with the exception Healthcare workforce influenza vaccinations which are slightly lower than the state and national averages.
- The applicant highlights the fact that seven of its affiliated Baptist Memorial hospitals in Arkansas, Mississippi and Tennessee were named to the 2024–2025 U.S. News & World Report Best Hospitals list with Baptist Memorial Hospital-Memphis (Memphis) and Mississippi Baptist Medical Center (Jackson, Mississippi) named as the top hospitals in their respective cities.
- Four Baptist Memorial hospitals also received "A's" from Leapfrog Group for providing safe care, and the Centers for Medicare & Medicaid Services awarded four Baptist Memorial hospital's four stars and Baptist Memorial Hospital-Leake five stars, its highest rating for quality.

#### **Acute Care Bed Need Standards and Criteria**

1. Determination of Need: The following methodology should be used and the needfor hospital beds should be projected four years into the future from the current year.

The Applicant has contacted the Tennessee Department of Health for a forecast of the hospital beds needed in Fayette County as determined by the State Health Plan's Acute Care Bed Need formula. Because there are currently no hospital beds in Fayette County, the Acute Care Bed Need formula (which relies on the current and projected ADC and licensed bed count) cannot be calculated.

- a. New hospital beds can be approved in excess of the "need standard for a county" if the following criteria are met:
  - i. All existing hospitals in the proposed service area have an occupancy level greater than or equal to 80 percent for the most recent Joint Annual Report. Occupancy should be based on the number of staffed beds for two consecutive years.

There are no existing hospitals located in Fayette County.

ii. All outstanding CON projects for new acute care beds in the proposed service area are licensed.

There are not any outstanding CON projects for new acute care beds in Fayette County.

iii. The Health Services and Development Agency may give special consideration to applications for additional acute care beds by an existing hospital that demonstrates (1) annual inpatient occupancy for the twelve (12) months preceding the application of 80 percent or greater of licensed beds and (2) that the addition of beds without a certificate of need as authorized by statute will be inadequate to reduce the projected occupancy of the hospital's acute care beds to less than 80 percent of licensed bed capacity.

Not applicable. The applicant is not an existing hospital.

b. Applicants applying for acute care beds in service area counties where there is no hospital, and thus no bed occupancy rate numbers to provide for the need formula, should provide any relevant data that supports its claim that there is a need for acute care beds in the county or counties. Data may include, for example, the number of residents of the county or counties who over the previous 24 months have accessed acute care bed services in other counties.

According to the 2023 Joint Annual Report Summary, 3,436 Fayette County residents were admitted for hospital care in 2023 with 3,377 (98%) of those admissions occurring in hospitals in counties adjacent to Fayette County. Of those 3,377 admissions, approximately 44.4% visited Baptist-affiliated hospitals, 24.4% were admitted to Methodist facilities, and 23.4% were admitted to Saint Francis facilities. Those 3,377 admissions resulted in total patient days of 19,154.

With 19,154 total patient days in 2023, the Acute Care Bed Need formula would suggest a current need of 52.5 acute care beds necessary to treat Fayette County residents. This calculation does not include observation patients who also sought care at a hospital and were held for observation but not admitted to the hospital. Although Baptist Memorial Fayette only intends to treat a small subset of these patients, clearly sufficient demand exists to support the proposed facility.

2. Quality Considerations: Applicants should utilize Centers for Disease Control & Prevention's (CDC) National Healthcare Safety Network (NHSN) measures. Applicants must provide data from the most recent four quarters utilizing the baseline established by the NHSN within the dataset.

Baptist Fayette County is a new hospital and does not have an operating history. The applicant has provided the quality ratings for Baptist Memorial's Memphis campus, which is the largest single provider of hospital care to Fayette County.

3. Establishment of Service Area: The geographic service area shall be reasonable and based on an optimal balance between population density and service proximity of the applicant.

The proposed service area for Baptist Memorial Fayette is Fayette County. As discussed elsewhere in this application, Baptist Memorial Fayette will be conveniently located on Highway 64 – the main thoroughfare that traverses Fayette County – and it will sit essentially equidistant between Oakland (4 miles) and Somerville (5 miles), the two largest cities in the county. The applicant projects that essentially all its admissions will be Fayette County residents.

4. Relationship to Existing Similar Services in the Area: The proposal shall discuss what similar services are available in the service area and the trends in occupancy and utilization of those services. This discussion shall include the likely impact of the proposed increase in acute care beds on existing providers in the proposed service area and shall include how the applicant's services may differ from these existing services. The agency should consider if the approval of additional beds in the service area will result in unnecessary, costly duplication of services. This is applicable to all service areas, rural and others.

There are no acute care beds in Fayette County. According to the 2023 Joint Annual Report Summary, 3,436 Fayette County residents were admitted for hospital care in 2023. This represents a 10% increase in hospital admissions since the closure of Methodist Fayette in 2015 (3,114 total). The proposed hospital will include 8 inpatient acute care beds, imaging (x-ray, ultrasound, and CT), 8 emergency rooms, and laboratory services. It will improve access to care for Fayette County residents, reducing the need for many residents to travel into Shelby County for both hospital admission, observation care, and emergency services. This will permit patients to receive care closer to home and reduce the costs to consumers necessitated by travel into Shelby County. It will also reduce EMS transports of Service Area patients out of the Service Area, which are having to travel significant distances with associated time out of the area. For patients requiring a higher level of care, the proposed hospital will have the ability to stabilize patients before transferring them to a tertiary facility in Shelby County.

As discussed below, utilization projections for the proposed hospital were derived by primarily analyzing the number and acuity of Fayette County residents currently traveling into Shelby County to be treated at Baptist facilities. Nevertheless, it is likely that some small number of Fayette County residents who are currently traveling to Methodist and Saint Francis facilities in Shelby County will also choose to access the more convenient option provided by Baptist Memorial Fayette. Given the limited number of such patients, it is not expected that the occupancy or utilization of either Methodist or Saint Francis will be meaningfully impacted.

5. Services to High-Need and Underserved Populations: Special consideration shall be given to applicants providing services fulfilling the unique needs and requirements of certain high-need populations, including uninsured, low-income, and underserved geographic regions, as well as other underserved population groups.

According to the United States Census Bureau, 10.8% of Fayette County residents live below the federal poverty level and according to TennCare, 17.1% of residents are TennCare enrollees. Baptist Memorial is dedicated to providing compassionate, high-quality care for patients consistent with its faith-based mission. Baptist Memorial Fayette will provide care to all patients regardless of race, ethnicity, income, or other factors. In accordance with Baptist Memorial's system-wide policies, the applicant will provide services to underinsured, uninsured, and low-income populations, including TennCare. Baptist Memorial maintains robust charity care and financial assistance policies for allocating assistance to uninsured and underinsured patients.

6. Relationship to Existing Applicable Plans; Underserved Area and Population: The proposal's relationship to underserved geographic areas and underserved population groups shall be a significant consideration.

Fayette County is an underserved geographic area that currently requires substantial travel in order to access inpatient acute care services and emergency services. There currently is no acute care hospital within Fayette County. Depending on a resident's location, travel times from certain parts of Fayette County can exceed 40-45 minutes depending on traffic patterns. The proposed Baptist Memorial Fayette will improve geographic access for the vast majority of Fayette County residents, providing an option for acute care and emergency services in their own community that has not existed since 2015.

7. Access: The applicant must demonstrate an ability and willingness to serve equally all of the service area in which it seeks certification. In addition to the factors set forth in HSDA Rule 0720-11-.01(1) (listing factors concerning need on which an application may be evaluated), the HSDA may choose to give special consideration to an applicant that is able to show that there is a limited access in the proposed service area.

Baptist Memorial Fayette will service equally all patients who present to its facility. As discussed above, the applicant believes that special consideration of this application is appropriate given the lack of available healthcare resources in Fayette County today.

8. Adequate Staffing: An applicant shall document a plan demonstrating the intent and ability to recruit, hire, train, assess competencies of, supervise, and retain the appropriate numbers of qualified personnel to provide the services described in the application and that such personnel are available in the proposed service area.

Baptist Memorial is one of the largest privately-owned hospital systems in the nation, operating 24 hospitals in Arkansas, Memphis, and Tennessee and it has developed an innovative approach

for hiring, training and retaining necessary clinical staff. Since 1912, Baptist Memorial has operated the Baptist Health Sciences University, which offers many unique programs of study, including nursing programs, with the flexibility to attend class online or on nights and weekends. Annually, approximately 250 nurses graduate from Baptist University, many of whom take employment at a Baptist facility. Staff for the proposed facility will likely be combination of recent Baptist University graduates as well as staff recruited for their positions, both locally and Statewide.

In addition, Baptist Memorial also operates its Center for Career Development which assists both future and current employees throughout West Tennessee, Eastern Arkansas, and North and Central Mississippi. This program includes a comprehensive range of services from career coaching and advising, to assistance with developing career and learning plans, education program search support and guidance.

9. Assurance of Resources: The applicant shall document that it will provide the resources necessary to properly support the applicable level of services. Included in such documentation shall be a letter of support from the applicant's governing board of directors, Chief Executive Officer, or Chief Financial Officer documenting the full commitment of the applicant to develop and maintain the facility resources, equipment, and staffing to provide the appropriate services. The applicant shall also document the financial costs of maintaining these resources and its ability to sustain them.

Attached as Attachment 1N.a is a letter from Baptist Memorial's CEO confirming Baptist Memorial's commitment and financial capability to operate Baptist Memorial Fayette.

10. Data Requirements: Applicants shall agree to provide the Department of Health and/or the Health Services and Development Agency with all reasonably requested information and statistical data related to the operation and provision of services and to report that data in the time and format requested. As a standard practice, existing data reporting streams will be relied upon and adapted over time to collect all needed information.

Baptist Memorial Fayette agrees to provide the Department of Health and/or the Health Facilities Commission with all reasonably requested information and statistical data related to the operation and provision of services and to report that data in the time and format requested.

11. Quality Control and Monitoring: The applicant shall identify and document its existing or proposed plan for data reporting, quality improvement, and outcome and process monitoring system.

Baptist Memorial Fayette will adopt and implement a quality improvement and outcome evaluation process consistent with the policies and procedures of Baptist Memorial. As required by CMS Conditions of Participation, Baptist Memorial Fayette's QI activities will include data reporting and process monitoring to ensure quality outcomes and efficiency. As with any Baptist Memorial facility, outcomes will be reviewed by medical and clinical staff involving individual

review of adverse events, root cause analyses and QIC investigations. Baptist Memorial Fayette staff will maintain ongoing, formal quality improvement activities for all credentialed physicians and staff.

12. Licensure and Quality Considerations: Any existing applicant for this CON service category shall be in compliance with the appropriate rules of the TDH. The applicant shall also demonstrate its accreditation status with the Joint Commission or other applicable accrediting agency.

The Applicant is a new hospital and does not have an operational history.

13. Community Linkage Plan: The applicant shall describe its participation, if any, in a community linkage plan, including its relationships with appropriate health care system providers/services and working agreements with other related community services assuring continuity of care.

As part of Baptist's mission to provide quality health care to all who need it, Baptist's Healthy Communities program partners with local non-profit organizations that share its dedication to providing effective, affordable health care to underserved, underinsured and uninsured members of our communities. Through programs, sponsorships and community events/activities, Baptist Memorial address the top health needs identified communities it serves. Baptist Memorial commits to continuing these programs in Fayette County to further help partner with the local government and physicians to improve the health of Fayette County residents.

**RESPONSE:** The Baptist Memorial Fayette will contain eight emergency department rooms and eight inpatient rooms. The hospital will also have CT, X-Ray, and Ultrasound capabilities. A copy of the floor plan identifying the areas of the hospital has been submitted as Attachment 10A.

**RESPONSE:** The project will be located on the northwest corner of U.S. Highway 64 and Warren Road in Somerville, Fayette County, Tennessee. The location is approximately equidistant to the city-centers of both Oakland and Somerville. U.S. Highway 64 is the main thoroughfare in Fayette County connecting the citizens of Fayette County to Hardeman County to the east and Shelby County to the west. While there is no public transportation in Fayette County, the Delta Human Resources Agency ("DHRA") provides low cost roundtrip "door-to-door" transportation services to the residents of Fayette County. However, the applicant expects that most patients will arrive by private vehicle. The centrally located site is easily accessible by car, ambulance, and other ground transportation.

#### **RESPONSE:**

Baptist Memorial is proposing to establish a new rural community hospital to be centrally located in Fayette County, Tennessee. The proposed hospital will include 8 inpatient acute care beds, imaging (x-ray, ultrasound, and CT), 8 emergency rooms, and laboratory services.

Over the past decade, Fayette County has seen a dramatic reduction in the availability and access to healthcare services in its community. In 2015, Methodist Healthcare closed the only hospital located in Fayette County – Methodist Fayette. In the last full year of operation, 7,580 Fayette County residents visited the Methodist Fayette emergency department, 101 patients were placed in observation status, and 145 patients were admitted. Since Methodist Fayette's closure, Fayette County residents, who had previously accessed the hospital in Fayette County, have been forced to travel significant distances into Shelby County to receive necessary healthcare.

The proposed Baptist Memorial Fayette will be appropriately staffed with physicians and nurses to support low acuity inpatient medical treatment, observation status as well as emergency services. The focus will be to provide improved convenience and accessibility for Fayette County residents, excellent patient experience and better clinical outcomes. If a patient presents to Baptist Memorial Fayette with a condition that exceeds the capabilities of the facility to care for, the patient will be properly stabilized and then transferred to a tertiary facility for further treatment.

It should be noted that beginning in July 2025, the proposed Baptist Memorial Fayette project will not require a CON because of the lack of a licensed hospital in Fayette County. Nevertheless, given the strong community and governmental support for the project, Baptist Memorial has chosen to move forward with this application to accelerate the construction of this much needed facility.

• Ownership structure

**RESPONSE:** Baptist Memorial Fayette will be solely-owned and operated by Baptist Memorial Health Care Corporation.

• Service Area

**RESPONSE:** The proposed service area for this project is Fayette County.

• Existing similar service providers

**RESPONSE:** None. Fayette County currently does not have any acute care hospitals.

Project Cost

**RESPONSE:** Total estimated project costs are \$27,202,590.

Staffing

**RESPONSE:** Baptist Memorial Fayette will require 23.85 FTEs. These positions will be filled either through existing Baptist Memorial resources or using Baptist Memorial's extensive recruiting network.

#### • Need

**RESPONSE:** As described above, there is a current lack of reasonable access to hospital services in Fayette County, Tennessee. In 2015, Methodist Healthcare closed the only hospital located in Fayette County – Methodist Fayette. In the last full year of operation, 7,580 Fayette County residents visited the Methodist Fayette emergency department, 101 patients were placed in observation status, and 145 patients were admitted. Since the closure of Methodist Fayette, the population of Fayette County has grown by eleven percent – from approximately 39,000 residents in 2015 to over 45,000 today. In particular, the towns of Oakland and Somerville have seen rapid growth as residents of the greater Memphis area move into Fayette County. With no hospital in Fayette County, residents are geographically isolated from needed healthcare services. Today, residents of Somerville must travel between 26-35 miles to reach the three closest hospitals (Saint Francis Bartlett, Baptist Collierville or Methodist Le Bonheur Germantown). Residents of Oakland, Tennessee are approximately 17-25 miles from the closest hospitals. Baptist Memorial Fayette will be conveniently located on Highway 64 – the main thoroughfare that traverses Fayette County - and it will sit essentially equidistant between Oakland (4 miles) and Somerville (5 miles). The proposed Baptist Memorial Fayette will substantially reduce that travel burden for both communities and the majority of Fayette County residents. Patients will receive needed inpatient and emergency care in their community, allowing friends and families to be part of the patient's recovery process. Furthermore, as demonstrated by Fayette County's partnership in this project, Baptist Memorial Fayette has strong support from the local government officials, who believe that there is a substantial need to restore inpatient acute care and emergency services to their community.

#### Quality Standards

**RESPONSE:** Baptist Memorial is one of the country's largest not-for-profit health care systems and the largest provider of Medicaid in the region. Consistently ranking among the top integrated health care networks in the country, Baptist Memorial comprises 24 affiliate hospitals in West Tennessee, North and Central Mississippi and East Arkansas; a freestanding emergency department; more than 5,400 affiliated physicians; Baptist Medical Group, a multispecialty physician group with more than 1,100 providers; Baptist Cancer Center; home, hospice and psychiatric care; walk-in and urgent care clinics; a network of surgery, rehabilitation and other outpatient centers; and an education system that includes Baptist Health Sciences University and a college of osteopathic medicine. Baptist employs more than 22,000 people, and in fiscal year 2023 contributed more than \$465 million in community benefit and uncompensated care to the communities it serves. Seven Baptist Memorial hospitals in Arkansas, Mississippi and Tennessee were named to the 2024–2025 U.S. News & World Report Best Hospitals list with Baptist Memorial Hospital-Memphis (Memphis) and Mississippi Baptist Medical Center (Jackson, Mississippi) named as the top hospitals in their respective cities. Four Baptist Memorial hospitals also received "A's" from Leapfrog Group for providing safe care, and the Centers for Medicare & Medicaid Services awarded four Baptist Memorial hospitals four stars and Baptist Memorial Hospital-Leake five stars, its highest rating for quality. As part of the Baptist Memorial system, Baptist Memorial Fayette will operate under the same quality standards as other Baptist Memorial hospitals. The hospital will be appropriately licensed and accredited by The Joint Commission. Baptist Memorial Fayette will also implement quality improvement and review procedures consistent with the policies of Baptist Memorial to ensure the highest quality of care for Fayette County residents.

#### Consumer Advantage

O Choice

**RESPONSE:** Baptist Memorial Fayette will be the only hospital in Fayette County, which is geographically isolated from other hospitals in adjacent counties. Currently, Fayette County residents have no choice in provider in their community. Their only option when they require emergency care or a hospital admission is to travel either by EMS or car - 30-45 minutes into Shelby County.

• Improved access/availability to health care service(s)

**RESPONSE:** Baptist Memorial Fayette will improve access to care by restoring acute care and emergency services to Fayette County that have been absent since the closure of Methodist Fayette in 2015. Baptist Memorial Fayette will reduce travel time for hospital services, reduce the need for Fayette County residents to out-migrate to surrounding counties for care, reduce EMS transports out of the county, and meet the community's demand for healthcare resources closer to their homes.

## **RESPONSE:**

Fayette County is an underserved geographic area that currently requires substantial travel in order to access inpatient acute care services and emergency services. There currently is no acute care hospital within Fayette County. Depending on a resident's location, travel times from certain parts of Fayette County can exceed 40-45 minutes depending on traffic patterns. The proposed Baptist Memorial Fayette will improve geographic access for the vast majority of Fayette County residents, providing an option for acute care and emergency services in their own community that has not existed since 2015.

Moreover, according to the United States Census Bureau, 10.8% of Fayette County residents live below the federal poverty level and according to TennCare, 17.1% of residents are TennCare enrollees. Baptist Memorial is dedicated to providing compassionate, high-quality care for patients consistent with its faith-based mission. Baptist Memorial Fayette will provide care to all patients regardless of race, ethnicity, income, or other factors. Consistent with Baptist Memorial's system-wide policies, the applicant will provide services to underinsured, uninsured, and low-income populations, including TennCare. Baptist Memorial maintains a robust charity care and financial assistance policies for allocating assistance to uninsured and underinsured patients.

#### **RESPONSE:**

The applicant is a new provider and does not have historical utilization for the previous three years. Projected utilization has been provided as attachment 6N.

Utilization was projected for the proposed facility by first analyzing the total number of patients from Fayette County who sought hospital admission at Baptist Memorial-affiliated facilities in 2024. These admissions were analyzed on a DRG level to evaluate the patients for acuity and compare those admission DRGs to the level of services to be offered at Baptist Memorial Fayette. These admissions were also evaluated based on geographic location within Fayette County as it was assumed that the population of northern Fayette County along the Highway 64 corridor will be more likely to access this facility than those in southern Fayette County (portions of southern Fayette County may continue to travel west into Collierville for care instead of north to Baptist Memorial Fayette.)

Although attachment 6N provides projected inpatient utilization, Baptist Memorial also projects that it will treat 5,110 patients through its emergency department during the first year of operation. Baptist Memorial further projects that approximately 20% of these patients will be converted to observation status, consistent with Baptist Memorial's experience at its other rural community hospitals. For the eight inpatient beds at the facility, Baptist Memorial projects that there will be an ADC of 5 - 2 inpatients and 3 observation patients.

#### **RESPONSE:**

The establishment of Baptist Memorial Fayette does not duplicate or impact any competition in the area. As previously stated, there are currently no acute care hospitals in Fayette County. This project will allow residents of Fayette County to receive medical treatment within their County in a more convenient location, close to their residence and support system.

The establishment of Baptist Memorial Fayette will require 23.85 FTEs to operate the hospital. All positions will be filled by leveraging their current employee assets as well as through Baptist Memorial's recruiting relationships with regional medical and nursing programs, both locally and statewide. As volumes grow at the facility, there may be a need to hire additional full-time positions. These efforts will be led by the hospital administrator and other Baptist Memorial personnel.

Baptist Memorial Fayette also plans to become accredited by the Joint Commission.





## Oakland DRC and Planning approve Take 5 Oil Change's building elevations; tables adding event venue to the B-1 Neighborhood District

Staff Writer The Oakland Design Review Commission met on Tuesday, January 7, 2025. Present were Stephen Laskoski, Christina Hall, Mike Brown, Jack Poole, Mayor Adrian Wiggins, and Marilyn Austin, along with city planner Ed Courton.

The only item on the agenda was Take 5 Oil Change requesting design review approval for building elevations, trash enclosure, and landscaping for to a new +/-1,680 SF building. The subject property is situated immediately to the east of the existing Sonic Drive-In restaurant addressed as 7026 Hwy 64. The property is zoned Highway Oriented Business (B-2) zoning district. The proposed development site is proposed to be +/- .9 acres. Access is proposed via Highway 64.

The lot has the existing Sonic on it on part of the same parcel. The developer will desegregate this into 2 lots. Ed Courton said I will give an overview on this but tonight it is about the elevations, trash enclosure, and

Courton said next month they will submit this and they can move forward without the lot separation but they need it for financing.

Jack Poole stated I see this is going out on Hwy 64 and asked where is the connectivity from Sonic which is already there. There's no room on the front there for the road to go. 

## The Constituion-**Backstories #27**

I served four years active duty in the Air Force Judge Advocate General's Corps (JAG), prosecuting and defending courts-martial. I was a young lawyer, just having been licensed by the Tennessee Supreme Court. Under the Uniform Code of Military Justice (UCMJ), all accused personnel were entitled to counsel, at government expense, regardless of financial status. At the time, I thought all systems provided counsel for the accused. This had to be especially true if a defendant or accused could not afford a lawyer. After my active duty, I learned something in my new day job. I learned that I


was wrong. In 1979, I transferred to JAG as a Reserve Officer in the Tennessee Army National Guard. I was a young lawyer, age 29, with four years experience under my belt. Practicing law on the court square in my hometown in Fayette County, I was shocked. Tennessee had no public defender system. If a defendant was indigent, he or she was not entitled to counsel unless charged with a felony. In General Sessions Court, poor defendants had no lawyer for misdemeanors. On felonies, the judge usually appointed the younger lawyers who were regular practitioners in that court. I recall being appointed to represent defendants on many felony charges, including first degree murder. Unless the client was indicted or charged by the grand jury and counsel reappointed, the lawyer was not paid by the state. Only on cases disposed of in Circuit or Criminal Court was the lawyer paid. The payment did not cover a fraction of the time she or he spent in defense of the accused, whether disposition was by jury, judge, or plea negotia-

That system has changed now. Beginning around 1985, Tennessee now has a public defender (PD) system. Public Defenders run for election in the 32 Judicial Districts of Tennessee every eight years. They are on the ballot just like the District Attorney General (prosecutor). By virtue of several U.S. Supreme Court Cases, the 14th Amendment, and action by the Tennessee General Assembly, we have a constitutional system. Lawyers are appointed for indigent defendants facing jail or prison time if convicted, including appeals and post-conviction proceedings. Juveniles facing consequences in juvenile proceedings; parents facing termina-tion of parental rights; persons facing mental health determination; and others-all may have counsel, if indi-

gent, due to constitutional motion to table this for a and statutory provisions. ## Charter of Baptist Memorial Hospital Memphis, Tennessee Revised October 29, 2013

Pursuant to the provisions of Section 48-60-106 of the Tennessee Nonprofit Corporation Act, the undersigned corporation adopts the following amended and restated Charter:

- 1. The name of the corporation is Baptist Memorial Hospital.
- 2. The duration of the corporation is perpetual.
- 3. The address of the principal office of the corporation in the State of Tennessee shall be 6019 Walnut Grove Road, Memphis, Tennessee 38120 (Shelby County).
- 4. The street address, zip code and County of the corporation's registered office is: 350 North Humphreys Boulevard, Memphis, Tennessee 38120, Shelby County. The name of the corporation's registered agent at that office is Gregory M. Duckett.
- 5. The corporation's purpose, for which it is formed, is to operate exclusively for charitable, religious, scientific, or educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, more specifically described as follows:
  - (a) The corporation is a not-for-profit, public benefit corporation, which shall serve as an organization for carrying out a health care mission consistent with the traditional and on-going health care missions of the Arkansas, Mississippi and Tennessee Baptist Conventions and their affiliated Baptist churches with which the corporation shares common religious bonds and convictions. This mission includes prevention of illness, infirmity, injury, and disease as well as the care and treatment of persons who are ill, diseased, injured or infirmed. To this end, the corporation is authorized to acquire, own, lease, manage, operate, sell, construct, finance, provide services to, generally deal with, and affiliate with or be the parent organization of separately incorporated hospitals, clinics, home health care organizations, rehabilitation centers, health maintenance organizations, hospices, nursing homes, nursing and other schools, educational organizations and institutions, together with facilities, equipment and materials related thereto, and any other supporting business units, facilities, equipment and activities deemed to be appropriate in connection therewith and permitted by the Tennessee Nonprofit Corporation Act and to make contributions to organizations that qualify as exempt organizations under Section 501(c)(3) contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986.
  - (b) Notwithstanding any other provisions of this Charter, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) contributions to which are deductible under Section 170(c)(2) of the Internal

Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue law.

- (c) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation in connection with one or more of its purposes) and no director, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporation's assets on dissolution of the corporation.
- (d) No substantial part of the activities of the corporation shall involve carrying on propaganda or otherwise attempting to influence legislation or participating in or intervening (including the publishing or distributing of statements) in any political campaign on behalf of any candidate for public office; nor shall the corporation engage in any activities that are unlawful under applicable federal, state or local law.
- (e) Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation to Baptist Memorial Health Care Corporation or its successor if such corporation is, at the time of dissolution, organized and operated exclusively for charitable, educational, religious, or scientific purposes and then qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue Law, and if Baptist Memorial Health Care Corporation is not then so organized, operated, and qualified, then said assets shall be disposed of exclusively for the purposes of the corporation to such other organizations as the Board of Directors shall determine that are described in Section 8 below, that at the time of dissolution are organized and operated exclusively for charitable, educational, religious or scientific purposes and which then qualify as exempt organizations under Section 501(c)(3) of the said Internal Revenue Code, but if none of said organizations are then so organized, operated and qualified, then said assets remaining after paying or making provisions for the payment of the liabilities of the corporation shall be disposed of exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the said Internal Revenue Code, and as the Board of Directors shall determine.
- 6. The corporation shall operate a hospital institution in Memphis, Tennessee, located on three campuses and doing business as Baptist Memorial Hospital Memphis, Baptist Memorial Hospital for Women and Baptist Memorial Hospital Collierville.

- 7. The corporation shall have one member, Baptist Memorial Health Care Corporation.
- 8. The corporation shall be organized and operated exclusively for the benefit of, to perform the functions of, or to carry out the purposes of Baptist Memorial Hospital and such other organizations of which Baptist Memorial Health Care Corporation is the sole voting Member, or is the sole voting member of the entity which is in turn the sole voting member of such organizations, so long as such supported organizations are exempt from federal income tax under Section 501(c)(3), and are not private foundations under Sections 509(a)(1) or 509(a)(2), of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue law. At least one of the members of the board of directors or an officer of each of the supported organizations shall also be a member of the board of directors or an officer of this corporation.
- 9. Subject to the express limitation that the corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity that would invalidate its status (a) as a corporation which is exempt from federal income taxation as an organization which is exempt from federal income taxation as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, or (b) as a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, the corporation shall have and possess all powers and rights conferred upon not-for-profit corporations by the Tennessee General Corporation Act and any enlargement of such powers conferred by subsequent legislative act; and, in addition thereto, the corporation shall have and exercise all powers and rights not otherwise denied not-for-profit corporations by the laws of the State of Tennessee, as are necessary, suitable, proper, convenient, or expedient to the attainment of the purposes set forth in this Charter.
- 10. All references herein to provisions of the Internal Revenue Code of 1986 shall be deemed to include statutes which succeed such provisions (i.e., the corresponding provisions of future United States Internal Revenue laws).
- 11. The corporation's affairs shall be governed by a Board of Directors consisting of not less than three (3) nor more than eighteen (18) members. The election, removal, and replacement of directors and the filling of vacancies by the Board of Directors shall be as described in bylaws adopted by the Board of Directors.
- 12. Bylaws of the corporation shall be adopted by the Board of Directors and may be amended by resolution of the Board of Directors.
- 13. This Charter of Incorporation may be amended upon adoption by the Board of Directors of a resolution setting forth the amendment in the manner provided by law; provided, however, no amendment of the Charter may be adopted which changes or affects in any way the exempt status of the corporation as an organization existing exclusively for religious, charitable, educational, or scientific purposes as described in

Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any future Internal Revenue law of the United States.



## AGREEMENT OF PURCHASE AND SALE

This Purchase and Sale Agreement (toget	her with all Exhibits and attachments, the
"Agreement") is entered into as of	_, 2025 (the "Effective Date"), by and between
Chickasaw Electric Cooperative a Tennessee Non-profit corporation ("Seller"); and Fayette	
County, Tennessee, a Governmental entity, or it	s assigns ("Buyer").

## <u>WITNESSETH</u>:

In consideration of the mutual covenants set forth herein, Seller and Buyer agree as follows:

## 1. <u>Conveyance of Property</u>

On the terms and subject to the conditions set forth in this Agreement, Seller shall sell, convey and assign to Buyer, and Buyer shall buy and accept from Seller, the fee simple title in approximately 5.10 acres, more or less, in Fayette County, Tennessee, as described on *Exhibit A*, (the "Property"). The Property shall be transferred to Buyer at Closing (as hereinafter defined) free and clear of all liens, claims and encumbrances except for the Permitted Encumbrances (as hereinafter defined). A description of the Property from a current survey is to be obtained by Buyer at Buyer's expense (the "Survey") and shall be deeded by general warranty deed to Buyer at Closing or to another entity upon Buyer's request.

Upon transfer of the Property to Buyer, Seller shall remain liable for all obligations of Seller in connection with the Property which are incurred, accrued or arose on or prior to the Closing Date, arising out of, by reason of, or in connection with the ownership, operation, management or maintenance of the Property for all periods prior to the Closing Date. After the Closing Date, Buyer shall be liable and responsible for all obligations of Buyer arising after the Closing Date in connection with the Property (other than roll-back taxes) and arising out of, by reason of, or in connection with the ownership, operation, management or maintenance of the Property after the Closing Date.

## 2. Purchase Price

The purchase price for the Property shall be Six Hundred Sixty-Three Thousand and no/100 Dollars (\$663,000.00) (the "Purchase Price"), to be paid at Closing in immediately available funds by wire transfer to the Seller or his agent. This purchase price is based per acre and will be specifically determined by the actual amount of acreage of the Property, as calculated at \$130,000.00 per acre based on a current or mutually acceptable survey. Seller shall pay all personal property taxes and real property taxes of the Property for any years or partial years prior to Closing including but not limited to, any roll back taxes which shall be assessed in the future as a result of this property no longer qualifying for greenbelt assessment.

## 3. <u>Due Diligence</u>

For a period of ninety (90) calendar days commencing on the Effective Date (the "Due Diligence Period"), Buyer or any person or entity authorized by Buyer shall have the right to enter upon the Property for purposes of undertaking tests, analysis, inspections, or evaluations of any kind in Buyer's sole and absolute discretion. Prior to the expiration of the Due Diligence Period, Buyer shall have the right to terminate this Agreement for any reason or proceed to close on this purchase in its sole discretion as further provided herein.

## 4. Title

Within seven (7) days of the Effective Date, Seller through its closing attorney shall deliver a commitment for title insurance covering the fee simple title in the Property (the "Title Commitment") setting forth the status of the title of the Property together with copies of documents that may be listed as exceptions in the Title Commitment.

For a period of twenty-one (21) days from the receipt of the Title Commitment, Buyer shall have the right to object in writing to any matters reflected by the Title Commitment. All matters to which Buyer so objects are hereinafter referred to as "Non-Permitted Encumbrances"; all matters reflected by the Title Commitment to which such objection is not made shall be deemed "Permitted Encumbrances". Seller, at its sole cost and expense, shall cure or remove all Non-Permitted Encumbrances on or before the Closing Date or either party may terminate this Agreement, and the Earnest Money, if any, shall automatically be returned to Buyer.

## 5. Representations and Warranties

Seller hereby represents and warrants to and covenants with Buyer that Seller is the sole owner of fee simple title to the Property and has good, merchantable and insurable fee simple title to the Property and that Seller has the full right, power, and authority to execute, deliver and perform this Agreement. From the date hereof until Closing, Seller shall maintain and operate the Property in a manner consistent with Seller's maintenance and operation thereof during the twelve (12) months preceding the Effective Date. Seller represents and warrants that to the best of Seller's knowledge there is no environmental condition on the Property as defined under applicable law nor lawsuits, claims, or condemnations threatened or filed against the Property.

All improvements and personal property, if any, are being sold "AS IS - WHERE IS" without warranty as to condition, functionality or suitability.

## 6. Closing

The closing ("Closing") of the sale of the Property by Seller to Buyer shall occur within sixty (60) days following the later to occur of the following:

(i) Final approval of this Agreement by the Fayette County Commission, including the necessary funding needed to complete the closing on behalf of the Buyer; and

(ii) Receipt of a Certificate of Need from the Tennessee Health Facilities Commission for a hospital to be built on the Property by Baptist Memorial Health Care Corporation or its designated entity.

Closing shall occur at the place and/or time as mutually agreed upon by the Seller and Buyer. Closing may also be extended by mutual written agreement of the parties. On the date of closing of the sale of the Property, the Closing shall occur as follows, subject to the satisfaction of all of the terms and conditions of this agreement:

- (a) Each party shall deliver appropriate evidence to establish the authority of such party to enter into and close the transaction contemplated hereby.
- (c) Should Buyer complete construction of the Hospital and a Termination of Repurchase Option be filed as set forth herein above, Seller shall have a right of first refusal to purchase the Property if Buyer receives a bona fide offer from a third party (the "Offer") which would result in the property no longer being used as a healthcare facility, and decides to sell the Property by accepting the Offer. Within ten (10) calendar days from Buyer's receipt of such an Offer, Buyer shall provide Seller with written notice that Buyer has received an Offer that Buyer intends to accept (the "Offer Notice"). Seller shall have ten (10) calendar days after receipt of the Offer Notice to exercise Seller's right of first refusal by providing Buyer with written notice that Seller will purchase the Property upon the terms as are contained in the Offer Notice (the "Acceptance Notice"), at which time Buyer shall be obligated to sell the Property to Seller. Closing of any such sale shall take place within one hundred twenty (120) calendar days from Buyer's receipt of the Acceptance Notice. Buyer shall transfer the Property to Seller free and clear of any liens and/or encumbrances except for those non-monetary liens as may be approved by Seller at the commencement of this Agreement.
  - (d) Seller shall deliver possession of the Property to Buyer at closing.
- (e) Seller shall deliver to Buyer a Seller's Affidavit on the title company's approved form.

- (f) Seller shall deliver to Buyer an affidavit for purposes of Section 1445 of the Internal Revenue Code.
- (g) Buyer and Seller shall execute any and all other documents as required by the title company or as is reasonable and customary in Fayette County, Tennessee except that Buyer will not sign any document that contains an indemnity and/or hold harmless provision as Tennessee law prohibits it from doing so.

At Closing, Buyer, at its sole cost and expense, shall deliver or cause to be delivered to Seller payment in accordance with Section 3 hereof and evidence satisfactory to Seller and the Title Company that the person executing the Closing Documents on behalf of Buyer has full right, power and authority to do so. Seller, at its cost and expense, shall deliver or cause to be delivered to Buyer a General Warranty Deed as above described, fully executed and acknowledged by Seller, conveying to Buyer good, merchantable and insurable fee simple title in the Property; and evidence satisfactory to Buyer and Title Company that the person or persons executing the Closing Documents on behalf of Seller have full right, power and authority to do so. At Closing, both parties will execute a closing statement, such affidavits or statements as may be required by any governmental agency relating to transfer and similar taxes; and any other instruments and documents which shall be reasonably necessary to complete the sale of the Property. Both Seller and Buyer agree that it will without further consideration execute and deliver such other documents and take such other action, whether prior or subsequent to Closing, as may be reasonably requested by the other party to consummate more effectively the purposes or subject matter of this Agreement. Upon completion of Closing, Seller shall deliver to Buyer possession of the Property.

Each of Seller and Buyer shall pay its own legal fees incurred in connection with this Agreement; provided, however, that if a suit is filed by Buyer or Seller alleging a breach hereof or default hereunder, the non-prevailing party shall pay all reasonable legal fees and out-of-pocket expenses of the prevailing party resulting from such suit. The provisions of this paragraph shall survive Closing.

Buyer shall pay all sales taxes, transfer or documentary taxes payable in connection with the closing of this transaction. Buyer shall pay the premium for the Owner's Policy and Lender's Policy, if any. Buyer shall pay any fee charged by the Title Company for any endorsements or reinsurance required by the Buyer and for the deletion of the standard exception pertaining to discrepancies, conflicts or shortages in area. Seller shall pay for the Title Commitment and search and all costs of drafting conveyance documents to Buyer. The parties shall pro rate real property taxes as of the day of Closing. Buyer shall also reimburse Seller outside of closing the sum of \$\\_\_\_\_\_ for additional engineering, geotechnical and planning fees and costs incurred by Seller related to the sale of the property. All other closing costs shall be paid in accordance with local custom.

#### 7. Notices

Any notice or demand provided for or given pursuant to this Agreement shall be in writing and served on the parties at the addresses listed below. Any notice shall be sent by a nationally recognized overnight courier, in which case it shall be deemed delivered one (1) business day after

deposit with such courier. The addresses listed herein may be changed by written notice to the other parties. For purposes of notice, the addresses of the parties shall be as follows:

#### 8. Commissions

Except as provided in this Section, each party represents and warrants to the other party that neither party, nor anyone acting on the behalf of either party, has incurred any liability to any broker or finder in connection with the transaction contemplated by this Agreement. The representations, and warranties set forth in this Section shall survive Closing and/or termination of this Agreement for any reason.

## 9. Destruction, Damage or Taking Before Closing

In the event of a fire or other casualty or an eminent domain taking or the issuance of a notice of an eminent domain taking with respect to all or any substantial portion of the Property prior to the Closing Date, Buyer and Seller shall have the option to terminate this Agreement within thirty (30) days after Buyer's receipt of written notice from Seller (but in no event later than the

Closing Date) advising of such casualty or taking or proposed taking, which notice Seller hereby agrees to give promptly. If Buyer and Seller shall elect not to exercise their right to terminate this Agreement, Buyer shall be obligated to consummate this transaction for the full Purchase Price (subject to any deductible) and Buyer shall be entitled to receive all insurance proceeds or eminent domain awards and, to the extent the same may be necessary and appropriate, Seller shall assign to Buyer at Closing Seller's rights to such awards.

#### 10. Termination and Remedies

If Buyer fails to consummate the purchase of the Property pursuant to this Agreement for any reason other than (i) Seller's failure to perform its obligations hereunder, or (ii) the termination of this Agreement pursuant to a right granted to Buyer herein, then Seller, as its sole and exclusive remedy (Seller expressly waiving all other remedies, including, without limitation, specific performance and the right to seek damages), shall have the right to terminate this Agreement by notifying Buyer thereof, in which event the Escrow Agent shall deliver to Seller, as liquidated damages, the Earnest Money, whereupon neither Buyer nor Seller shall have any further rights or obligations hereunder. If Buyer terminates this Agreement pursuant to a right granted herein then the Escrow Agent shall deliver the Earnest Money to Buyer whereupon neither party hereto shall have any further rights or obligations hereunder.

If Seller fails to consummate the purchase of the Property pursuant to this Agreement for any reason other than (i) Buyer's failure to perform its obligations hereunder, or (ii) the termination of this Agreement pursuant to a right granted to Seller herein, then Buyer, as its sole and exclusive remedy, shall have the right to (a) terminate this Agreement by notifying Seller thereof, in which event the Escrow Agent shall deliver to Buyer, as liquidated damages, the Earnest Money, if any, whereupon neither Buyer nor Seller shall have any further rights or obligations hereunder or (b) enforce the specific performance of this Agreement against Seller. The parties hereto waive the lack of mutuality of remedies.

Seller and Buyer hereby acknowledge and agree they have included the provision for payment of liquidated damages because, in the event of a breach by Buyer, the actual damages incurred by Seller can reasonably be expected to approximate the amount of liquidated damages, and because the actual amount of such damages would be difficult if not impossible to accurately measure.

#### 11. Disclaimers

Notwithstanding anything to the contrary herein it is expressly understood and agreed that Buyer is purchasing the Property "as is" and "where is," and with all faults and that Seller is making no representations or warranties, whether express or implied, by operation of law or otherwise, with respect to the quality, physical condition or value of the Property, the income or expenses from or of the Property or the compliance of the Property with applicable laws or regulations, including specifically without limitation building and fire codes, or the performance capability or working status of any of the Improvements. Seller is making no representation or warranty concerning the accuracy or thoroughness of any reports delivered to Buyer, the information contained therein, or the methods of the parties which prepared any such reports. Purchaser has

inspected the Property and is relying solely upon its own judgment in this transaction. Without limiting the foregoing, it is understood and agreed that (a) Seller makes no warranty of habitability, suitability, merchantability or fitness for a particular purpose, and (b) to the extent that warranties of title are to be made, such warranties shall be set forth solely and expressly in this Agreement. Buyer agrees that Seller is not liable or bound by any guarantees, promises, statements, representations or information pertaining to the Property made or furnished by any real estate agent, broker, employee, servant or other person representing or purporting to represent Seller, except as and to the extent expressly set forth herein.

#### 12. Modification

This Agreement, including the Exhibits, contains the entire agreement between Seller and Buyer pertaining to the subject matter hereof and fully supersedes all prior agreements and understanding between Seller and Buyer pertaining to such subject matter. This Agreement cannot, under any circumstances, be modified orally, and no agreement shall be effective to waive, change, modify or discharge this Agreement in whole or in part unless such agreement is in writing and is signed by both Seller and Buyer. If any provision of this Agreement is determined by a court of competent jurisdiction to be invalid or unenforceable, the remainder of this Agreement shall nonetheless remain in full force and effect. Section headings contained herein are for convenience only and shall not be considered in interpreting or construing this Agreement.

#### 13. Applicable Law

This Agreement shall be governed and construed in accordance with the laws of the State of Tennessee. The enforceability or invalidity of any one or more provisions hereby shall not affect the validity or enforceability of any other provision hereof.

#### 14. Time

Time is of the essence for all matters in this Agreement.

#### 15. Counterparts.

This Agreement may be executed in any number of counterparts, any one or all of which shall constitute the agreement of the parties.

#### MEMORANDUM OF UNDERSTANDING

## MEMORANDUM OF UNDERSTANDING BY AND BETWEEN FAYETTE COUNTY, TENNESSEE, THE FAYETTE COUNTY INDUSTRIAL DEVELOPMENT BOARD OF FAYETTE COUNTY, TENNESSEE, AND BAPTIST MEMORIAL HEALTH CARE CORPORATION

WHEREAS, the only acute care hospital located in Fayette County, Tennessee, Methodist Fayette Hospital, closed in March of 2015;

WHEREAS, Fayette County, Tennessee, a governmental subdivision of the State of Tennessee (the "County"), has determined that it is vital to the health and welfare of its citizens and vital to the long-term success of the County that there be a hospital facility in the County;

WHEREAS, hospital facilities provide important health care services to citizens of a county, but they also serve as economic multipliers for rural communities. New hospital facilities bring well-paying jobs to a region and also serve an important role in a community's ability to attract economic development projects and support job growth in various industries;

WHEREAS, The Fayette County Industrial Development Board of Fayette County, Tennessee, a Tennessee non-profit corporation (the "Fayette IDB") was established by the County to promote job creation and economic development in the County;

WHEREAS, the County and the Fayette IDB believe having a hospital facility located in the County is critically important to their ability to attract jobs and economic development projects to the region;

WHEREAS, Baptist Memorial Health Care Corporation ("Baptist") is a Tennessee nonprofit corporation whose first hospital was founded in 1912 by the Southern Baptist Conventions of Arkansas, Mississippi, and Tennessee. Baptist is a tax-exempt corporation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Baptist is part of a network of hospitals and healthcare-related affiliates serving the Mid-South with hospitals in Tennessee, Arkansas, and Mississippi;

WHEREAS, the charitable purpose and faith-based mission of Baptist is the promotion of health, welfare, wellness, education, and research in the communities it serves by providing quality healthcare and related services, at reasonable costs;

WHEREAS, in furtherance of its charitable purpose and faith-based mission, Baptist wishes to establish a new acute care hospital in the County (the "New Hospital"); and

WHEREAS, the County and the Fayette IDB desire to facilitate the development of the New Hospital, by providing the funding for the acquisition and design and construction of the New Hospital and providing financial support for the initial year of the New Hospital's operations.

NOW, THEREFORE, the County, the Fayette IDB, and Baptist (each, a "Party" and collectively, the "Parties") desire to enter into this Memorandum of Understanding ("MOU") to set forth the terms and understanding among the Parties.

#### PART A - NON-BINDING TERMS

- Definitive Agreements. This MOU is entered into by the Parties to serve as the basis for negotiation of a Development Agreement between the County, the Fayette IDB, and Baptist (the "Development Agreement"), a Lease Agreement between the Fayette IDB and Fayette County (the "Lease Agreement"), a Sublease Agreement between Fayette County and Baptist (the "Sublease Agreement"), a Financial Support Agreement between Baptist and the County (the "Financial Support Agreement"), and other definitive agreements necessary to effectuate the transactions described herein (together, the "Definitive Agreements"). Initial drafts of the Definitive Agreements will be prepared by the Fayette IDB Bond Counsel. Subject to prior written consent of the County and/or the Fayette IDB, which consent will not be unreasonably withheld, Baptist will have the right to assign the Definitive Agreements and Its rights thereunder to a related entity which agrees to assume the Definitive Agreements and perform the covenants set forth therein so long as Baptist remains primarily liable to the County and Fayette IDB with respect to the covenants and agreements set forth in the Definitive Agreements.
- 2. <u>Development Agreement</u>. Upon the execution of this MOU, the County, the Fayette IDB, and Baptist will negotiate and enter into the Development Agreement. The Development Agreement will include the following terms related to the hospital design, site selection, approvals, construction, and financing:
- (a) <u>Hospital Design and Planning.</u> Baptist will select an architect experienced in the design of acute care hospitals of this size and type and who is acceptable to the Fayette IDB. The Fayette IDB and Baptist will collaborate in the design development and construction of the New Hospital and establish a selection process for the selection of a qualified developer, contractor, and/or engineer for the New Hospital.
- (b) <u>Selection of Site</u>. The County will option the real property on which the New Hospital will be constructed (the "Real Property"). The Real Property must be located in a location that is mutually acceptable to both the County and Baptist. The Option Agreement will be assigned to the Fayette IDB by the County.
- (c) <u>Certificate of Need</u>. The establishment of a new hospital in Tennessee requires the grant of a Certificate of Need ("CON") by the Tennessee Health Facilities Commission pursuant to Tenn. Code Ann. §68-11-1601 et seq. Baptist will prepare and file a CON application for the New Hospital. Baptist will be responsible for the costs of the CON application fees and process.
- (d) Acquisition and Construction Financing. The County has identified funds for the acquisition of the Real Property and \$18 Million dollars in funding (the "Hospital")

Development Funds") to finance the construction of the New Hospital (the "New Hospital Project"). A portion of the Hospital Development Funds is anticipated to be a financing obtained by the Fayette IDB ("IDB Financing") pursuant to which the Hospital Development Funds will be assigned or otherwise be made available to the Fayette IDB as funding for the New Hospital and/or as a source of payment for the IDB Financing in order to acquire the Real Property and to construct the New Hospital. Upon completion of construction, the Fayette IDB will lease the Real Property and New Hospital to Fayette County and Fayette County will sublease the New Hospital to Baptist pursuant to the terms and conditions of the Sublease Agreement.

- (e) <u>Equipment Financing</u>. Upon the completion of construction, Baptist will agree to equip the New Hospital at Baptist's expense.
- Agreement with Fayette County with respect to the New Hospital and the County will sublease the New Hospital to Baptist. Under the Lease Agreement, Fayette IDB will agree to use the Hospital Development Funds to acquire the Real Property and construct the New Hospital according to the terms, conditions and standards set forth therein. The initial term of the Lease Agreement will be a term, not to exceed twenty (20) years, that is necessary for the IDB Financing to be fully amortized from the sources available for such purposes. Baptist will covenant in the Sublease Agreement that the New Hospital will (i) provide uncompensated emergency care to eligible individuals who are unable to pay for their care, (ii) participate in Medicare, TennCare, and other governmental payor programs on a nondiscriminatory basis, and (iii) provide emergency care 24 hours a day, 7 days a week.
- 4. <u>Hospital Conveyance to Baptist</u>. The Sublease Agreement will also provide that upon repayment and retirement of the Fayette IDB Financing, Fayette IDB and Fayette County will convey to Baptist fee simple title in the Real Property and the New Hospital for a nominal fee of \$1,000 plus the expenses related to the closing and conveyance.
- 5. <u>County Financial Support</u>. Prior to the opening of the New Hospital, the County will enter into a Financial Support Agreement with Baptist whereby the County will agree to provide not-to-exceed \$1 Million dollars in addition to the Hospital Development Funds in financial support to Baptist to reimburse Baptist for operating losses during the New Hospital's initial year of operations.

#### PART B - BINDING TERMS

1. Public Announcements; Confidentiality. Each Party agrees to consult with the other Parties prior to issuing any press release or otherwise making any public statement with respect to the transactions contemplated by this MOU and will not issue any such release or make any such statement without the consent of the other Parties, except as required by law and provided that the County and Fayette IDB may issue public meeting notices and publish

agendas with respect to public meetings and hearings regarding its matters involving Baptist without any further consent of Baptist.

- 2. Exclusive Negotiations. Baptist contemplates the expenditure of substantial amounts of time and money in connection with legal, accounting, financial, and other work to be performed in conjunction with the transactions described in this MOU. For purposes of inducing Baptist to execute this MOU, from the date the County and the Fayette IDB approve this MOU until March 31, 2025. The County and the Fayette IDB shall not, directly or Indirectly, without Baptist's prior written consent, enter into any agreement with any person or entity (other than Baptist) concerning the design, development, construction or operation of an acute care, medical surgical hospital, an ambulatory surgical treatment center, a freestanding emergency department, a rural emergency hospital, or an outpatient diagnostic center in the County.
- 3. <u>Expenses.</u> Each Party shall bear its own expenses in connection with the implementation of this MOU, regardless of whether the Definitive Agreements are executed. Neither the County, Fayette IDB, nor Baptist shall be obligated to pay for professional services of architects, contractors, realtors, or any other professional services with respect to the New Hospital Project except as set forth in the Definitive Agreements, which shall be consistent with Part A, Section 1 above.
- 4. <u>Governing Law</u>. This MOU and all agreements executed by the Partles in connection with the transactions contemplated by this MOU shall be governed by the laws of the State of Tennessee without regard to conflicts of laws principles.
- 5. <u>Termination</u>. This MOU shall terminate with the execution of the Definitive Agreements. The Definitive Agreements will contain the provisions outlined above in this MOU and representations, warranties, and other terms (including, without limitation, contingencies for all necessary regulatory approvals), all of which must be acceptable to the Parties in their sole discretion. If the Definitive Agreements are not executed by March 31, 2025, then this MOU shall terminate and none of the Parties shall have any obligation to the others pursuant to this MOU.
- 6. Approval by County and Fayette IDB. Although the County Mayor is executing this MOU for the purpose of establishing the terms and agreements negotiated with Baptist, the effectiveness of this MOU is contingent upon the approval by the respective governing bodies of the County and Fayette IDB at open public meetings as to which adequate public notice has been given and agendas have been made available to the public as required by law.





Dear Mr. Taylor:

This letter is submitted on behalf of Baptist Memorial Hospital. Tenn. Code Ann. §68-11-1607(c)(9)(B) requires that, "[i]f an [Certificate of Need] application involves a healthcare facility in which a county or municipality is the lessor of the facility or real property on which it sits, then, within ten (10) days of filing the application, the applicant shall notify the chief executive officer of the county or municipality of the filing, by certified mail, return receipt requested."

Although Fayette County will not be the technical lessor of the Baptist Memorial Hospital Fayette County project, I am writing to notify you pursuant to Tenn. 



Response: Yes. Baptist Memorial Hospital – Fayette County was registered with the Tennessee Secretary of State's office on January 1, 2025 as an assumed name of Baptist Memorial Hospital. A copy of the filing information for the new assumed name is attached as 7AR.

It appears that the project site Parcel ID 088 028.00 is currently owned by Chickasaw Electric Cooperative which is an entity not referenced in the attached Memorandum of Understanding. Please provide documentation confirming the ability of the applicant to establish site control that includes the current owner of the property.

Response: A copy of the draft Agreement of Purchase and Sale between Fayette County and the Chickasaw Electric Cooperative is attached as 9AR.

Response: No. The only potential planned expansion would be for additional medical office space as displayed on the submitted plot plan.

Nevertheless, out of an abundance of caution, the applicant has submitted notice to the Fayette County mayor to comply with the notice requirements of TCA §68-11-1607(c)(9)(B). Who operates the EMS service for Fayette County?

Fayette County operates the local EMS service for the county which includes four EMS stations in Somerville, Oakland, Rossville, and Collierville.

Where are those transports going to on a percentage basis?

The applicant does not have access to Fayette County EMS transport data. As set forth in attachment 1N, according to the 2023 Joint Annual Report Summary, 3,436 Fayette County residents were admitted for hospital care in 2023 with 3,377 (98%) of those admissions occurring in hospitals in counties adjacent to Fayette County. Of those 3,377 admissions, approximately 44.4% visited Baptist-affiliated hospitals, 24.4% were admitted to Methodist facilities, and 23.4% were admitted to Saint Francis facilities.

What percentage of those transports does the applicant expect can be reduced due to the presence of the proposed facility?

While Baptist Memorial does not have access to detailed data on EMS transports, from its own internal data, Baptist knows that approximately 15% of Fayette County patients that presented to a Baptist Memorial-affiliated ED last year arrived by Fayette County EMS. The applicant projects that it will treat 5,110 patients through its emergency department during the first year of operation. Assuming the same 15% EMS-to-private vehicle ratio, the applicant projects approximately 767 EMS drop-offs at Baptist Memorial Fayette.

At 767 EMS drop-offs in Year 1, the facility will improve access to care for Fayette County residents, reducing the need for residents to travel into Shelby County for emergency services, It will also cause a material reduction in EMS time out of the area and improve EMS efficiency by reducing the number of trips EMS must make into Shelby County to deliver patients for care.

Are there any additional service lines that are planned for the facility that the applicant can identify beyond general inpatient care based upon the applicant's historical analysis of DRGs of patients admitted to Baptist Hospitals?

**Response:** Will the emergency department have any behavioral health capacity, such as dedicated room or staffing?

The Baptist Memorial Fayette emergency department will have one ED room equipped to treat behavioral health patients. The room will be minimized for ligature risk and it will be in close proximity/view of the nurse station. Patients displaying behavioral health symptoms will be assessed on arrival to evaluate the urgency of their condition and will receive a medical screening to determine whether any underlying medical condition may be causing or exacerbating the patient's mental health symptoms. ED clinicians will evaluate the patient's risk of harm to themselves or others, will initiate appropriate interventions to manage the patient's condition and if risk of harm is present, the patient will be placed in 1:1 direct observation. Local mental health providers will be contacted and the patient will either discharged into an appropriate outpatient program or transferred for inpatient admission.

Are there any additional service lines that are planned for the facility that the applicant can identify beyond general inpatient care based upon the applicant's historical analysis of DRGs of patients admitted to Baptist Hospitals?

The current focus for the facility will be emergency, observation and inpatient care. The inpatient unit will have access to telehealth specialty consults in Cardiology, Neurology, and Infectious Disease.

#### 9. 2C. Insurance Plans

Are there any large commercial plans covering the service area that are not accepted by the applicant?

Response: Memphis is a unique insurance market in that the insurance networks are "narrow" – insurance providers in Memphis generally do not have network contracts with all area hospital systems. Patients who are covered by BlueCross insurance, for instance, will be out-of-network if they use Methodist inpatient facilities. Patients covered by Cigna or United insurance will be out-of-network if they use Baptist inpatient facilities. Patients in Memphis are generally aware of their narrow network and will choose to access the closest facility that is in their insurance network.

Consistent with its EMTALA obligations, Baptist Memorial Fayette will treat all patients who present to its emergency department regardless of their ability to pay. However, as described in the application, the utilization projections for the proposed facility were generated by analyzing Fayette County residents currently utilizing Baptist (and thus those whose insurance is in network with Baptist). Considering the influence of narrow insurance networks on patient choice, patients who have historically utilized Methodist and Saint Francis will likely continue to use Methodist and Saint Francis facilities.

**Response:** Any proposed use of telehealth for consultation services at the facility?

Telehealth consultative services will be available to connect patients with physician providers at Baptist Memorial who will be able to assess, diagnose, and monitor patients who present to Baptist Memorial Fayette. The inpatient unit will also have access to telehealth specialty consults in Cardiology, Neurology, and Infectious Disease.

Please describe the recruiting relationships with regional medical and nursing programs that will support staffing of this project.

As set forth in response to Acute Care Criterion No. 8, Baptist Memorial operates Baptist Health Sciences University, which includes a nursing program that graduates hundreds of nursing students every year. In addition, Memphis is home to the Loewenberg College of Nursing at the University of Memphis, the University of Tennessee Health Sciences, Christian Brothers University nursing school, the Nursing Institute of the Mid South, and Southwest Tennessee Community College. Baptist Memorial has recruiting relationships with each of these nursing programs which will be utilized, as necessary, to recruit the staffing requirements for the Baptist Memorial Fayette hospital.

Adjusted patient days is used to standardize patient volume for both inpatient and outpatient utilization and is calculated by multiplying inpatient days \* (gross patient revenue / gross inpatient revenue). Given the high ratio of outpatient and emergency services expected at the proposed facility, the use of adjusted patient days more meaningfully assesses the project's financial charge structure.

For inpatient admissions, Baptist Memorial Fayette projects an average length of stay of 3.274 days for total inpatient patient days of 730 on the projected 223 inpatient admissions.

Please explain the projected breakdown of inpatient vs. outpatient revenue in the Projected Data Chart. Also, please confirm whether emergency services are included in the outpatient services category.

Yes, emergency services are included with outpatient revenue. Outpatient revenue also includes observation patients, which the applicant projecting an ADC of approximately 3 observation patients per day in Year 1. Given the dearth of available medical resources in the community, the applicant also expects that physicians will utilize the hospital's laboratory testing, radiology, and imaging services on an outpatient basis.

Response: An ED physician will be onsite 24/7/365. The core clinical ED support staffing will also be available 24/7/365, including 1 ER-trained registered nurse, 1 paramedic, and 1 multi-modality radiology tech (for both X-Ray and CT). Beyond this baseline model, staffing will be scaled up as necessary to properly manage the facility's ED volumes.

What partnerships with community health providers and services does the applicant currently have in place or plan to establish in Fayette County?

Response: Baptist Memorial Health Care has a robust community outreach program with established partnerships across more than 110 counties in TN, AR, and MS. In fiscal year 2023, Baptist contributed more than \$465 million in community benefit and uncompensated care to the communities it serves.

As to Fayette County, Baptist Memorial has worked with and funded the Fayette County Search and Rescue, Fayette-Ware High School, United Way of the MidSouth, Fayette County Boy Scouts, Southwest TN Community College and Porter-Leath, which operates early childhood education programs in Fayette County. Baptist Memorial also included Fayette County in its Baptist Community Health Needs Assessment for 2013, 2016, 2019 and 2022.

Baptist will continue to work with the Fayette community as part of its CHNA process to develop a strategic plan for how best to respond to the community's

needs. This focus will likely include wellness programs, free health screenings, chronic disease prevention and management including cancer, obesity and diabetes, behavioral health and maternal child health.

Yes, the inpatient pharmacy will be operational 24/7. For hours in which the pharmacist is not physically on site, a pharmacist will be on call and access to medications will be done via automated dispensing machines such as Omnicell.

No, the hospital is not being designed to allow for vertical expansion.
