CALL TO ORDER:

APPROVAL OF MINUTES

Mr. Chinn presented the February 22, 2023 minutes for approval.

Ms. Jordan moved for approval with Ms. Brown providing the second.

The motion CARRIED [9-0-0] unanimously by voice vote. APPROVED.

CERTIFICATE OF NEED APPLICATIONS

PC 557 eliminated TCA § 68-11-1616, which had provided that "each decision rendered by the Health Facilities Commission shall include written documentation and explanation of the factual and legal basis upon which the commission grants or denies the Certificate of Need." PC 557 only requires this for applications that are denied.

Therefore, for applications filed on or after the effective date of the relevant portions of PC $_{557}$ ($_{10/1/2021}$), a simple motion to approve an application will suffice, and a motion to deny must include an explanation of the factual and legal basis as to why one or more of the criteria have not been met.

Three Certificate of Need applications was considered under the regular CON agenda.

Phillip Earhart introduced the following applications (3) under consideration and with all three (3) being approved.

1. <u>Diagnostic Radiology Consultants</u>, P.A. Hixson (Hamilton County), TN - CN2301-002

Request: The establishment of an Outpatient Diagnostic Center located at 5441 Highway 153, Hixson (Hamilton County), TN 37343. Imaging services to be provided include MRI (adults only), CT, X-ray, Mammography and Ultrasound. The proposed space and medical equipment will be leased from the existing physician owned imaging practice, Diagnostic Radiology Consultants, P.A. The service area includes Bledsoe, Bradley, Hamilton, Marion, Rhea, and Sequatchie Counties in Tennessee, and Catoosa and Walker Counties in Georgia. The applicant is owned by Diagnostic Radiology Consultants, P.A. Estimated project cost: \$4,905,500.

CONDITION: Within two (2) years of approval, the applicant must become accredited by the American College of Radiology.

The Applicant's affiliate, Prime Imaging, LLC ("Prime"), will relinquish an inactive ODC license held at 2205 McCallie Avenue, Chattanooga, TN 37404.

Ms. Jordan moved for approval with Mr. Pinkney providing the second.

Nine members voted to approve the application— Jordan, Scarboro, Brown, Duckett, Wainner, Jerman, Grandy, Pinkney and Chinn. The motion CARRIED [9-0-0].

2. Apollo Surgery Center, Memphis (Shelby County), TN - CN2302-004

Request: The establishment of a single-specialty ambulatory surgical treatment center (ASTC) located at 6409 North Quail Hollow Road, Memphis (Shelby County), TN 38120. The proposed ASTC will have four (4) procedures rooms and will be limited to vascular surgery for peripheral procedures and dialysis shunt maintenance performed by vascular surgeons who are members of Vascular and Vein Institute of the South, PLLC. The service area consists of Shelby County, Tennessee, DeSoto and Panola Counties in Mississippi, and Crittenden County in Arkansas. The applicant is owned by Prateek K. Gupta, MD and Anton Dias Perera, MD. Estimated project cost: \$5,533,621

OPPOSITION: Baptist Memorial Health Care, Methodist Healthcare-Methodist Hospitals and Mark White, State Rep, 83rd Legislative District.

RECUSED: Duckett and Scarboro

CONDITION: Limited to three procedure rooms and no operating rooms in which only the following peripheral vascular procedures may be performed by physicians who are members or full-time employees of Vascular and Vein Institute of the South:

(a) angioplasty, stents, and atherectomies in the upper and lower extremities (legs, ankles, feet); (b) miscellaneous diagnostic peripheral arteriograms of those extremities, and (c) rapid turnaround dialysis access maintenance procedures (percutaneous balloon angioplasty, stents, diagnostic fistulagrams, and percutaneous shunt thrombectomy).

Mr. Pinkney moved for approval with Ms. Brown providing the second.

Seven members voted to approve the application—Jordan, Brown, Grandy, Jerman, Wainner, Pinkney and Chinn. The motion CARRIED [7-0-0].

3. <u>TriStar Skyline Medical Center - East Nashville Freestanding Emergency Department, Nashville (Davidson County), TN - CN2302-006</u>

Request: The establishment of a freestanding emergency department (FSED) located at 1000 Dickerson Pike and adjacent parcels 1012 - 1018 Dickerson Pike and 1005 - 1007 Whites Creek Pike, Nashville (Davidson County), TN 37207. The service area includes ZIP Codes 37206, 37207, 37213, and 37216, which is the part of Nashville known as East Nashville. The applicant is owned by HTI Memorial Hospital Corporation. Estimated project cost: \$20,876,000.

RECUSED: Brown

Mr. Scarboro moved for approval with Mr. Duckett providing the second.

Eight members voted to approve the application—Jordan, Scarboro, Duckett, Grandy, Jerman, Wainner, Pinkney and Chinn. The motion CARRIED [8-0-0].

The following two applications were deferred to the May 24, 2023 Commission meeting:

 AHC Home Health and Hospice of Nashville, LLC, Nashville (Davidson County), TN -CN2302-003

Request: The establishment of a home care organization to initiate and provide home health services limited to patients who have received services at an existing nursing home facility, AHC Nashville, LLC, d/b/a Advanced Health Care of Nashville, located at 627 19th Avenue North, Nashville (Davidson County), TN 37203. The home office for the home health agency will be located at the same address. The 7-county service area includes Cheatham, Davidson, Robertson, Rutherford, Sumner, Williamson, and Wilson Counties. The applicant is owned by New AHC Holdings, LLC. Estimated project cost: \$178,100.

OPPOSITION: Guardian Home Care of Nashville, LLC, and NHC HomeCare.

DEFERRED TO MAY 24, 2023

AHC Home Health and Hospice of Nashville, LLC, Nashville (Davidson County), TN -CN2302-005

Request: The establishment of a home care organization to initiate in-home hospice services to be officed at an existing nursing home facility, AHC Nashville, LLC, d/b/a Advanced Health Care of Nashville, located at 627 19th Avenue North, Nashville (Davidson County), TN 37203. The 7-county service area includes Cheatham, Davidson, Robertson, Rutherford, Sumner, Williamson, and Wilson Counties. The applicant is owned by New AHC Holdings, LLC. Estimated project cost: \$155,859.

OPPOSITION: Alive Hospice, Guardian Hospice of Nashville, LLC, and Caris Healthcare.
