CALL TO ORDER:

The meeting was called to order at 9:00 a.m. by Mr. Chinn with the following members present: Donaldson-Sub Comptroller, Fowler, Jordan, Brown, Grandy, Jerman, Pinkney, Wainner, and Chinn. A quorum was established with nine members present.

APPROVAL OF MINUTES

Mr. Chinn presented the March 24, 2024, minutes for approval.

Ms. Brown moved for approval with Mr. Pinkney providing the second.

The motion CARRIED [9-0-0] unanimously by voice vote. APPROVED.

CONSENT CALENDER

1. Vanderbilt University Medical Center, Nashville (Davidson County), TN - CN2402-003

Request: For the initiation of pediatric lung transplant and pediatric pancreas transplant services at Vanderbilt University Medical Center located at 1211 Medical Center Drive, Nashville (Davidson County), Tennessee 37232. The applicant is owned by Vanderbilt University Medical Center. Estimated project cost: \$13,000.

Ms. Jordan moved for approval with Mr. Pinkney providing the second.

Eight members voted to approve the application— Jordan, Grandy, Jerman, Wainner, Pinkney, Chinn, Fowler, and Donaldson-Sub Comptroller. The motion CARRIED [8-o-o].

CERTIFICATE OF NEED APPLICATIONS

PC 557 eliminated TCA § 68-11-1616, which had provided that "each decision rendered by the Health Facilities Commission shall include written documentation and explanation of the factual and legal basis upon which the commission grants or denies the Certificate of Need." PC 557 only requires this for applications that are denied.

Therefore, for applications filed on or after the effective date of the relevant portions of PC $_{557}$ ($_{10/1/2021}$), a simple motion to approve an application will suffice, and a motion to deny must include an explanation of the factual and legal basis as to why one or more of the criteria have not been met.

Two Certificate of Need applications were considered under the regular CON agenda.

Tom Pitt introduced the following, applications under consideration and with two (2) being approved.

Tennessee Valley Home Care, LLC dba Tennessee Quality Care Home (West), Martin (Weakley County), TN - CN2402-004

Request: For the establishment of a home care organization and the initiation of home health services in a 13-county service area that includes: Carroll, Crockett, Dyer, Fayette, Gibson, Haywood, Henry, Lauderdale, Obion, Shelby, Tipton and Weakley Counties, as well as Certificate of Need-exempt Lake County. Lake County meets the criteria under T.C.A. § 68-11-1607(q) for designation as an economically distressed county and is not subject to Certificate of Need review. Upon approval of this project, the 13 proposed service area counties will be removed from the 51-county licensed service area of Tennessee Valley Home Care, LLC, d/b/a Tennessee Quality Care – Home Health (License No. 221), an existing home care organization located at 580 Tennessee Avenue, North, Parsons (Decatur County), Tennessee that is also owned by American Home Care, LLC. The address of the project will be 115 Neal Street, Suite E&F, Martin (Weakley County), Tennessee 38237. Estimated project cost: \$261,969.

Mr. Pinkney moved for approval with Ms. Sweitzer providing the second.

Tennessee Valley Home Care, LLC dba Tennessee Quality Care Home Health (Middle), Lebanon (Wilson County), TN - CN2402-005

Request: For the establishment of a home care organization and the initiation of home health services in a 21-county service area that includes: Cheatham, Clay, Cumberland, Davidson, DeKalb, Fentress, Jackson, Macon, Maury, Montgomery, Overton, Pickett, Putnam, Robertson, Rutherford, Smith, Sumner, Trousdale, White, Williamson and Wilson Counties. Upon approval of this project, these 21 counties will be removed from the 51-county licensed service area of Tennessee Valley Home Care, LLC, d/b/a Tennessee Quality Care – Home Health (License No. 221), an existing home care organization located at 580 Tennessee Avenue, North, Parsons (Decatur County), Tennessee that is also owned by American Home Care, LLC. The address of the project will be 95 Signature Place, Lebanon (Wilson County), Tennessee 37087. Estimated project cost: \$735,500.
