# Notice of Beginning of Review Cycle

Applications will be heard **July 27, 2022** at the Tennessee Health Services and Development Agency Meeting.

This is to provide official notification that the Certificate of Need applications listed below have begun a 30-day review cycle effective **June 15, 2022**. At the end of the review cycle, Agency staff shall forward a copy of its official written report to the applicant and the appropriate licensing agency.

A healthcare institution wishing to oppose a certificate of need application must:

- be located within a 35-mile radius of the location of the action proposed, unless the application is to establish or add counties to the licensed service area of a home care organization, in which case the opposing healthcare institution must have served patients in at least 1 of the counties in the application's proposed service area within the 730 days immediately preceding the filing date of the certificate of need application;
- file a written objection with the agency specifying reasons why 1 or more of the criteria of T.C.A. Section 68-11-1609 (b) are not satisfied, and serve a copy to the contact person for the applicant, not later than 15 days before the Agency meeting at which the application is originally scheduled

An individual acting in the individual's capacity as a private citizen may express support or opposition to an application before the Agency or in writing.
